Virtual Meeting
Instructions:

A short video regarding virtual meetings was played for attendees.

The Chair provided information on internet and phone access for today's virtual meeting and announced that today's meeting was being recorded and that the recording will be posted on the Board's web page.

Call to Order:

The Chair took roll call of the Board members and asked members attending virtually to indicate if they were alone in a non-public place. The Chair noted that Board member Karen Boyer was excused.

In accordance with Act 220, SLH 2021, all Board members attending virtually confirmed that they were alone in their nonpublic location.

After taking roll, quorum was established, and the meeting was called to order at 9:05 a.m.

Chair's Report:

Announcements

The Chair did not have any announcements.

Approval of Minutes:

Approval of the July 11, 2024 Open and Executive Session Minutes

The Chair asked if there were any discussion or corrections to the minutes of the July 11, 2024 Open and Executive Session minutes. The Chair noted that she provided non-substantive revisions to the Executive Officers. Mr. Kuo said that he did not have any changes to recommend.

Upon a motion by the Mr. Kuo, seconded by the Vice Chair, it was voted on and unanimously carried to approve the aforementioned minutes with the Chair's non-substantive revisions.

The Chair announced the next agenda item.

Education Committee
Report

Education Committee Report for July 11, 2024 Meeting

The Chair stated that she would be giving the report on behalf of Karen Boyer, Chair of the Board of Nursing Education Committee.

The Chair reported on the following recommendations of the Education Committee's July 11, 2024 meeting:

The Chair said that the Education Committee also reviewed two foreign-educated applicants. The Education Committee recommended deferral for the LPN application by exam for Sara Langer. The Education Committee recommended approval for the RN application by endorsement for Gabriella Joyette.

Upon a motion by Ms. Shields-Hanson, seconded by Mr. Aratani, it was voted on and unanimously carried to approve the Education Committee's recommendations regarding faculty and applicant applications.

Executive Officer's Report:

Amendments to Hawaii Administrative Rules ("HAR") Chapter 89, Relating to Nurses – Proposed Amendments to HAR §16-89-22, Pertaining to Temporary Permits – Status Report

EO Pang reported no change to the status of the rules as reported at the July meeting.

Random Audit – Status Report

EO Pang reported that EO Teshima was still working on the audit, and that the Executive Officers would have a report for the next meeting.

Sixteenth Proclamation Relating to Wildfires

EO Pang reported that on July 19, 2024, Governor Green signed the 16th Proclamation Relating to Wildfires that still includes the suspension of certain laws including chapters 457 and 16-89 that would require a license to practice nursing in this State. This proclamation is due to expire on September 17, 2024 unless terminated or superseded by a separate proclamation.

Scope of Practice Inquiry – RNs Relaying Pathology Results of Tissue Samples to Patients

EO Fukunaga reported that the Board had received a scope of practice inquiry from Kimberly Gibu at Kaiser Permanente on June 10, 2024. Ms. Gibu wrote:

My name is Kimberly Gibu and I am a senior manager at Kaiser Permanente. I supervise RNs working in the Breast Care Team department. There is a current expectation that the RNs relay pathology results of tissue samples to patients. At this time, they communicate with patients about negative results, however we would like them to also relay positive results and inform patients about the next

steps in the process, which in many cases involves a surgical consult. This is a part of an initiative to improve timeliness, efficiency and quality of services to our patients.

The RNs, through their Union, Hawaii Nurses and Healthcare Professionals, have raised the issue that it is outside the scope of a registered nurse to relay positive results to a patient. To be clear, we are not asking the nurses to diagnose or interpret, we are asking them to relay in layman's terms, the results of the tests. To that end, we propose scripts be followed to ensure major communication points are covered.

Pathology results are typically stated in medical terms. For example, "invasive Carcinoma of no special type (ductal), grade 1 as sampled." In this situation, we would expect our nurses to communicate that cancerous cells were found in the tissue sample which would necessitate further action on the patient's part. Information from the nurse to the patient would be confined to what is available in the chart and documented by licensed independent practitioners.

As needed, we can attend a future meeting of the Board of Nursing to clarify this request, however it would also be helpful to have a written opinion from the Board of Nursing concerning whether we are asking our RNs to practice outside of scope by resulting positive pathology results, as explained above.

The Chair asked if there was anyone attending wishing to testify on this specific agenda item.

Staff reported that no one raised their hand.

The Chair asked the Board for discussion on this agenda item.

EO Fukunaga noted that an audience member on Zoom had raised a hand.

Ms. Shields-Hanson said that this sounded within the training of a nurse. The nurse was not being sent out to deliver this information to the patient without a policy in place. She felt that because it was within hospital policy, it was within the scope of practice for the nurse. She said it may be helpful for a patient to hear this information from a nurse who may already have a relationship with the patient.

Mr. Kuo said that as he looked at Hawaii Revised Statutes 457, he noted that nurses are always working in collaboration with their team. To him, this request was part of the collaboration process. It was important to him that this process helped to alleviate a delay in care. If a patient had to wait to speak with a provider, that could take some time.

The Vice Chair said that in her experience, a nurse could relay results, whether positive or negative. In the letter, it sounded like the nurses had guidelines to follow. To her, the practice as discussed was not out of scope.

The Chair asked if Mr. Aratani had any thoughts on this matter. Mr. Aratani said he did not.

The Chair said that to her, communicating a test result was absolutely within the scope of practice. Her only hesitation was that here, the nurse was relaying a positive cancer result. This was different from conveying, say, a pregnancy result. If the patient had questions, to what extent could a nurse answer them? She agreed with Mr. Kuo that this was intended to expedite patient care. She just had a concern that this situation pushed a nurse to the edge of their scope, placing them in a situation where they had to answer questions. If a nurse told her, "You have a positive cancer result, you need a surgical consult," then her immediate next questions would be: "What does that mean? What are my options? What are the implications of what you're recommending?" She thought that some of the answers to those questions would be outside of the scope of practice.

Mr. Kuo said he understood the Chair's concerns but felt that those concerns would likely be addressed by the script. Mr. Kuo noted that the Board was not being asked to review the script.

The Chair reiterated that it was certainly within a nurse's scope to relay test results. She said that nurses should be prudent in the conversation that follows the relaying of the test results.

Mr. Kuo said that he also saw this as RNs practicing to the full scope of their education and training. He felt that by saying they can't relay positive test results, that would pose an issue in a lot of other areas of the health system.

Staff noted that an audience member on Zoom had raised their hand. The Chair asked the individual listed on Zoom as "iPhone 130" to unmute their audio and allow for video.

The individual introduced herself as Celeste Mau, one of the nurses with Kaiser Permanente's Breast Care Team. She was concerned about what happens after test results are relayed and the patients start asking further questions, such as "Do I have cancer?" She wanted to know if the nurses could clearly answer that question. Yes, the pathology report did show that there were some cancerous cells in the tissue sample, but the patient had not been clearly diagnosed with cancer at that point. There was also concern that a nurse would be out-of-scope for answering a patient's further questions in this situation. She said that Kaiser's intent in this situation was to use nurses as the point of contact with the patient rather than a physician.

The Chair thanked Ms. Mau for her testimony.

EO Pang said that three days ago, the Executive Officers received documentation from some of the RNs working on the Kaiser Breast Care Team, including Ms. Mau. He had received a copy of a sample report that the RNs would be using. EO Pang noted that the report did not say whether an individual "had cancer," similarly to what Ms. Mau had said. The verbiage in the sample report discussed the presence of carcinoma. EO Pang said, when you bring this information to a patient, the first question from the patient is going to be, "Does this mean I have cancer or not?" Would a nurse then be exceeding his or her scope by answering that question?

Ms. Mau said that was exactly her point.

Mr. Kuo said, if the nurse is recommending the patient to see a surgical consult, you have to tell the patient why, or else that would be very strange. Why could that not be done by a nurse?

EO Pang asked, if you use the information in this report to tell a patient whether they do or do not have cancer, is that outside of the scope of an RN?

The Chair asked, is the point of a surgical consult to say that we need more information before we can make a diagnosis? Mr. Kuo answered yes to the Chair's question. The Chair said, then at that point, there is no diagnosis to relay and nobody is expecting a nurse to make a diagnosis because the point of sending a patient to a surgical consult is to get more information to confirm or disconfirm a diagnosis.

Ms. Shields-Hanson agreed with the Chair's statement. As an educator, she believed that this was aligned with the objectives of nursing school, which was to teach the RN to communicate with the client. The RN has the right to say that they are not making the diagnosis, they are just conveying this information. She said that nurses are trained to communicate information in this way.

EO Fukunaga noted that a "Linda" had raised her hand on Zoom.

Linda Cordova introduced herself as a member of the Kaiser Breast Care Team. She said that she was one of the nurses who had sent documents to the Board. She noted that the Breast Care Team was comprised of telephone nurses. Their only contact with the patient was to call them to let them know that the results of their recent imaging showed something that needed to be biopsied. She would then educate the patient about the biopsy procedure and schedule the procedure. She did not have a relationship with the patient or see them regularly. Their concern was that a patient was receiving this drastic, life-changing information from a registered nurse whom the patient had never met. She also wanted to address the Chair's prior question, whether the purpose of the surgery consult was to further explain whether the patient had cancer. Ms. Cordova said that typically, the results go to the patient's primary care provider who then calls the patient to give them the information, including whether they have cancer. Ms. Cordova said yes, the nurse can read the patient a copy of the test results, but the first question the patient is going to ask is, "Do I have cancer?" The main concern that the Breast Care Team had was being put in the position of giving a diagnosis of cancer and exceeding the scope of an RN. She believed that the sample script said something to the effect of "I'm sorry to tell you, but you do have cancer. You need to go see a surgeon." She understood that the script could be changed, and discussions were ongoing between her employer and her union, but she emphasized that this was always the patient's response. After being read the technical terms from a radiologist's report, the patient would ask, "What does that mean? Do I have cancer?"

Mr. Kuo noted that a nurse could still be subjected to this question when reaching out to a patient to say, "We need a biopsy. There's something suspicious on the radiology report."

Ms. Cordova said, it's one thing to tell your patient that their blood sugar level is high, but a nurse wouldn't tell the patient that they have diabetes, because that is a diagnosis. A nurse would tell the patient, "We need to monitor and manage your blood sugar," but they

would expect the diagnosis to come from a provider and then the nurse would educate the patient accordingly based on the provider's diagnosis.

The Chair called upon Laura Reichhardt, who had her hand raised. Ms. Reichhardt said that she had two points to offer for consideration. First, the three scopes of nursing practice – LPN, RN, and APRN – each had different limitations. The guidance in state law applied to all specialties and settings. The Board, administrative rules, and laws do not offer guidance for specific specialties. The guidance had to be general enough that someone in a rural setting, a telehealth area, and an acute care area could all use the same guidance. Second, what is the scope of practice? An RN can say, “this is a lab finding and this is the policy and procedure we have in our institution, leading to these next steps. These next steps mean you will go to a surgeon. There is no diagnosis today. They will work with you towards this diagnosis.” This is contrasted with the scope of an APRN, who can say, “here is the lab finding, we have this diagnosis,” and then also educate the patient. The question is, is this describing a policy and procedure in an organization helping the patient navigate that process, or is this a diagnosis? Is this describing a lab finding and a policy and procedure that gets triggered because of that? That is what she is hearing. She noted that this policy needs to be applied generally, regardless of whether the subject matter is as sensitive as cancer.

Mr. Kuo said that it is up to the institution's policies, procedures, and scripting.

Ms. Shields-Hanson said that she agreed with the last two comments. She did not think that this was a violation of the State's Nursing Practice Act. It was the Board's role to make sure that the Nursing Practice Act was being followed. If a nurse was uncomfortable with the institutional policy, then that discomfort had to do with institutional policy and was not related to the Nursing Practice Act.

The Chair called upon BJ Bartleson, who introduced herself as a health policy consultant. Ms. Bartleson said that this was a very good topic of discussion as all practices moved to a higher level of scope. She agreed with many of the comments before that the devil was in the details. She noted that she was a member of Hawaii-American Nurses Association, including their Advocacy Committee. This issue was brought before them as a matter of discussion. They did not get a lot of the detail about the policy and procedure. Looking at scope, nurses obviously don't diagnose disease, and so the question was: how can the policy and procedure of the institution give guidance to the nurses as they deliver some type of information so that they aren't infracting on their scope of practice? Much of the conversation has been about treating a patient's response to illness. Guiding a patient through a policy and procedure put forth by the institution, with nurses' input, could help with that. This sounds like a scope issue at first, but the details can be mapped out in a way that the nurse's scope of practice and the physician's scope of practice can be protected, and care from nurses can be expedited.

Ms. Cordova commented that the “details” were the Breast Care Team's concern. In this instance, where the nurses would become the first point of contact with the patient, taking the place of the doctor, the procedure was not “the nurse will call you first to go over the results and then the doctor will follow up.” The procedure was, “the nurse will call you, go over the script and results with you, and then you will go on to your next steps in this treatment.” The concern was that RNs were giving diagnoses of breast cancer, and that patients were depending on the nurses to impart this information.

The Chair called upon Jeremy Creekmore. Mr. Creekmore wondered what the intent of this policy was. Was the intent to give rapid information to the patient so that they don't worry? It seemed to him that this could create more worry as the patient waited upon the provider to go over the results. Or was the intent to use the nursing staff to take the edge off so that the provider did not have to deal with the emotional dumping of the patient upon communicating the test results? When looking at this particular healthcare system, which appeared overburdened to begin with, he wondered what the purpose was of having a nurse impart this information rather than a provider pick up the phone for five minutes to speak with the patient.

The Chair asked if anyone else wished to provide testimony on this agenda item. EO Fukunaga said that there were no raised hands.

The Chair said that, in summary, the consensus of the Board was that the relaying of a test result, whether positive or negative, is within the RN scope of practice. The Board encouraged nurses to engage with their employer to develop policies that allow them to deliver test results in a way that is reflective of their training, at top of their scope, and in the best interest of their patients. The Chair noted that this was an informal opinion of the Board, not an official opinion or decision, and therefore was not to be viewed as binding upon the Board or the Department of Commerce and Consumer Affairs.

The Chair announced the next agenda item.
