# <u>2024 Legislation:</u> Chair Wong asked if any members of the public would like to provide oral testimony on this agenda item.

Hearing none, Executive Officer Green provided updates on the following measures:

a) H.B. NO. 2523, H.D.1, S.D.1, Relating to Electric Utility Lineman

Beginning 1/1/2027, establishes licensing requirements, including minimum standards and qualifications, for licensure as a journey worker electric utility lineman and expands the Board of Electricians and Plumbers to include members engaged in electric utility work. Repeals an existing exception to the impending sunset of the limited exemption from electrician licensing requirements that was originally enacted by Act 65, SLH 2013, and extended pursuant to Act 60, SLH 2018, and Act 68, SLH 2022. Takes effect on 7/1/2027.

Executive Officer Green stated the Senate Committee on Public Safety and Intergovernmental and Military Affairs passed the measure, and was then referred to the Senate Committee on Commerce and Consumer Protection. That Committee did not hear the bill.

b) S.B. NO. 2917, Relating to Electric Utility Lineman

Beginning 1/1/2027, establishes licensing requirements, including minimum standards and qualifications, for journey worker electric utility linemen and expands the board of electricians and plumbers to include members engaged in electric utility work. Sunsets the original limited exemption from licensing requirements for qualified electricians that was originally enacted by Act 65, SLH 2013, and extended pursuant to Act 60, SLH 2018.

Executive Officer Green stated this bill was referred to the Senate Committee on Commerce and Consumer Protection, but the Committee did not hear the bill.

Mr. Bukoski asked to provide oral testimony regarding the approval of minutes and requesting clarification if the written corrections he submitted for the January 23, 2024, open session minutes were considered by the Board.

Chair Wong stated the Board received Mr. Bukoski's recommended corrections to its minutes of that meeting, they were duly noted, and the Board approved the draft of its meeting minutes, as is.

Mr. Bukoski asked the Board if it would consider corrections on comments made by testifiers.

DAG Leong stated that the policy for all Boards is to receive and consider recommendations for corrections to the drafts of minutes, but it is up to the Board to determine whether or not to accept the recommended corrections. However, the Board cannot substantively change the discussion that was provided in the draft minutes from a previous meeting.

Mr. Bukoski stated that the corrections he submitted were to clarify comments he made or did not recall saying; not necessarily to change the substance of what was being said.

DAG Leong stated that the Board should generally avoid amending what is already on record by making after-the-fact clarifications. This not only applies to public testimony, but also to Board member comments as well.

Mr. Bukoski asked if his testimony would be part of the record.

DAG Leong informed Mr. Bukoski that if he has comments on or clarifications to statements made at a previous meeting, then he may provide them in his oral testimony now and his comments or clarifications would be recorded in the minutes of this meeting.

Mr. Bukoski stated that, based on his recollection, there are some statements that are either incorrect or inaccurate. His testimony is an attempt to provide clarification. He added that other Boards have adopted video recordings of Board meetings. As the subject matters that his Board discusses is important, he suggested that this Board consider implementing video recordings, which may assist in providing accurate information.

Executive Officer Ito asked Mr. Bukoski if there is anything that he'd like to clarify at this time, which would be reflected in the minutes for this meeting.

Mr. Bukoski stated that he would have to go back and review his testimony line-by-line.

As Mr. Bukoski expressed no further comments or questions, Chair Wong asked if any other members of the public would like to provide oral testimony on this agenda item.

Seeing none, Chair Wong proceeded to the next agenda item.

<u>Adjournment</u>: There being no further business to discuss, the meeting adjourned at 11:04 a.m.
