A. February 2, 2024: Open Meeting and Executive Session

After Chair Oliveira Cabbab asked other members if they had any changes or corrections, it was motioned by Dr. Pedro, seconded by Vice Chair Ching, and unanimously carried to make non-substantive corrections to the executive session minutes, and to approve the open session minutes with following amendments:

On page 3:

"He added, since the decision making had not been released from the House Health committee for HB1830, he was unsure if the requests to amend the language to allow applicants to sit for examination on a degree and internship by other testifiers, including the Hawaii Psychological association were accepted."

• On page 3:

"Vice Chair Oliveira Cabbab was concerned that the language as it was written was not clear and that it should be so that applicants do not believe they can take the exam prior to their postdoctoral experience."

B. March 8, 2024: Open Meeting and Executive Session

It was motioned by Dr. Stern, seconded by Vice Chair Ching, and unanimously carried to approve the executive session minutes with a non-substantive correction and the open session meeting minutes with the following amendments:

"EO Fernandez informed the Board that HB1830 was alive and that it had passed through its 3 committees: Health and Homelessness ("HLT"); CPC; and House Finance ("FIN") committee".

On page 6:

"Vice Chair Oliveira Cabbab asked if this process is similar to the process the Board uses to review non-APA programs. She added that the Board would want to see that the internship was an organized sequence of training, and the criteria is laid out nicely, e.g., APPIC standards".

"EO Fernandez discussed his experience with developing the provisional license with the Board of Speech Pathology and Audiology".

"On a motion by Dr. Stern, seconded by Vice Chair Oliveira, the Board unanimously voted to support the intent of HB1830 HD2 and to provide comments".

On a motion by Vice Chair Ching, seconded by Dr. Stern, and unanimously carried by members present, the Board voted to approve the application of Dr. Martin for licensure by examination waiver.

B. Ratification List

Chair Oliveira Cabbab noted that Dr. Rosemarie Charles, who was included in the ratification list of the agenda, was approved at the Board's previous meeting and therefore should be removed from the list prior to its ratification.

Board Administrative Matters & Planning:

Chair Oliveira Cabbab opened the conversation to updating Board member assignments, such as the Permitted Interaction Group ("PIG") regarding rules change and legislative session.

DAG Kim suggested that members consider assigning (2) members to research subjects, so that the use of a PIG is not needed for subject matters not needing them. He added that there are specific statutory purposes for creating a PIG which are strict, and the PIGs are limited in purpose requiring 3 separate meetings to create the PIG, for the PIG to report findings, and then a meeting to address the subject.

Dr. Pedro asked what advantages there are to create a (2) person committee, as opposed to a PIG.

DAG Kim explained that Hawaii sunshine law bars the Board as a whole from speaking outside of meetings. He stated that an ongoing (2) person committee would not have this issue since it was under the maximum allowed by sunshine laws.

After some discussion which provided a brief outline of the rules change process set forth by HRS chapter 91, the Board decided to continue the rules change preparation leading up to its next meeting. Tasks include research and planning, specifically members are encouraged to identify which sections will require updates, and review laws and rules related to the process including sunshine laws. The Board also requested to hear from DAG Kim who will provide a brief overview of the sunshine laws governing member permitted interactions outside of meetings.
