<u>Administrative</u> <u>Rules Change</u>: Chair Oliveira Cabbab deferred discussion on this agenda item, but made some clarifying comments about the progress the Board and staff were making in preparing for this subject. She additionally confirmed that there was no public testimony.

She stated that the Board would first be focusing its attention on degree, internship, postdoctoral experience requirements as they pertain to rules change. She noted that EO Fernandez had been working on compiling information for the Board to compare national standards, added that she suggests the Board review internship and postdoctoral experience.

EO Fernandez additionally recommended the Board review the Standards of Accreditation for Health Service Psychology guidelines of accreditation by the American Psychological Association ("APA").

Chair Oliveira Cabbab continued by adding there may be some changes needed in order for requirements for licensure in Hawaii to be comparable with APA and the Association of Psychology Postdoctoral and Internship Centers ("APPIC") current standards, but emphasized the Board needs additional language on internship and postdoc requirements, that currently, the statute and administrative rules chapters are silent on.
