Call to Order: There being a quorum present, Chairperson Nishek called the meeting to order at 9:09 a.m.

Agenda: The agenda was posted on the State electronic calendar as required by Hawaii Revised Statutes (“HRS”) section 92-7(b).

Amendment to the
Agenda:

It was moved by Mr. Higashihara, seconded by Mr. Polischeck, and unanimously carried to amend the agenda to correct the following inadvertent error:

Applications Committee Report, item b. Jensen Pool Service Hawaii LLC, delete “B” General building and add C-5 Cabinet, millwork, and carpentry remodeling and repairs.

Minutes:

It was moved by Mr. Alejado, seconded by Mr. Polischeck, and unanimously carried to approve the Applications Committee Meeting Minutes of September 3, 2024 and the Board Meeting Minutes of July 19, 2024 and August 23, 2024.

Committee
Reports:

1. Scope of Activity Committee:
Paul Alejado and John Polischeck, Co-Chairpersons

a. Kainoa Holt

Requests a determination on whether a contractor’s license is required to build traditional Hawaiian houses known as hāle to potentially be offered as dwellings for people to live in. If a license is required, which classification is required to build traditional Hawaiian houses and/or structures.

Chairperson Nishek stated that the Kauai Department of Public Works (“DPW”) allows cultural practitioners to construct of Hawaiian hāle without a building permit provided that the structures are not used for occupancy (cannot live in the structure). The Board stated that Mr. Holt will be contracting with the public to construct traditional Hawaiian hāle. The drawings submitted show that the rock wall is a structural wall.

The Board also noted that the State Building Code Adopted by State Building Code Council on 11/13/2018, Appendix X, Table X203.1 states that the Hale noa is the only structure that permits sleeping as an allowable use. Chairperson Nishek stated that on Kauai, cultural practitioners need to apply with the DPW and ensure that the structure is not in a flood zone. Cultural practitioners are only allowed to use natural materials to build the hāle. Mr. Lau stated that traditional Hawaiian hāle are exempt from the International Building Code. Mr. Polischeck stated that a contractor’s license is required to contract with the public to construct the traditional Hawaiian hāle. Mr. Hayashi stated that the hāle he is aware of were built for cultural purposes, which is different from contracting with the public to build these structures. The Board discussed requiring a “B” General building classification for consumer safety; if people will be living in the hāle, it should be structurally sound.

Recommendation: Based solely on the information provided, a “B” General building and a C-31b Stone masonry contractor’s license is required to build traditional Hawaiian hāle.

b. Nicholas Muragin

Requests a determination on the contractor license required to drill holes for drywells for drainage, HELCO power poles, and cell tower foundations. The holes ranges from 1 to 10 feet in diameter and from 1 to 50 feet in depth. Mr. Muragin may assist in adding concrete rings in the drywell, may assist in lowering a rebar cage in the hole for cell tower foundations, and does not set the power poles for HELCO.

Executive Officer Ito stated that initially she provided Mr. Muragin with the Board's July 21, 2006 and August 17, 2006 meeting minutes in which the Board determined that the digging and setting of utility poles (new and replacement poles) and anchors falls under the scope of the C-68PR Erect new poles in new pole lines only classification. Mr Muragin responded that he is not interested in setting the poles for HELCO, he just drills the holes for the pole.

Chairperson Nishek stated that Mr. Muragin is digging holes that are 50 feet deep and setting some of the rings which is similar to building a cesspool. Mr. Polischeck stated that if Mr. Muragin is only digging the holes and does not set the concrete rings, backfill, or rebar cages, it appears that a license is not required. He could be contracted by an "A" General engineering contractor to just dig the holes.

The Board reviewed the description of the C-57 Well and C-35 Pile driving, pile and caisson drilling, and foundation classifications. Both classifications involve more than drilling holes. If the drill rig is just picking up the rebar cage and placing it in the hole and a contractor (e.g. an "A" General engineering contractor) sets the rebar, a license is not required. Setting the rebar cage to its final location to specification involves measuring, making sure of the clearances, etc. If Mr. Muragin is out on his own without a licensed contractor and he is setting the concrete rings and rebar cages, then he would need a contractors license. If Mr. Muragin is lifting the concrete rings and rebar cages, it is similar to crane service for which a license is not required.

Because Mr. Muragin is digging large holes, the Board discussed a C-17 Excavating, grading and trenching classification. The drilling rig is attached to an excavator and the drill bit pulls the earth material out. Contractors rent the drill rigs and the operator and once the hole is dug, the contractor removes the spoils from the hole; they just provide a drilling service. Mr. Shintani stated that if an individual were not drilling for a licensed contractor, there is a lot of liability because of underground power and water lines.

Recommendation: Based solely on the information provided, the general scope of work requires an "A" General engineering license. A contractor's license is not required to drill holes and hoist concrete rings and rebar cages, provided that Mr. Muragin is contracted by a licensed "A" General engineering contractor to perform that work.

- c. Apply-A-Line LLC
State of Hawaii, Department of Transportation, Airfield Rubber Removal & Pavement Markings Maintenance Statewide, Project No. BS1424-23

Requests a determination on the contractor license required to perform water blasting. Apply-A-Line LLC requests that “water blasting rubber removal” and “water blasting stripe removal” be identified as prep work to the striping or pavement marking work as identified in the C-3a Asphalt concrete patching, sealing, and striping classification.

The scope of work consists of removing rubber deposits of variable thickness from asphalt concrete pavement, removal of existing runway designation markings within the rubber removal areas, periodic repainting of runway or taxiway centerlines and other airfield markings.

Candice Edmundson, Project Administrator for Apply-A-Line LLC stated that they are a local concrete striping contractor. They are requesting to add water-blasting to the scope of the C-3a Asphalt concrete patching, sealing, and striping classification. Ms. Edmundson stated that the purpose of the water blasting is for stripe removal, rubber removal from runways, and surface preparation. Sometimes they restripe after they remove the rubber and sometimes, they just remove the rubber for maintenance of the runway.

Mr. Polischeck stated that any method used to remove existing striping to re-stripe is considered as surface preparation for striping and is included in the scope of the C-3a; a license is not needed just for water blasting to remove the striping. Any surface preparation required to restripe is in the scope of the C-3a. Rubber removal by pressure washing for maintenance does not require a contractor’s license. The contractor must determine which method of surface preparation would produce the best result. The Board should not just state one type of surface preparation because it would be misleading and may appear that there is only one method of surface preparation.

The Board explained that the C-33 Painting and decorating classification includes surface preparation. The C-33c Surface treatment contractor license is required if the C-33 contractor does not perform the surface preparation; the C-33c Surface treatment contractor is contracted only to perform the surface preparation for the C-33 contractor.

Recommendation: Based solely on the information and testimony provided, a license is not required to perform water blasting for maintenance and cleaning. Any method used, including but not limited to water blasting, to remove striping for surface preparation is included in the C-3a Asphalt concrete patching, sealing, and striping classification.

It was moved by Mr. Alejado, seconded by Mr. Polischeck, and unanimously carried to approve the above scope recommendations.

Chapter 91, HRS,
Adjudicatory
Matters:

Chairperson Nishek called for a recess from the Board's meeting at 9:50 a.m. to discuss and deliberate on the following adjudicatory matter pursuant to HRS chapter 91.

1. Settlement Agreements

In the Matter of the Contractors' Licenses of Su Builders, Inc. and Sam Su Chon; CLB 2023-277-L

RICO received a complaint from a consumer about a contract to demolish a residence and construct a new two-story residence in its place (hereinafter "the Project"). The complaint alleged, among other things, that Su Builders, Inc. and Sam Su Chon ("Respondents") departed from the construction plans, failed to complete the work, and abandoned the Project.

RICO alleges the contract for the Project failed to include required disclosures of lien or bond rights and the contractor right to repair. Further, RICO alleges that Respondents completed specialty work outside of Respondents' license classification.

If proven at an administrative hearing, the foregoing allegations would constitute violations of the following statutes and/or rules:

- Hawaii Revised Statutes ("**HRS**") § 444-17(3) (abandonment of project without reasonable or legal excuse);
- HRS § 444-17(5) (willful departure from the construction plans in a material respect without consent of the owner);
- HRS § 444-25.5(b) (failure to provide consumer with required written disclosures); and
- Hawaii Administrative Rules § 16-77-33(a) (completing specialty work outside of licensee's classification).

Respondents agree to pay an administrative fine in the amount of three thousand five hundred and no/100 U.S. dollars (\$3,500.00).

After discussion, it was moved by Mr. Polischeck, seconded by Mr. Suehiro, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order in the above case.

Following the Board's review, deliberation, and decisions in these matters, pursuant to HRS chapter 91, Chairperson Nishek announced that the Board was reconvening to its open meeting at 9:53 a.m.

Do not include the time spent for design, ordering materials, scheduling, downtime for rain-outs, or waiting for delivery of materials.

The revised project list must include additional projects in the broad scope of the "A" General engineering classification and a detailed description of the work he supervised (including but not limited to the

number of cubic yards excavated) while he was on-site supervising his employees performing work in the "A" classification; and remove all "B" General building projects (buildings that were constructed for occupancy by people or animals). Mr. Tomas may document projects where he was on-site directing and supervising his own crew performing work in the broad scope of the "A" classification from more than ten years ago. Also submit an Experience Certificate verifying his on-site supervision and direction of his employees performing work in the "A" General engineering classification from the RME of one of your employers or an Experience Certificate from employees who worked with him and have direct knowledge of his experience performing on-site supervision and direction of employees performing work in the "A" General engineering classification; and

- "B" General building – a revised project list verifying forty-eight months of Mr. Tomas' on-site supervision and direction of his own employees constructing buildings from the "ground-up" in the broad scope of the "B" General building classification, specifying the trades performed in house and the work or trades subcontracted to other licensed contractors. The revised project list should include new stand-alone "ground-up" projects that he was on-site supervising his employees building the structure from start to finish specifying the trades performed in house and the work or trades subcontracted to other licensed contractors.
