Board Business:

USA Boxing, Hawaii Association Report on Amateur Events

Eiichi Jumawan was promoted to panelist.

Mr. Jumawan highlighted recent USA amateur boxing events.

Mr. Jumawan noted a recent coaching clinic put on for local coaches by USA Boxing. This program is meant to standardize boxing strategies across the country. All attendees passed.

Mr. Jumawan noted that Michael Pruitt has been appointed president of the local boxing chapter of USA Boxing.

Mr. Jumawan stated that amateur boxing events will be held on April 27, 2024, and May 4, 2024.

Ms. Jumawan noted an additional amateur event will take place on March 22, 2024, in Kailua Kona. Ms. Jumawan highlighted additional potential upcoming events.

Chair Freitas thanked Mr. Jumawan for his service to amateur boxing in Hawaii.

EO Skizewski asked, and Mr. Jumawan noted that he will continue to help USA Boxing by holding clinics for boxers and officials.

Senate Bill ("SB") 2170 Senate Draft ("SD") 1 Relating to Combat Sports

EO Skizewski highlighted SB 2170 SD1 which establishes a new regulatory framework for combat sports contests in Hawaii by renaming the existing Boxing Commission of Hawaii as the Combat Sports Commission of Hawaii, expanding the Commission's jurisdiction to include all combat sports, and repealing existing law governing mixed martial arts contests in Hawaii.

EO Skizewski briefed the Commission on the creation and history of the State of Hawaii's Mixed Martial Arts Contests ("MMA") Program and MMA events in Hawaii.

EO Skizewski noted that the State of Hawaii Department of Commerce and Consumer Affairs ("Department") has supported the combining of the State Boxing Commission and the Combat Sports Commission as the most cost-effective way to regulate combat sports in this state.

EO Skizewski noted SB 2170 SD1 has recently been amended by State of Hawaii, House of Representative, Committee on Consumer Protection, to create two separate regulatory entities, one for boxing and one for mixed martial arts.

EO Skizewski concluded that it would be prudent for this Commission to provide comment on the bill in the case that the bill is amended further to combine the two combat sports areas under one commission.

Mr. Verdi was promoted to panelist.

Mr. Verdi noted that California works closely with the national association to regulate all of boxing under national standards.

Mr. Verdi was promoted to attendee.
