Agenda: The agenda was posted on the State electronic calendar as required by HRS section 92-7(b).

A brief video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board during the meeting.

Call to Order: The Vice Chair proceeded with roll call of the Board members. Members joining by Zoom confirmed that they were present and alone. There being a quorum present, Vice Chair Hall called the meeting to order at 12:09 p.m.

Approval of the
May 14, 2024, The Vice Chair asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Minutes:

It was moved by Mr. Murata, and seconded by Vice Chair Hall, and unanimously carried to approve the meeting minutes of the open and executive session of the May 14, 2024 meeting as circulated.

Ms. Margaret Williams raised her hand for comment. She stated that from reading through the May 14, 2024 open session minutes reads to her that nail technicians cannot touch any type of disorder or disease of nails. She believes that she had stated "what was infectious is what they cannot touch".

EO Shahan asked Ms. Williams for the page number which she is referencing.

Ms. Williams was not sure as what page she was referencing but was the first item on the agenda.

EO Shahan stated that she could be referencing pages 4 – 5 of the open session minutes.

Ms. Williams asked the board members if they agreed on the intent to not touch anything if they are professional enough to recognize disorders instead of diseases that are not infectious.

Vice Chair Hall responded that she had interpreted that section as nail technicians are not diagnosis anything.

Ms. Williams stated that diagnosing is determining if it is safe to touch or not.

EO Shahan asked if Ms. Williams was referring to page 5 paragraph 4 of the May 14 open session minutes and read the paragraph.

Ms. Williams stated that the paragraph might have started with The Chair said "no".

EO Shahan read page 5 paragraph 1 out loud for Ms. Williams for confirmation that it is what she is refereeing to.

Ms. Williams restated that the way the minutes are written it infers those manicurists cannot do the job they are supposed to be doing. Which is taking care of people who have disorders that can be taken care of and love to get them done as long as they are not infectious, and the manicurist is senior enough to do it they should be able to do it. She thinks that something should be added to the minutes to make that clear.

DAG Kim added that on page 5 paragraph 5 seems to cover Ms. Williams concerns.

EO Shahan restated that Ms. Williams concerns look to be covered on page 5 paragraph 5 and read the paragraph out loud.

Vice Chair Hall added that the paragraph that was read out loud states that if a manicurist is senior enough and have the knowledge to decide if you will or will not take the client.

Ms. Williams asked the board for confirmation as she does not read that section as a manicurist cannot work on the client and the board does read it as they are able.

Vice Chair Hall confirmed that the follow up statement of paragraph 5 it does state that the manicurist can work on the client.

Ms. Williams added that it only mentions "fungus" but does not mention other disorders and diseases.

EO Shahan stated that the minutes have already been voted on and if there are any changes to be made to the minutes that the board will need to revote on what is going to be changed to the minutes. If the board wants something changed.

Vice Chair Hall stated that she doesn't think that it needs to be changed as she thinks it is clear. She adds that in the minutes it does state that the chair stated "no they are not able to, and they are to send them to their doctors" as they are not able to diagnosis the client, the milady book was covered and reading the minutes as a whole no changes need to be made.

Ms. Williams replied that she just wants to make sure that the boards statements do not restrict the work for a manicurist.

Mr. Murata added that based upon paragraph 5 and feels that it is inferring to let the technicians determine if they can work on the client.

Ms. Williams stated that she wanted it to be clear on the board's statements.

Executive Officer's
Report:

The Vice Chair asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Ethics training for State Board Members.

EO Shahan reminded the board members that the ethics training for State Board Members are to be completed every 4 years. Vice Chair Hall will need to recomplete in August 2026, Mr. Murata November 2024, and Mr. Basta June 2026.

Ms. Cornelio stated that she had completed and submitted the training.

The Vice Chair asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

EXECUTIVE SESSION

At 12:23 p.m. it was moved by the Mr. Basta, seconded by Mr. Murata, and unanimously carried for the Board to enter into Executive Session to consider and evaluate personal information relating to individuals applying for licensure in accordance with HRS section 92-5(a)(1), and to consult with the Board’s attorney on questions and issues pertaining to the Board’s powers, duties, privileges, immunities, and liabilities in accordance with HRS section 92-5(a)(4). (Note: Board members and staff entered into a ZOOM Breakout Room).

At 12:53 p.m., it was moved by Mr. Basta, seconded by Mr. Murata, and unanimously carried for the Board to move out of Executive Session and to reconvene to the Board’s regular order of business.

A. Apprenticeship Applications:

It was moved by Mr. Murata, seconded by Vice Chair Hall, and unanimously carried to approve Chelsea Gouveia’s Beauty Apprentice application with conditions.

It was moved by Mr. Murata, seconded by Vice Chair Hall, and unanimously carried to approve Patrick Sundahl 's barber application for exam.

ii. Rebecca Blessum

It was moved by Mr. Murata, seconded b Vice Chair Hall, and unanimously carried to approve Rebecca Blessum's Cosmetologist application via exam waiver.

iii. Amber Ledesma-Quinata

It was moved by Mr. Murata, seconded by Vice Chair Hall, and unanimously carried to approve Amber Ledesma-Quinata's cosmetologist application for exam with conditions.

D. School Applications:

i. University of Hawaii, Maui College

It was moved by Mr. Murata, seconded by Vice Chair Hall, and unanimously carried to approve the school application for the University of Hawaii, Maui College pending receipt of additional documentation.

It was moved by Mr. Murata, seconded Vice Chair Hall, and unanimously carried to ratify the list of issued licenses attached (see attached list).

Correspondence:

Letter of Concern for Barbering and Cosmetology Teaching/Apprenticeship email from Brianna Laimana-Whitmen, June 11, 2024.

The Vice Chair asked if any members of the public would like to provide oral testimony on this agenda item.

Ms. Brianna Laimana-Whitmen appeared in person to add testimony on this agenda item.

Ms. Laimana-Whitmen a licensed Cosmetologist, Barber, and instructor introduced herself. She reported to the board that she teaches her students those rules and laws are black and while and are to the read left to right. They are not allowed to assume anything, and it is all what is in front of them.

Ms. Laimana-Whitmen explained that she is a licensed cosmetologist, attended a hairdressing school, attended an esthetician school, attended a

manicuring school, attended a barber school, and attended a school for her instructor's license. According to the State of Hawaii she is only a cosmetology instructor. Upon attending all those schools, she was only allowed to obtain three licenses out of six. She brought these up because a barber can practice with a hairdresser, and an esthetician.

Ms. Laimana-Whitmen asked to confirm a barber can learn from an esthetician.

EO Shahan answered no. She stated that based up on the new law, §438 and §439 were repealed in July 2022 and the new statute is §439A. Statute §439A -2 states barber apprentices may train under a cosmetologist or hairdresser for the hairdressing portion of training. She clarified that a cosmetologist and hairdresser cannot teach shaving they can only train on the hairdressing portion.

Ms. Laimana-Whitmen voiced her concern that if she is notable to obtain all six licenses; why a barber would not want to train without a barber.

EO Shahan responded that they do not have the ability to read the minds of barber apprentices. There are many factors which inform an individual in choosing their supervisor, but it does mean that they would need to do two registrations to complete their barbering training. They would need to register as a barber apprentice under the cosmetologist/hairdresser and do all the hairdressing hours. They would then need to register for a second apprenticeship under a barber to obtain the barbering training. The barbering apprentices are forced by necessity to have two registrations, which in turn means they are paying double for their apprenticeships, but they are not learning things outside of the scope of a barber.

Ms. Laimana-Whitmen stated that she has a better understanding from what was explained at the last meeting.

EO Shahan clarified that from the last meeting was that a cosmetologist can teach the facial part, but hairdressers cannot as they do not do the facial massage part.

Ms. Laimana-Whitmen thanked EO Shahan and the board.

EO Shahan asked the board if they had any comments to add.

There was none.

New Business:

The Vice Chair asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

- A. Delegation of Responsibility to the Executive Officer to Approve Barber and Beauty Operator Apprenticeship and License Applications with DUI Convictions pursuant to HRS section 436B-8.

EO Shahan explained to the board that the first item deals with applicants with a single DUI and have completed the terms that the court imposed on them. No outstanding fees, no probation, no parole, or incarceration that needs to be completed.

EO Shahan asked to save the boards time would the board like to delegate the responsibility of reviewing and approving those individuals' applications to the EO's or the Chair rather than reviewing those applications in the board meeting. Or does the board feel like they would like to see those applications.

Vice Chair Hall asked if it only must include single DUI's what if it includes multiple convictions. For example, an applicant has multiple convictions from "1975" and they paid their dues, and we don't have to look at it.

DAG Kim clarified that the applications come to the board because they are up to the board's digression and the EO's do not have that digression to approve those applications because of the criminal conviction. If the board wants to delegate, the ability to do so it would need to be very specific on the delegation so the EO's know what to do within the scope of what is being delegated to them.

Vice Chair Hall answered that if the applicant with a single DUI has paid their fine, done their duty according to the court she feels that they can move on with their careers. But she feels that applicants with more than a sign DUI if they had paid their fines, no probation, no parole, it seems to her that they are the same if they are already paid and done.

EO Shahan reminded that the purpose of the board is to protect the public, if an individual has convictions, some convictions are more egregious than others and some probably would not affect the public. Generally, barbers and beauty operators are not driving as part of their job which is one of the reasons why the EO's thought this would be something the board would like to delegate. Theft however, customers put their purses down and go to the back to get their hair done or don't pay attention to their belongings because they are relaxed as they are receiving services. Drug use, by the time applicants have applied they have already addressed their addictions and are in recovery. Due to public safety if the convictions are for theft, drug use, or assault are things that as Executive Officers feel the board's responsibility to protect the safety of the public.

EO Shahan explained that since barbers and beauty operator are not driving as part of their job that a non-repetitive DUI is not endangering the safety of the public.

Mr. Basta answered he would not have a problem with delegating that as it is a one-off to the EO's.

Ms. Cornelio asked what the chances would be if the applicant with the single DUI that has not been completed, would be denied licensure.

EO Shahan answered that if the terms have not been completed it would be presented to the board for determination to move forward with conditions or wait until the court decided what the final terms would be.

Vice Chair Hall asked Mr. Murata if he had any questions or comments.

Mr. Murata stated that he agrees with the EO's, a single happening DUI is one time and they have not repeated any offences. Any other offense there is temptation, and the board should be allowed to see how often, when was the last occurrence, so a decision can be made as a board.

It was moved by Vice Chair Hall, seconded by Mr. Murata, and unanimously carried to delegate the responsibility to the Executive Officer to approve Barber and Beauty Operator Apprenticeship and License Applications with DUI Convictions pursuant to HRS section 436B-8.

- B. Administrative Rules Committee Pursuant to HRS 436B-7 and 439A-5. EO Shahan reported that it has been two years since the completion of merging the Barbering and Cosmetology statutes. It is now time to get the administrative rules to be combined and updated. Generally, a rules committee is formed to do the leg work and then reports to the board. The committee would need to be less than quorum.

DAG Kim suggest appointing two board members to the committee and those two committee members can talk to each other outside of Sunshine law, outside of the public meeting. DAG Kim suggest two members due to specific rules and guidelines that need to be followed when there are more than two members appointed.

EO Shahan stated that there are two separate sets of rules that need to be referenced, she will assist the committee with referencing previous minutes requesting for an update or items to be added over the last twenty years. If there are two people interested in volunteering at today's meeting or if time is needed to think about it, this item can be pushed back to the next meeting.

Mr. Murata recommended that a cosmetologist and a barber be on the committee as they would represent both sides of the apple.

EO Shahan clarified a barber and a beauty operator.

Mr. Murata answered yes, a barber and a beauty operator.

Vice Chair Hall stated that she is a nail technician, business owner, and a salon customer and is willing to volunteer as a committee member.

Ms. Margaret Williams has her hand raised in the ZOOM.

Vice Chair Hall agreed to allow public testimony for this agenda item.

Ms. Williams asked she would be able to be on the committee.

EO Shahan asked DAG Kim if public input is only allowed later.

DAG Kim answered that he would need to investigate that. A response to her question will be provided later.

Mr. Murata asked if this agenda item would need to wait till the next meeting for Ms. Williams question to be answered.

EO Shahan responded that DAG Kim advises to get the two volumeters now and report back at the next meeting about a third.

Ms. Cornelio volunteered.

EO Shahan stated that a vote can be made to establish the rules committee and revisit next meeting regarding a third member.

Vice Chair Hall asked if at any point herself or Ms. Cornelio have any questions would they be able to reach out to another board member or a member of the public.

EO Shahan answered not at this time. The committee would first be working on a draft. Copies of the rules will be sent to them, and she is currently still going through minutes regarding updates and change recommendations from the past twenty years.

It was moved by Vice Chair Hall, seconded by Mr. Basta, and unanimously carried appoint Vice Chair Hall and Ms. Cornelio as members of the Administrative Rules Committee Pursuant to HRS 436B-7 and 439A-5.

- C. Election of Chair and Vice Chair Pursuant to HRS 436B-6(a).
Ms. Hall volunteered to be nominated as Chair.

Mr. Murata volunteered to be nominated as Vice Chair.
