The Chair and Ms. Boyer mentioned that they forwarded non-substantive amendments to the Executive Officers for both the open and executive session minutes of the October 3, 2024 meeting.

Upon a motion by Ms. Boyer, seconded by Mr. Kuo, it was voted on and unanimously carried to approve the open and executive session minutes of the October 3, 2024 meeting as amended.

**Seventeenth Proclamation Relating to Wildfires**

EO Pang reported the Eighteenth Proclamation Relating to Wildfires was issued on October 8, 2024, which is set to expire on

December 7, 2024, unless terminated or superseded by a separate proclamation.

Reports:

**Hawaii State Center for Nursing – Laura Reichhardt, Executive Director**

Ms. Reichhardt reported:

- Midwifery bill likely to be introduced
  - Affects nurse midwives who are licensed in HRS Chapter 457
- Tracking similar bills to HANA
- Completed HRS review – 2 year initiative
  - Review 528 bills
  - Finalizing draft and sharing with Legislature and various State departments
  - Thanked everyone for their hard work
- Held the Nursing Scientific Symposium
  - Highlighted nurses leading in research and evidence-based practice in the State
  - Impacting nursing process and patient care
- Brianne Kuwabara, runs Clinical Placement Collaborative and Transition to Practice Program
  - Awarded by HAH
- Co-Hosting Leadership in Action Conference
  - November 14-15 at the Prince
  - Keynote speaker, Katie Boston-Leary of ANA
    - Developed Nurse Staffing Thinktank
    - SHIFT Nursing – recent documentary
- Working on nursing workforce projections, focus groups that lead to strategic planning, programs that work to promote recruitment and retention, quality practices and best outcomes.

**Hawaii American Nurses Association – Elizabeth Kahakua**

Ms. Kahakua reported:

- Currently have 455 members
- Just had annual conference
  - Keynote speaker, Jeff Doucette of Press Ganey
  - Spoke about how to improve things for nurses, culture of nurses, how to welcome new nurses and how to retain nurses
  - Staffing shortages

- Leadership Summit in December
  - Some bills may not go as planned due to recent election
  - Keeping an eye on nursing shortages and strike on Maui
- LRB study on nurse/patient ratio
- Tracking - Nurse Preceptor Tax Bills, APRN Compact, Workplace violence, Continuing Education requirements about Alzheimer's for some professions, Medicaid reimbursement fees, HELP Repayment Program

Mr. Kuo asked what is ANA's position on the APRN Compact.

Ms. Kahakua replied that ANA is currently reaching out to all the chapters; the APRN Compact will be a topic of discussion at the Leadership Summit in December. It appears that they are in support of the compact, because they support nurses practicing at the top of their scope. She stated that she will report on this at the January meeting.

**Hawaii Association of Professional Nurses –  
Jeremy Creekmore**

Scope of  
Practice:

**Correspondence**

Email inquiry from Gwen Kreitzman, dated October 7, 2024 regarding the necessary licensure and certification to perform the following procedures: plasma pen, HIFU, micro-needling, micro-dermabrasion, Botox, collagen threading, and laser.

EO Pang read the email received from Gwen Kreitzman, as follows:

*"To whom it may concern,  
Thank you for the scope of practice however, I need to know what I need in order to perform invasive aesthetic procedures.*

1. *What licenses and certificates are needed to open a face spa doing these procedures?*

- *Plasma pen*
  - *Hifu*
  - *Micro needling*
  - *Mirco dermabrasion*
  - *Botox*
  - *Collagen threading*
  - *Laser*
2. *Who is the professional that can perform these invasive procedures? (nurse practitioner/dermatologist/)*
  3. *Also if it is written that a nurse practitioner can perform a procedure under physician supervision, what does this mean? Direct supervision or a medical director that takes responsibility?*
  4. *What certificates do we need for the business and how do we register (aesthetics and invasive procedures in case there are different certificates needed for each)?”*

EO Pang stated that he provided excerpts from previous Board meetings; specifically the April 2016 and December 2019 meetings.

At the April 7, 2016 meeting, the Board informally opined:

*“After some discussion and careful consideration, although the Board had concerns that the administration of botox for cosmetic purposes and laser treatments were not basic nursing tasks and that other licenses may be required in order to perform such treatments for cosmetic purposes, it is the Board’s informal interpretation that the nursing laws and rules do not specifically prohibit a nurse from administering botox or performing laser treatments, therefore, an RN may administer medications such as botox and may perform laser treatments provided the performance of professional services commensurate with the education preparation and demonstrated competency of the individual having specialized knowledge, judgment, and skill...and using reasonable judgment in carrying out prescribed medical orders of a licensed physician (HRS §457-2, definition of “The practice of nursing as a registered nurse”)*

*Furthermore, the RN is accountable and responsible for the quality of nursing care rendered.*

*In addition, pursuant to HRS §457-1.5, “The scope of nursing practices established in this chapter and by the rules of the*

*board shall serve as general guidelines and are not intended to address the appropriateness of the use of specific procedures in any particular work setting or to grant permission to implement specific procedures in any particular work setting.”*

*In accordance with HAR §16-201-90, the above mentioned interpretation is for informational and explanatory purposes only. It is not an official opinion or decision and is thus, not binding on the Board.*

EO Pang stated that in December 2019, the Board upheld their April 2016 decision in response to an email inquiry regarding the ability of an RN to administer Botox and Dysport, laser hair reduction, and dermal fillers, along with microneedling with radio frequency, OxyGeneo facials, and chemical peels. The Board also informally opined at this meeting that an RN would have to carry out the orders of a licensed physician in order to obtain the prescription drugs to administer or to perform “laser” procedures as the Hawaii Medical Board considered “laser” treatment a medical procedure.

Mr. Kuo clarified that APRNs are also able to perform these procedures, prescribe and recommend these procedures in a treatment plan. Mr. Kuo commented that although it may be semantics, all of the procedures listed in the email inquiry are considered minimally invasive; despite being labeled as invasive aesthetic procedures by Ms. Kreitzman. He stated that this is an important nuance to clarify as none of these procedures go beyond a typical blood-draw.

In response to the first question, “What licenses and certificates are needed to open a face spa doing these procedures?”, the Chair responded that this is outside of the Board’s purview to determine and no comment will be provided.

In response to the second question, “Who is the professional that can perform these invasive procedures? (nurse practitioner/dermatologist/”, the Chair responded that the Board is unable to comment on another profession’s scope of practice and is only able to determine whether a nurse is able to perform these procedures.

Mr. Kuo recommended that the inquirer be directed to the previous minutes provided by Mr. Pang for the Board’s informal opinion related to these procedures.

The Chair agreed with Mr. Kuo's recommendation but with the amendment that RNs are able to take orders from licensed providers which would include APRNs.

The Chair asked the Board whether there was a reason that the Board would modify or reverse its previous informal opinion.

Mr. Kuo and Ms. Boyer indicated that there was no reason to reverse the Board's previous informal opinion.

Ms. Shields Hanson commented that she believes that the Board's previous informal opinion should stand.

Mr. Aratani agreed stating no change should be made.

The Chair provided the following response, "Nurses may perform these procedures pursuant to the Board's previous opinion in 2016, which was reaffirmed in 2019; with the clarification that it includes receiving orders from providers, and not just physicians."

In response to the third question, "If it is written that a nurse practitioner can perform a procedure under physician supervision, what does this mean? Direct supervision or medical director that takes responsibility?", Mr. Kuo recommended that Ms. Kreitzman read HRS Chapter 457 in its entirety to understand what an APRN can do.

The Chair agreed, stating that the scope of practice for an APRN is describe in HRS Chapter 457. The Chair strongly encouraged APRNs and any working with APRNs to read HRS Chapter 457 and HAR Chapter 89 in its entirety.

In response to the fourth question, "What certificates do we need for the business and how do we register (aesthetics and invasive procedures in case there are different certificates needed for each)?", the Chair responded that this was outside of the purview of the Board.
