<u>Call to Order</u>: The Chair proceeded with roll call. All Board members confirmed they

were present and those joining via Zoom indicated that there was no one in the room with them. There being a quorum present, the meeting was

called to order at 10:07 a.m.

Dr. Nishimoto made the motion, seconded by Vice-Chair Wood, and unanimously carried to approve the ratifications of the issued licenses items i-xii; courtesy/relief permits i.-ix.; and, restored licenses i.-v., as listed above.

Examinations:

Chair Chock asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

EO Shahan provided the results of the following examinations:

<u>Correspondence:</u> Chair Chock asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

A. Letter from Dillon D Morton, DVM

Chair Chock read the following from Dr. Morton's letter:

"I am writing to respectfully request a reconsideration of the current passing score for the Hawaii Veterinary State Board Exam, which is currently set at 75%. Given the comprehensive and rigorous nature of the exam, I believe that adjusting the passing score to 70% or allowing the exam to be open book with additional time allotted would be beneficial for several reasons."

EO Shahan noted that chapter 16-101-16 **Required examination – passing score**, Hawaii Administrative Rules states:

Each applicant shall take and pass each part of an examination which shall be composed of the following three parts:

- (1) A national board examination (NBE);
- (2) A clinical competency test (CCT); and
- (3) A Hawaii state board examination which consists of those aspects of veterinary medicine common to the State of Hawaii.

A Candidate shall be assessed a fee for each part of the examination required by the candidate. A grade of not less than seventy-five points (75.00) for each part of the examination shall be a passing grade.

EO Shahan also noted that applicants must achieve at least a 75% passing score on both the national exam and state-specific exam. She is not aware if the passing score percentage ever changed.

Chair Chock asked EO Shahan if there would be a sizable difference in the amount of questions if decreasing from 75% to 70%.

EO Shahan indicated there are 40 questions on Hawaii's exam and 75% equates to 30 questions being answered correctly. If decreasing to 70%, the applicant would a difference of 2 correct questions at 28 questions being answered correctly.

Dr. Nishimoto stated that the applicants are provided the topics and names of references ahead of time, prior to taking the exam.

EO Shahan explained that the examination reference material (resources) listed on the candidate bulletin are the sources the subject matter experts used to create each question on the exam. The candidate bulletin breaks down the exam indicating the number of questions for each topic. Many of the resources provided on the candidate bulletin are website links..

Vice-Chair Wood asked if the reason for Dr. Morton's request is due to him having applied and how many times he failed the test.

EO Shahan answered yes, that Dr. Morton failed the test one time.

Chair Chock reference Dr. Morton's letter which indicates that "veterinarians frequently consult references and collaborate with colleagues to provide the best possible care for their patients" as a reason for his open book request. Though, she does state that the exam is meant to test the knowledge of basic competency.

The Board agreed.

Dr. Nishimoto stated if open book is to be allowed for the exam that the passing rate should be higher.

With discussion from the Board, EO Shahan stated the exam is designed to test minimum competency on topics unique to Hawaii, which may not be typically dealt with in another state. Examples of these would need to be considered to implement as questions in the exam should the Board allow open book.

She also expressed concern that should a veterinarian receive a patient that ingested a foreign matter specific to Hawaii, would their knowledge lead to immediate attention and proper care or would the individual require time to research how to appropriately care for the situation which could possibly endanger the patient.

Ms. Wada does not believe the passing score should be lowered as it seems majority of the applicants are passing Hawaii's exam.

Ms. Wada asked what the time period is to retake the exam and fee of the exam.

EO Shahan stated there is a 60-day wait period to retake the exam, and the fee is \$30.00.

Chair Chock stated regardless of the cost, with regard to Dr. Morton's passing score request, the number of questions on the exam has historically been the

same and not as high as other licensing areas, which includes minimum competency the Board wants to help reassure the community that individuals applying to Hawaii are competent.

Dr. Nishimoto asked EO Shahan if she has statistics on pass rates for applicants who have taken the exam a second, and possibly third time.

EO Shahan stated the Board has not maintained that type of statistics but could inquire with PSI for that information. She does not have any recollection of individuals failing when taking the exam a second time. She also asked how far back he would recommend she request statistics indicating that PSI began administering the current exam in April of this year.

Dr. Nishimoto states that is acceptable.

Chair Chock asked if PSI is able to capture the questions most often missed.

EO Shahan stated they are able to and that PSI would bring those to the attention of the Executive Officer with the opportunity to inquire with the subject matter experts to relook at the question.

Vice-Chair Wood asked if PSI could provide the top 3 most missed questions.

EO Shahan stated she will include that with her requests to PSI.

After discussion, EO Shahan stated she will respond to Dr. Morton indicating the Board discussed and taken his inquiry into consideration at this Board meeting, but the passing rate of 75% and a closed-book exam stands.

New Business:

Chair Chock asked if any member of the public would like to provide oral testimony on this agenda item. There were none.

A. NAVLE Retake Policy – Upcoming Changes

EO Shahan stated she provided the Board with the updated policy changes issued by the North American Veterinary Licensing Examination (NAVLE) which will take into effect during the 2025 testing cycle. The changes will not affect the Board, only test takers. NAVLE always had a retake limit of five (5) times. Their previous process was for the test taker to receive approval from the state licensing board if requesting a sixth time. NAVLE is changing who the test takers have to ask and now have to petition with the International Council for Veterinary Assessment.

B. AAVSB Board Basics & Beyond Report Marcella Chock

Chair Chock attended this meeting which is held in Kansas City annually, and reported the following:

• It was a great meeting for new Board members in a leadership role (i.e. Chairperson or Vice-Chairperson);

- This portion of the meeting provided instructions on how to conduct Board meetings;
- An attorney was available to speak on procedures that Boards are recommended to follow
- Representatives from other state Boards provided oversight on how their Boards function, and some states do not have a Board; and,
- Some states do not have public members
- C. AAVSB Convention Report Marcella Chock Aileen Wada

Ms. Wada stated she attached this year's convention as a committee member. She stated the following as being the most beneficial in attending this annual meeting:

- Learn about all the new ideas:
- Areas affecting the veterinary community;
- Discussed aging regarding concerns of veterinarians who are forgetting to write prescriptions, as an example, which is an issue across the nation;
- Discussed the value of the public member for their input into the industry;
- Spoke with the younger generation of some state Board who meet monthly; and,
- Hawaii has two (2) voting delegate and one (1) alternate;
- Discussed topics that are important to many, such as drug narcotic diversion, with their attorney providing direction on how illegal activity is to be addressed; and,
- Shortage of professionals in the industry, which may have led to the discussion of veterinary technicians

Ms. Wada also stated she noticed that veterinary technicians hold a position as a Board member in some states and recommended that Hawaii consider adding to the Board. The perspective of a veterinary technician could be beneficial.

Chair Chock added that some states added a veterinary technician position as a Board member as they are looking to add representation on their Boards in looking to expand their scope of practice. In doing so, the veterinary technicians will be able to provide input on their current scope of practice, what they can currently perform under current training requirements.

Dr. Nishimoto asked if lectures at the meetings are certified by the AAVSB's Registry of Approved Continuing Education (RACE) program.

Ms. Wada stated there are select lectures which provide continuing education credits (CEs).

Chair Chock added that the morning sessions offer CEs, while other sessions are delegate-based where policy changes were voted on.
