- 2) Mr. Branco shall refrain from any actions that may result in his arrest or conviction for any crimes against persons or property (including but not limited to theft, burglary, assault, etc.) or any other act that is directly related to the guard profession.
 - a. Mr. Branco shall report any such arrests or convictions to the Board within thirty (30) calendar days of the arrests or convictions, and
 - b. If Mr. Branco fails to timely notify the Board of such arrests or convictions, Mr. Branco's conditional registration shall be forwarded to the Regulated Industries Complaints Office for investigation for non-compliance with the terms of this conditional approval.
- 3) Mr. Branco shall submit proof of that he is compliant with the sex-offender registry requirements annually.
 - a. Mr. Branco shall submit proof of his compliance with the sex-offender registry requirements on or before January 31st annually.
 - b. If Mr. Branco fails to timely submit proof of his compliance with the sex-offender registry requirements, Mr. Branco's conditional registration shall be forwarded to the Regulated Industries Complaints Office for investigation for non-compliance with the terms of this conditional approval.
- 4) Mr. Branco shall disclose his prior conviction(s) and the conditions on his guard employee registration to any and all employers, in which he is hired to work in a guard capacity.
 - a. Mr. Branco shall provide a signed letter, from any and all employers who have employed Mr. Branco in a guard capacity, acknowledging that they are aware of his prior conviction(s) and the conditions on his guard employee registration.
 - b. Mr. Branco shall provide the signed letter(s) of his employer(s) acknowledgement within thirty (30) calendar days of receipt of an offer of employment.

.c. If Mr. Branco fails to timely submit the signed letter of acknowledgement from his employer(s) who have employed him in a guard capacity, Mr. Branco's conditional registration shall be forwarded to the Regulated Industries Complaints Office for investigation for non-compliance with the terms of this conditional approval.

5) Mr. Branco may make a written request to the Board asking that the conditions be removed, provided that the documentation indicates he has not been involved in any subsequent criminal incidents.

3. Evangeline Perry

After due consideration of the information received, it was moved by Chief Moszkowicz, seconded by Mr. Ontai, and unanimously carried to approve Evangeline Perry's application for licensure subject to certain conditions:

* * *

- (1) Failure to meet or maintain the conditions and requirements necessary to qualify for the granting of a license;

HAR section 16-97-7.2 provides that:

An individual may be a responsible principal for more than one agency, but not more than two, if:

- (1) There is a common ownership of at least fifty-one percent of each entity for which the individual acts as the responsible principal; or
- (2) An entity applying for an agency license is a subsidiary of or joint venture with another licensed firm; or
- (3) There is an immediate and direct family relationship between the responsible principal and the officers, directors, members, managers, or partners of the other licensed firm for which the individual acts as the responsible principal; or
- (4) There is an immediate and direct family relationship between the officers, directors, members, managers, and partners of all detective or guard entities for which the

individual acts as the responsible principal;
and

- (5) The board is satisfied that it is in the public's interest and that the individual is competent, able, and qualified to be a responsible principal for more than one agency.

G. Guard Employee Ratification

It was moved by Chief Moszkowicz, seconded Chief Logan, and unanimously carried to ratify the approval of the Guard Employees assigned registration numbers: GDE-36491 to GDE-37170 (see attached list).

Executive Officer Report:

A. 2025 Board Meeting Schedule

EO Fukunaga reminded Board members to mark their calendars with next year's Board scheduled meetings.

B. Nineteenth Proclamation Relating to Wildfires

EO Fukunaga reported that on December 6, 2024, Governor Green issued the Nineteenth Emergency Proclamation Relating to Wildfires. The proclamation suspended Hawaii Revised Statutes ("HRS") section 463-10.5 to the extent necessary to allow out-of-state licensed guards with a current and active license, or those previously licensed pursuant to Chapter 463, HRS, but who are no longer current and active, to engage in the business of guarding statewide without a Hawaii license; provided that they have never had their license revoked or suspended, have not been convicted of a felony within the last five years, and are hired by a Hawaii licensed guard agency who license is current, active, and in good standing.

EO Fukunaga stated that this proclamation is due to expire on February 4, 2025, unless terminated or superseded by a separate proclamation.

EO Fukunaga noted that the proclamation only exempts licensure under HRS section 463-10.5 under certain circumstances. All other provisions under HRS Chapter 463 and Hawaii Administrative Rules ("HAR") Chapter 97 are in effect.

EO Fukunaga noted that guards using the proclamation to work in the State, must be hired by a Hawaii licensed guard agency, have never had their license revoked or suspended, and have not been convicted of a felony within the last five years. EO Fukunaga added

that licensed Guard Agencies are still responsible for ensuring that they conduct pre-employment and post-hire employment criminal history record checks of county, state, and federal agencies of any individuals hired under the proclamation, pursuant to HAR section 16-97-7(b)(5). Guard Agencies utilizing the proclamation will be held responsible for any non-compliance with the terms of the proclamation.

C. 2024 Guard Employee Renewal Stats

EO Fukunaga reported on the following renewal statistics:

2024 GDE Renewal:

Out of 11,786 GDEs eligible to renew, 9,429 GDEs renewed on-time

2021 GDE Renewal:

Out of the 17,000+ GDEs eligible to renew, 9,640 GDEs renewed on-time

2018 GDE Renewal:

Out of 14,321 GDEs eligible to renew, 9,004 GDEs renewed on-time

D. 2024 Guard Employee Renewal Audit Announcements

EO Fukunaga reported that total of 358 guard employees were selected for audit to check for compliance with the 4-Hour Continuing Education requirement. Licensees were selected by license number. Audited licensees must submit documentation of their compliance, within 60 days of the date on the letter.

EO Fukunaga noted that the CE course must have been completed between July 1, 2021 and June 30, 2024. If the licensee fails to provide proof of their compliance with the 4-Hour CE requirement, their license will be referred to the Regulated Industries Complaints Office ("RICO").

EO Fukunaga stated that information regarding the 2024 GDE Audit as well as a listing of GDE's selected for the audit will be posted to the Board's website.

New Business:

A. Election of Chairperson and Vice-Chairperson

Chief Moszkowicz nominated Mr. Collins for the position of Chairperson. It was moved by Mr. Dolak, seconded by Chief Logan and unanimously carried to elect Mr. Collins as Chairperson.

Mr. Dolak nominated Chief Moszkowicz for the position of Vice-Chairperson. It was moved by Chief Logan, seconded by Mr. Ontai and unanimously carried to elect Chief Moszkowicz as Vice-Chairperson.

B. Legislative Liaison Delegate

EO Fukunaga stated that during the legislative session, a bill or bills are introduced that may require nuanced knowledge of the profession to provide testimony. Oftentimes, the bills are introduced or heard between Board meetings, making it difficult for the executive officer to provide testimony that is responsive to amendments to bills. EO Fukunaga proposed that a Board member be nominated as a legislative liaison to assist with drafting testimony, testifying, researching, etc. on legislative matters proposed during session. In addition, the legislative liaison will

assist the executive officer in clarifying Board positions in-between Board meetings, as hearings on bill and other updates typically occur prior to or after a Board meeting.

It was moved by Chief Moszkowicz, seconded by Mr. Ontai and unanimously carried to nominate Mr. Dolak as the legislative liaison for the 2025 legislative session.

C. Delegation to Board Member

EO Fukunaga stated that historically, the Board has delegated one or two members to review and approve applications on behalf of the Board in between Board meetings. These delegated Board members are allowed to approve applications that meet a specific set of criteria that has been approved by the Board. The delegation to Board members is also a common practice amongst the other Boards and assists with the expedient processing of applications that do not require Board review and discussion.

EO Fukunaga clarified that the delegated Board members would only have the authority to approve applications; only the Board has the authority to deny or condition a license. If a delegated Board member feels uncomfortable with approving an application, they will always have the option to forward that application to the Board for review.

EO Fukunaga added that a list of suggested delegations was provided in the meeting packet. They are as follows:

- Applicant has complied (nothing outstanding, e.g. probation, fine, etc.) with court sanctions/fines, etc.;
- Applicant has provided sufficient evidence of rehabilitation (i.e. letters of recommendation from prior/current employers, supportive letters from members of the community (non-relatives), proof of completion of a substance abuse or anger management program; etc.)
- Convictions not within 10 years of date application received.
