Lobbyists Training:

[ACT 20](#) establishes a new mandatory training requirement for all lobbyists who are required to register with the Commission under chapter 97, Hawai'i Revised Statutes. Lobbyists must complete a lobbyist training course prior to filing a lobbyist registration and repeat the course every **two years**.
