<u>Call to Order</u>: There being a quorum present, Chairperson Nishek called the

meeting to order at 9:05 a.m.

Agenda: The agenda was posted on the State electronic calendar as required

by Hawaii Revised Statutes ("HRS") section 92-7(b).

Minutes: It was moved by Mr. Alejado, seconded by Mr. Polischeck, and

unanimously carried to approve the Applications Committee Meeting Minutes of March 3, 2025 and the Board meeting minutes of February

21, 2025.

Hawaii Public Housing Authority
Preventive Maintenance Services IWS Systems, IFB-CMB-05-2025

Requests a determination whether bidders on the Preventive Maintenance Services IWS Systems, IFB-CMB-05-2025 project ("Project") are required to hold a C-37e Treatment and pumping facilities contractor license to perform preventive maintenance services to individual wastewater systems at various public housing properties on Kauai and Hawaii Island. The scope of work includes septic tank inspections; repair to the concrete, plastic and fiberglass septic tanks; O-box inspections; 1000-, 1500-, 2000-, 2500-, 3000-septic tank pumping; port inspections; pit pumps and inspections; IWS variance renewal and UIC permit renewal; and annual status reports.

Mr. Alejado stated that a C-9 Cesspool, C-37 Plumbing, or C-43 Sewer, sewage disposal, drain, and pipe laying license would be required to replace septic tanks. Mr. Polischeck stated that a contractor's license is not required to perform the preventive maintenance services for this project.

Recommendation: A contractor's license is not required to perform the preventive maintenance services to individual wastewater systems on the Project as described above. However, any work requiring a contractor's license must be performed by an appropriately licensed contractor.

Naz Senaldi

Requests a determination on whether a contractor's license is required to maintain, service, and repair commercial kitchen packaged equipment such as ice makers, walk-in coolers and freezers, undercounter refrigerators, and reach-in refrigerators. Maintenance and repair services may include cleaning and sanitizing internal components, cleaning coils and drains, and replacing various parts such as water/temperature sensing sensors, expansion valves, compressors, and other internal components of packaged units.

Mr. Alejado stated that changing compressors and valves requires a

C-40 contractor's license. In general, cleaning does not require a contractor's license. However, it is unclear what is included in "other internal components of packaged units".

Recommendation: Defer this matter pending the receipt of additional information on the work that is being performed; in particular, a more detailed description of the "other internal components of packaged units" that will be replaced.

Mira Image Construction LLC State Capitol Building, Capitol Pools Improvement (Phase 3), DAGS Job No: 12-10-1046

Requests a determination whether a C-1 Acoustical and insulation and/or a C-43 Sewer, sewage disposal, drain, and pipe laying contractor may install a drainage mat, 4" XPS foam insulation, and 1/8" protection board on top of an already completed roofing system for the State Capitol Building, Capitol Pools Improvement (Phase 3), DAGS Job No: 12-10-1046 project.

Michael Gangloff, Mira Image Construction LLC stated that he is seeking clarification on this project where the foam insulation board is the main scope of that work. There is a drainage board below the foam insulation board and a protection board above it. Both of these layers are for the sole purpose to protect the foam. Mr. Gangloff stated that the letter from Henry manufacturing, which he provided, states that this is not a watertight system. The description of the C-42 Roofing classification states that roofing is a watertight system. He is seeking clarification that a C-1 Acoustical contractor may install the insulation system.

Mr. Gangloff stated that there is nothing that affixes the protection board, the foam insulation board, or the drain board; it sits on the ground and lay flat on top of each other. The foam board is used to deflect water to the drain. The foam slopes to push the water toward the drain board and does not cause any damage to the foam. Mr. Alejado asked if the foam forms a customized slope. Mr. Gangloff stated yes.

Mr. Lau stated that the letter from Henry states that the Mira drain enhances the performance of the watertight layer by directing water to a drain. He asked what is the watertight layer? Mr. Gangloff stated that the whole roof is watertight and this system goes on top of the roof. Mr. Alejado asked how the foam boards are installed. Mr. Gangloff stated that the boards are installed by hand; there is no adhesives, tapes or fittings. The boards stay in place by the weight of the 6,000 tiles of glass per the design. The glass tiles are a raised floor. Mr. Gangloff asked if the C-25 Institutional and commercial equipment classification would be appropriate because it includes

raised floor systems. Although he included the C-43 Sewer, sewage disposal, drain, and pipe laying in his inquiry, he does not think that is the appropriate license for this system. Mr. Gangloff added that the specifications do not include roofing. The specifications for the protection board, foam insulation, and drain board are for roofing and deck insulation.

Mr. Alejado asked if the drains are at the height of the subfloor. Mr. Gangloff stated that the drains are installed at the same height of the existing roof. Mr. Lau asked what is the primary purpose of the extruded polystyrene foam? Mr. Gangloff stated to deflect water to the drains, not to prevent it from going underneath. The drain board airs out and drains out anything else. A waterproofing system on a roof would normally be covered with crushed rock to prevent UV damage. He further added that the drainage system is listed under the roof and deck insulation specifications. There is no ASTM specifications that pertain to watertight surfaces.

Executive Session:

At 9:23 a.m., it was moved by Mr. Lau, seconded by Mr. Torigoe, and unanimously carried to enter into executive session to consult with Jordan Ching, Deputy Attorney General, on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities pursuant to HRS section 92-5(a)(4).

At 9:38 a.m., it was moved by Mr. Polischeck, seconded by Mr. Alejado and unanimously carried to move out of executive session and to reconvene to the Board's regular order of business.

Chairperson Nishek informed Mr. Gangloff that the Board is deferring this matter because additional information is needed to make a determination on this inquiry. In particular, the Board requests the plan detail and specifications. Mr. Gangloff stated that what he has provided is the only detail in the bid document; there is no additional information that he can provide. The Board asked him to provide the specifications. Mr. Gangloff asked if the Board would consider his inquiry if he were able to bring the additional information before the meeting ends. The Board stated it would look at the information if he is able to return before the meeting ends.

Contractor Consumer Education Fund:

Media on Hiring Licensed Contractors

Ashton Stallings and Kayla Seztler were present to discuss the Hire A Licensed Contractor campaign.

The Board viewed the Maui centric PSA with the girl scout cookies, surfing lessons, and contracting services. Ms. Stallings stated that the vendor was selected because they have connections on Maui and had an understanding of what happened on Maui. This PSA features

local talent and is catered to a Maui audience because the residents should recognize the actors.

Mr. Polischeck stated that the PSAs are missing what could happen if you hire an unlicensed contractor. For example, in the IBEW commercial, it shows that the worker could be shocked. Ms. Stallings stated that there are different versions of the PSA; the Maui centric PSA is a lighthearted version. She stated that she was concerned whether it was the wrong tone when she first saw it. The vendors chose the lighthearted tone because the residents went through so much hardship and pain, the message is getting across without bringing up their hurt and pain. There are other versions that focus on accidents can happen or it's important to hire licensed contractors because they are professionals.

Mr. Polischeck stated that homeowners should be aware of what could happen if they hire an unlicensed contractor and a worker gets hurt; it could lead to lawsuits. He suggested that they refer to the old PSA. Ms. Stallings stated that they tried to obtain the rights to the original "Hire a Licensed Contractor" PSA but they we not able to get the original creator to sign away his rights. Mr. Polischeck stated that they don't need to remake the old version but is asking that they use the same concepts from that PSA. Mr. Lau asked about the other PSAs. Ms. Stalling stated that there are three PSAs focused on licensed contractors and the fourth is on business check. There is also a 45 second PSA that is Archie Kalepa's personal story. Ms. Stallings stated that all the PSAs are part of the campaign.

The Board members previously reviewed a storyboard for a PSA (with the bookshelf). The Communications team asked members to provide comments which were shared with the vendor who created a new PSA. A draft of the PSA was presented to the Board. The 30 second version has been cut into a 15 second version and a 5 second version. For example, when a person is online and goes to watch a video, the 5 second version may be shown prior to a video being shown. The 30 second version will be shown as a traditional broadcast. Executive Officer Ito asked if the Hire a Licensed Contractor website information would be shown at the end of the PSA. Ms. Setzler stated that the information will we shown and that the presentation was a rough draft of the PSA.

The Licensed Contractor PSA was presented to the Board (repairing ceiling fan). Ms. Stallings stated that the Business Check PSA has not been developed yet. She also stated that the Board has contributed \$50,000.00 to produce the PSAs and DCCA has also contributed funding to the production of the PSAs. DCCA is also putting money toward advertising. They are here today to request \$100,000.00 for advertising.

Ms. Stallings stated that the production costs for the PSA was more than \$50,000.00 and DCCA covered the costs over \$50,000.00.

DCCA has approved some money to go into advertising; \$50,000.00 is going toward showing at the Maui PSA at the Hawaii International Film Festival.

Mr. Lau stated that he did not know that the PSAs were focused on the Maui community rather than the general public for the entire State. Ms. Stallings stated that the girl scout PSA was for the Maui community; it is one PSA in the fleet. The advertising campaign is largely statewide. Mr. Lau stated that the Maui centric PSA had very little to do with consumer protection and the pitfalls of hiring an unlicensed contractor. Although the actors in the Maui PSA have Maui ties and will be recognized by Maui residents, it will not carry any message to the rest of the State. The Board's quandary is how to allocate the money for advertising. Ms. Stallings proposed the following budget allocation:

\$25,000 - Maui-Targeted Campaign

- 20,000 will be located to Spectrum (Cable and Streaming).
- Approximately \$4,000 (remaining post-tax) will be dedicated to digital advertising (e.g.,Facebook/Meta and YouTube), both of which offer location-based targeting capabilities.

\$25,000 – Statewide Broadcast Campaign (via Hawaii Association of Broadcasters ("HAB"))

 This includes airtime on major network broadcast stations such as ABC, NBC, CBS, and FOX. Local affiliates include KHON2 and KITV.

\$50,000 – Statewide Cable/Streaming and Digital Campaign

- \$40,000 will be directed to Spectrum (Cable and Streaming).
- Around \$8,000 (remaining post-tax) will be used for digital advertising through geotargeted platforms like Facebook/Meta and YouTube

Ms. Stallings stated that the overall goal is to get as many people as possible to see the PSAs. The goal of the PSAs is to bring awareness that unlicensed contracting is a problem; it's dangerous and there are consequences for hiring an unlicensed contractor. The PSA should attract the consumer attention to go to the website where there is more information. The advertorial that is in the works will provide more information on the dangers of unlicensed contracting.

Ms. Stallings stated that the HAB is able to make the Public Education Awareness ("PEP") sponsorship available to state agencies. The HAB guarantees the sponsor a 3 to 1 rate of return on their investment. DCCA has used HAB in the past and has received a higher return. For example, DCCA bought \$15,000.00 airtime from February through April 2024 and received \$91,845.00 total TV airtime. The \$50,00.00 statewide campaign includes broadcasting during sports programming.

Mr. Lau asked whether the Maui targeted campaign will only be seen on Maui. Ms. Stallings stated that Spectrum was chosen because of their ability to geotarget more than the other broadcasters. The girl scout PSA is geotargeted for Maui. Mr. O'Donnell asked if Spectrum would air the PSA for Maui statewide. Ms. Stallings responded yes.

Ms. Stallings stated that they are willing to attend Board meetings to give monthly updates. Social media statistics are the easiest to track data. In social media there are impressions, which are the number of times it is shown; reach is the number of people that see the ad; engagement is when a person shares clicks on the link, shares the link, or leaves a comment on the ad. They are also able to track the number of visits to the "licensedcontractor.hawaii.gov" website. In 2020 DCCA did a campaign and saw a 50% uptick on the number of website visits during that campaign.

The Board discussed allocating \$25,000.00 from the Contractors Education Fund to the Maui targeted campaign and having more discussion as a Board on the content of the draft PSA that was presented today. Mr. Polischeck would like to see information regarding the importance of how a homeowner will be affected if an unlicensed contractor, who does not have insurance, gets injured on their property. Although the point of the PSAs is to lead the consumer to the "licensedcontractor.hawaii.gov" website for more information, he does not see that the PSA is accomplishing that. Ms. Stallings stated that in the ceiling fan PSA, consumers can see the danger that the fan may fall and hit the child; the bathroom PSA shows the hazard of hiring a licensed contractor. The thought process behind the Maui PSA is that this is what the consumers will be seeing; people coming to their home and capitalizing on the vulnerability of these consumers. This PSA is trying to raise awareness if people come to your door, they should do a reference check on them before hiring them. Ms. Stallings stated that the reason they have the fleet of PSAs is to get the message out that unlicensed contracting is a problem and that they can visit "licensedcontractor.hawaii.gov" for more information. She added that the advertorial will provide more detailed information. Ms. Setztler stated that the Hawaii News Now advertorial will be 4 to 5 minutes. She stated that it will be in an interview style format, asked the Board to look at the talking points that was distributed in their Board packets, and stated that they can write their own questions. If the Board wants to add a talking point on the dangers of hiring an unlicensed contractor, they can add information about lawsuits and how the homeowner could be liable for the injuries that occurred on their property. Once the advertorial is produced, DCCA will own the rights to it and will be able to distribute it on social media. The Board asked if the advertorial has already been funded. Executive Officer Ito stated that the Board approved \$10,000.00 for the advertorial. The Board also apologized and explained that they are being prudent in their decision making because the funding is coming from the

Contractor Education Fund and they have never approved a distribution of funds that is this large.

It was moved by Mr. Lau, seconded by Mr. Polischeck, and unanimously carried to approve \$25,000.00 from the Contractors Education Fund for the Maui targeted campaign that was presented today and to have further discussion on the advertising funding for the Statewide Broadcast and Cable/Streaming and Digital campaigns.

Ms. Stallings asked if they could provide information that would give the Board a better understanding of how the PSAs will be broadcast.

Ms. Setzler stated that Representative Elle Cochran from Lahaina has confirmed that her office will pick the signs up and put them up in Lahaina probably in early June. The Board discussed adding more messaging to the PSA. Ms. Stallings stated that she will not be able to determine the cost until the Board lets her know what the changes they are requesting. Executive Officer Ito asked the Board if they would consider adding the additional messaging to the "licensedcontractor.hawaii.gov" website because the PSA should direct consumers to that website. The Board preferred to discuss the matter further. Ms. Stallings asked if there is any specific feedback she can provide to the vendor. Chairperson Nishek stated that while the bathroom PSA is over the top, it got the point across. Mr. Lau stated that the bathroom PSA was a little more applicable, however, it needs to convey the seriousness of the consequences of hiring an unlicensed contractor. For example, if a worker falls off the roof, they may get sued. The Board wishes to continue discussion on whether they want to amend the current PSA or create a new PSA at its next meeting. They want to be included in the discussion of what goes into the PSA. The Board is willing to spend more to get a better product. Ms. Stallings will get a ballpark cost for an additional PSA. The Board wants to get the new or revised PSA before they discuss the statewide advertising campaign. Ms. Stallings estimated that the cost to produce a new PSA is approximately \$30,000.00. That would take several months because they need to go through the procurement process in addition to the production time. The Board stated that they will have their notes ready for discussion at its next meeting. The Board asked if the current PSA were revised, could it be completed in a shorter amount of time. Ms. Stallings stated that it depends on the changes that they want, and she cannot get an estimate until she gets that information from the Board. The Board asked how the first \$50,000.00 was used. Ms. Stallings stated that part of it went to the girl scout PSA, the 45 second Lahaina feature, and the bathroom PSA; DCCA contributed additional funds to get the PSAs produced. The contract amount was approximately \$75,000.00. She guessed that a modification to the story board may be approximately \$8,000.00. Ms. Stalling assured the Board that she negotiates with the vendors for lower costs.

Chapter 91, HRS, Adjudicatory Matters:

Chairperson Nishek called for a recess from the Board's meeting at 10:38 a.m. to discuss and deliberate on the following adjudicatory matters pursuant to HRS chapter 91.

1. <u>Settlement Agreements</u>

In the Matter of the Contractor's License of Alex G Ramos, doing business as Triple A Electrical Service; CLB 2022-481-L

RICO alleges that Alex G. Ramos, doing business as Triple A Electrical Service ("Respondent"), aided and abetted an unlicensed contractor by pulling permits for the unlicensed contractor on many projects.

If proven at an administrative hearing, the foregoing allegations would constitute violation of Hawaii Revised Statutes ("HRS") 444-9.3 (aiding and abetting).

Respondent agrees to pay an administrative fine in the amount of ten thousand and no/100 U.S. dollars (\$10,000.00).

After discussion, it was moved by Mr. Lau, seconded by Mr. Polischeck, and unanimously carried to approve the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Board's Final Order in the above case.

2. Petition for Declaratory Relief

In the Matter of the Petition of James S. Markiewicz, Trustee, Joanne C. Markiewicz, Trustee for Declaratory Relief

It was moved by Mr. Lau, seconded by Mr. Alejado, and unanimously carried to deny the Petition pursuant to Hawaii Administrative Rules sections 16-201-50(1)(A), 16-201-50(1)(B), and 16-201-50(1)(F).

Reconvene to Chapter 92 Meeting:

Following the Board's review, deliberation and decisions in these matters, pursuant to HRS chapter 91, Chairperson Nishek announced that the Board was reconvening to its open meeting at 11:30 a.m.

Executive Session:

At 11:31 a.m., it was moved by Mr. Alejado, seconded by Mr. Torigoe, and unanimously carried to enter into executive session pursuant to HRS section 92-5(a)(1), to consider and evaluate personal information relating to individuals applying for professional or vocational licenses

cited in HRS section 26-9, and to consult with Jordan Ching, Deputy Attorney General, on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities pursuant to HRS section 92-5(a)(4).

At 12:50 p.m., it was moved by Mr. Polischeck, seconded by Mr. Alejado, and unanimously carried to move out of executive session and to reconvene to the Board's regular order of business.

After discussion, it was moved by Mr. Polischeck, seconded by Mr. Alejado, and unanimously carried to defer Kaidio LLC and Jonathan D Diodato's RME applications for licensure in the "B" General building classification pending the submittal of a revised project list verifying forty-eight months of his on-site supervision of his own employees constructing buildings from the "ground-up" and from start to finish. His revised project list should include a detailed description of the work his crew self-performed under his direct, on-site supervision (e.g., square footage, number of bedrooms); only include projects that are specific to the "B" classification (e.g., remove elevator, gutter, roofing work); and the "Amount of Supervisory Experience" should only include the time spent on site supervising his crew and should be commensurate with the number of workers, "Detailed Description of the Work You Supervised", and the "Contract Amount". Mr. Diodato may document projects from more than ten years ago where he was directing the means and methods of projects in the broad scope of the "B" General building classification.

> d. Alpha-Omega Plumbing Inc Neil Edwards RME C-37 Plumbing

After discussion, it was moved by Mr. Polischeck, seconded by Mr. Alejado, and unanimously carried to defer Alpha-Omega Plumbing Inc. and Neil Edwards' RME applications for licensure in the C-37 Plumbing classification pending the submittal of a revised project list verifying forty-eight months of his on-site supervision and direction of his employees performing work in the broad scope of the C-37 classification specifying the work performed in house and the work or trades subcontracted to other licensed contractors; he must include underground and new complete projects (not only repair projects); and a detailed description of each project and the C-37 work his crew performed under his direct supervision. Mr. Edwards may document projects from more than ten years ago where he was directing the means and methods of projects in the broad scope of the C-37 Plumbing classification.

Mr. Patron was not present. After discussion, it was moved by Mr. Polischeck, seconded by Mr. Alejado, and unanimously carried to deny Utilities One Inc. and Alexandrin Patron RME's applications for licensure in the "A" General engineering classification in accordance with Hawaii Administrative Rules section 16-77-11(a), and Hawaii Revised Statutes sections 444-12(a)and 436B-10(a)(9).

Mr. Gangloff distributed copies of the specifications for the drainage mat, XPS foam insulation and protection board. Chairperson Nishek asked if the plans and specifications for the raised floor includes the drainage system. Mr. Gangloff stated no, the drawings he provided is the only drawing of the drainage system which is on sheet 106 of the plans. The Board noted that section 07220 – Roof and Deck Insulation of the specifications for the project stated, "Section includes: Extruded polystyrene rigid board insulation, drainage mat and protection board for horizontal insulation above waterproofing

membrane." Mr. Lau stated that the specifications contain code requirements for insulation of occupied space and the installation of the drainage mat, XPS foam insulation and protection board is under the insulation specifications. The drainage mat lifts the XPS foam off of the roof and the protection board protects the foam; the three components together act as an insulation system.

Recommendation: Based solely on the information provided, a C-1 Acoustical and insulation contractor may install the insulation system consisting of a drainage mat, 4" XPS foam insulation, and 1/8" protection board on the Project.
