	A. HB 629 Relating to Therapy Services Expands the scopes of practice for occupational therapists, physical therapists, and speech pathologists employed by or contracted with the Department of Education to diagnose students with a medical condition in an educational setting and treat the students. Effective 7/1/3000. (HD1)		
	• EO Araki reported HB 629 has been deferred at its last hearing.		

#### B. HB 1070 Relating to Therapy Services

Expands the scopes of practice for occupational therapists, physical therapists, and speech pathologists to allow those professionals working for or contracted by the Department of Education to diagnose medical conditions that can be treated with their respective services.

• EO Araki reported HB 1070 has been referred to House Committee on Health, House Committee on Education and House Committee on Consumer Protection and Commerce but no hearing has been scheduled.

### C. SB 1389 Relating to Therapy Services

Expands the scopes of practice for occupational therapists, physical therapists, and speech pathologists to allow those professionals working for or contracted by the Department of Education to diagnose medical conditions that can be treated with their respective services.

• EO Araki reported SB 1389 was last heard by Senate Committee on Education and recommended to be passed with amendments, but the recommendation was not adopted.

D. HB 1054 Relating to Administrative Licensure Actions Against Sex Offenders Authorizes the Department of Commerce and Consumer Affairs and certain licensing boards to automatically revoke and refuse to renew, restore, or reinstate the professional licenses, registrations, or certifications of registered sex offenders. Effective 7/1/3000. (HD1)

• EO Araki reported HB 1054 was last heard by House Committee on Consumer Protection and Commerce and recommended to be passed with amendments. The measure has been referred to House Committee on Judiciary and Hawaiian Affairs. No hearing has been scheduled by the House Committee on Judiciary and Hawaiian Affairs.

E. SB 1373 Relating to Administrative Licensure Actions Against Sex Offenders Authorizes the Department of Commerce and Consumer Affairs and certain licensing boards to automatically revoke and refuse to renew, restore, or reinstate the professional licenses of registered sex offenders. Effective 7/1/2050. (SD2)

• EO Araki reported SB 1373 has crossed over from the Senate and has been referred to House Committee on Consumer Protection and Commerce and House Committee on Judiciary and Hawaiian Affairs. The bill is scheduled to be

heard by the House Committee on Consumer Protection and Commerce on March 12, 2025.
