<u>Agenda</u> :	The agenda for this meeting was posted on the State electronic calendar as required by Hawaii Revised Statutes ("HRS") section 92-7(b).
	A brief video was played to explain procedures for this virtual meeting and how members of the public can participate and interact with the Board during the meeting.
<u>Call to Order</u> :	Chairperson Chock proceeded with roll call. All Board members confirmed they were present. Those joining by videoconference confirmed there was no one with them. There being a quorum present, the meeting was called to order at 10:06 a.m.
Approval of the March 19, 2025 Minutes:	Chairperson Chock asked if any members of the public would like to provide oral testimony on this agenda item. There were none.

Vice-Chair Wood stated the following amendment to the open session minutes, as follows:

On page 5, 4<sup>th</sup> paragraph, should read:

Vice-Chair Wood stated that her concern was where the animal control [offers] officers were getting the drugs and who was signing for the drugs. She further explained that whoever is prescribing the drug would need to oversee the administration.

Deleted language is bracketed and struck through. New language is bolded and underlined.

Dr. Thomson-Kerr stated the additional amendment, as follows:

On page 6, 3<sup>rd</sup> paragraph,

Dr. Thomson-Kerr noted that injectable euthanasia <del>could be</del> [gabapentin and] does not necessarily have to be a controlled substance. It could be potassium **chloride** or many other things.

On page 6, 9<sup>th</sup> paragraph:

Dr. [Thomas] **Thomson**-Kerr stated that if the method does not involve a controlled substance, veterinary supervision is not required. A suffering animal can be shot without veterinary supervision. She further stated that these questions have a lot of intricacies in terms of how each can be answered.

On page 7, 5<sup>th</sup> paragraph,

Dr. [Thomas] Thomson-Kerr wondered if there is a licensed veterinarian working under animal control. She stated if a licensed veterinarian who holds a NEA or any DEA is working or contracted with the animal control office, the pharmaceuticals are being obtained properly.

Deleted language is bracketed and struck through. New language is bolded and underlined.

It was moved by Dr. Nishimoto, seconded by Dr. Asay, and unanimously carried to approve the Open session minutes of the March 19, 2025, meeting, with the aforementioned amendments.

Legislative Matters: Chairperson Chock asked if any member of the public would like to provide oral testimony on this agenda item. There were none.

A. SB493, SD1: Relating to Veterinarians

Establishes the Veterinarian Workforce Development Special Fund. Establishes the Veterinarian Workforce Development Fee to support recruitment and retention of veterinarians in the State. Establishes the Veterinarian Workforce Development Loan Repayment and Scholarship Program to support qualified veterinarians committed to or currently working in veterinary medicine in the State. Appropriates funds. Effective 7/1/2050.

EO Shahan stated that this bill passed its second reading and was referred to the Ways and Means Committee, though the bill did not move further, thusly died this past legislative session.

B. HB547 HD2: Relating to the Spaying and Neutering of Animals

Establishes the Spay and Neuter Special Fund to reduce pet overpopulation and the reproduction of free-roaming cats and various revenue and fundraising sources for the special fund. Effective 7/1/3000.

EO Shahan stated that this bill passed its second reading and was referred to the Finance Committee, though the bill did not move further, thusly died this past legislative session.

C. SB1023 HD1: Relating to the Spaying and Neutering of Animals

> Establishes the Spay and Neuter Special Fund to reduce pet overpopulation and the reproduction of free-roaming cats and various revenue and fundraising sources for the special fund. Effective 7/1/3000.

> EO Shahan stated that this bill passed its second reading and was referred to the Finance Committee, though the bill did not move further, thusly died this past legislative session.

She also advised that HB547 and SB1023 may be reintroduced next legislative session as effective dates for both bills was amended to July 1, 3000. There seems to be a lot of interest and support for these two bills within the veterinary community.

Chairperson Chock asked if any member of the public would like to provide oral testimony on this agenda item. There were none.

It was moved by Ms. Wada, seconded by Dr. Nishimoto, and unanimously carried to have both Chairperson Chock and Vice-Chair Wood continue serving in their current respective positions.

Chairperson Chock recognized and thanked Dr. Nishimoto, as this meeting was his last as a Board member and shared some of his major accomplishments within the Veterinary community.

The remaining Board members and staff also thanked Dr. Nishimoto for his service and contributions to this Board.
