Call to Order: The Chair took a roll call of the Board members.

In accordance with Act 220, SLH 2021, all Board members attending virtually confirmed that they were alone in their nonpublic location.

After taking roll, quorum was established, and the meeting was called to order at: 1:05 p.m.

Chair McMenemy asked if any members from the public would like to provide oral testimony on this agenda item. There were none.

Approval of November 20, 2024 Minutes:

Chair McMenemy noted that the minutes from the November 20, 2024 meeting and public hearing were not yet completed and requested to defer their approval until the next morning.

Chair McMenemy asked if any members from the public would like to provide oral testimony on this agenda item. There were none.

Applications

Upon a motion by Ms. Rebella, seconded by Vice Chair Foreman, and unanimously carried to enter the executive session meeting at 1:09 pm.

Upon a motion by Chair McMenemy, seconded by Ms. Rebella, and unanimously carried to return to the open session meeting at 1:38 pm.

After due consideration of the information received, it was moved by Vice Chair Foreman, seconded by Dr. Mizumoto, and unanimously carried to defer Minori Sambe's application pending further information.

Ratifications

Upon a motion by Vice Chair Foreman, seconded by Dr. Mizumoto, it was voted and unanimously carried to ratify the listed licenses for acupuncturists and intern permits.

2025 Legislation

Chair McMenemy asked if any member of the public wished to provide oral testimony. There were none.

A. H.B.1054/S.B.1373, Relating to Administrative Licensure Actions Against Sex Offenders

EO Green reported on legislative measures concerning administrative licensure actions against registered sex offenders. The bills authorize the Department of Commerce and Consumer Affairs (DCCA) and licensing boards to automatically revoke, and to refuse renewal, restoration, or reinstatement of professional licenses held by registered sex offenders. HB 1054 was likely inactive; however, SB 1373 had passed both the CPN and JDC committees with amendments. The amendments clarified that revocation would be based on placement on the sex offender registry rather than solely on conviction.

Ms. Tsuchiyama (public) inquired about the process and the Board's role in decision-making.

DAG Kim explained that the bill seeks to expedite the process by mandating automatic revocation, thereby reducing steps in the current investigative process, while preserving the right of appeal through DCCA. The bill's intent is to enhance public safety by addressing registered sex offenders promptly.

The Board unanimously expressed support for the measure, consistent with its past position on protecting the public interest and welfare.

B. H.B. 1333/S.B. 1565, Relating to Acupuncture

EO Green noted that the bill "never got a hearing so that one is dead." Discussion then turned to its companion measure, SB 1565, which had a "double referral." SB 1565 had passed the HHS Committee, but the CPN Committee had not yet scheduled a hearing, with a filing deadline approaching.

The Board reiterated its longstanding position of supporting measures that modernize statutory language to align with the current professional standards and scope of practice of licensed acupuncturists. Individual members expressed strong support for the intent of such legislation, emphasizing that the core objective is parity, not elevation of the profession. The Board underscored that parity is necessary for acupuncturists to be recognized as essential health care providers alongside professions such as chiropractors and physical therapists, which is critical for inclusion in insurance, Medicare, and Medicaid.

It was further noted that achieving this status would allow acupuncturists to be eligible for grant funding. As an example, when Governor Green offered grants to certain health care professions, acupuncturists were excluded due to statutory wording. Another benefit of such measures is creating incentives for future acupuncture students by enabling eligibility for loan relief programs similar to those available to physicians and other health care providers, helping to address workforce shortages.

Ms. Tsuchiyama (public) confirmed that the intent is indeed to achieve parity so that acupuncturists are "on the same playing field" should there be a call for essential health care workers.

The Board concluded that, should SB 1565 advance, it would provide testimony reflecting these points of support.

Dr. Low asked about the administrative bill and its effective date, noting student concerns regarding labor hubs and completion of board examinations. He inquired whether the rules package was finalized or still under review, and whether the Board needed additional support to advance the process. It was explained that the process involves multiple steps, including review by regulatory boards and the

Governor's office, and therefore takes time. Dr. Low also asked whether the Small Business Regulatory Review process had already been completed following a prior hearing. He suggested keeping the topic as a standing agenda item to ensure it remains a priority even when no new updates are available.

New Business

EO Green reported that DAG advised against the change, noting that such applications are rare for acupuncture practitioners. The Board agreed and determined to continue referring all such matters to the full Board for review.
