Virtual Meeting  
Instructions:

A short video regarding virtual meetings was played for attendees. The Chair provided information on internet and phone access for today's virtual meeting and announced that today's meeting was being recorded and that the recording will be posted on the Board's web page.

Call to Order:

The Chair took roll call of the Board members. Ms. Oliveira and Mr. Kuo noted that they were present in person.

In accordance with Act 220, SLH 2021, Ms. Riggs, Ms. Moore, Mr. Aratani, Ms. Shields-Hanson, and Mr. Dunbar virtually confirmed that they were alone in a nonpublic location.

After taking roll, quorum was established, and the meeting was called to order at 9:11 A.M.

Chair's Reports:

**Announcements**

The Chair announced that NCSBN has released a schedule for upcoming events about a year in advance, like the annual meeting and a scientific symposium. Chair added that some of these meetings hosted by NCSBN are virtual and can be registered online. Chair and EO Chin will discuss who will be attending the midyear meeting on the Board's behalf.

**National Council of State Board of Nursing's (NCSBN)  
Presidents' Call on October 7, 2025**

Chair reported that there were some concerns discussed amongst Presidents and Chairs of other State Boards of Nursing and that she will be monitoring the ongoing basis of these concerns on the Board's behalf. One of the concerns discussed was about the verification of the identity of nurses. Chair reported that another state board suggested to include photographs on nurse licensed pocket cards. Chair explained that NCSBN is willing to entertain this inclusion of photographs to licenses, if there are further conversations of this concern. Another concern was related to med spas and IV hydration plants. The other boards were seeking guidance from NCSBN on how to respond to these inquiries. Chair reported that there are various resources from other boards of

nursing, like a consolidation of position statements, that are available on NCSBN discipline knowledge network hive sites. Chair added that there are also guidelines posted about social media use for nurses, also available on the NCSBN discipline knowledge network hive sites. Chair emphasized that EO Chin is the contact for creating an NCSBN account. Chair reported the last item to note from the meeting was the NCSBN National Nursing Education Database. Chair emphasized that Hawaii is not represented in this data because the State does not participate in the NCSBN annual report of surveys of school of nursing. Chair added that for the participating states, there is a dashboard that shows information about various aspects of nurse education programs, including clinical hours, class pass rates, major changes of programs, student characteristics, etc. Chair continued to announce that the dashboard can be filters by rural vs urban tax classification status in schools, degree program, and program enrollment size.

Mr. Dunbar asked the Chair why Hawaii is not a participating state in the NCSBN National Nursing Education Database and if Hawaii is the only non-participative state. Chair replied that her understanding is that the board has not discussed participating in the survey prior to this meeting and that there are only 35 out of 50 states that have participated in the recent survey for the database.

Chair asked if there was any member of the public requesting to provide public testimony. There were none.

**Approval of the Open and Executive Session Minutes of the  
October 2, 2025 Meeting**

Upon a motion by Ms. Shields-Hanson, seconded by Mr. Kuo, it was voted on and unanimously carried to approve the open and executive session minutes of the October 2, 2025 meeting as is.

Executive Officer's  
Report:

**NCSBN Executive Officers' Call on October 27, 2025: Remote  
proctoring of the National Council Licensure Examination  
(NCLEX)**

EO Chin reported that this call addressed the remote proctoring of the NCLEX and reminded the Board and attendees that this was discussed as the previous Board meeting. EO Chin added that the questions from the previous Board meeting were answered during this call. One of the questions was how NCSBN would maintain the integrity of the examination when proctored. EO Chin disclosed that the exam has been rebranded and is following a quality-line rather than a timeline to proceed with the implementation. NCSBN is still

in the early stages of writing the policies and rules for the online exam and there is a highlight on prioritizing technology. EO Chin added that there was a mention of an app being developed to assess the room that the online examinee is sitting in, which would require a 360-degree view. NCSBN is also looking into technology that has high resolution, so any spyware or hidden bugs can be detected from the remote candidates. EO Chin stated that NCSBN has looked into other groups that have utilized online testing and have been successful in doing so, one of the groups being EMTs. Another consideration NCSBN has been investigating is ensuring test takers have reliable internet and the necessary technology. If candidates do not have the required equipment to take the exam remotely, they will need to find a testing center instead. NCSBN is considering all options to verify the identities of test takers, like fingerprints or visual IDs.

Chair asked if there was any member of the public requesting to provide public testimony. There were none.

### **Operation Nightingale**

EO Chin reported that Operation Nightingale, phase two ended on September 16, 2025. This is when the Office of the Inspector General ("OIG"), Department of Health and Human Services released an update on 12 schools that were further indicted in the investigation into fraudulent transcripts issued by Florida nursing programs. Most of the transcripts were issued between 2016 to 2021, but some were still provided before and after those years. EO Chin disclosed that the US Department of Health and Human Services are leading the Nightingale investigation. The authorities were alerted when state boards noticed there were consistently poor NCLEX passing results coming out of certain nursing programs. Those nursing programs lead back to schools in Florida. Since the beginning of this operation, there have been over 21 nursing programs indicted. EO Chin added that although, a lot of the schools have closed from 2023 to 2024, the fraudulent transcripts are still being used to apply to take the NCLEX or jobs. EO Chin emphasized that a nurse who had a fraudulent transcript worked in Missouri at a hospital, where her lack of training led to the death of a patient. EO Chin highlighted that this is a serious concern for the public. EO Chin added that since she became the Executive Officer for the Hawaii Board of Nursing, she has reviewed a number of applications with the fraudulent transcripts. Some of the schools were legitimate programs, but over time the owners found a lucrative business in the scheme of selling illegitimate transcripts. Techni-Pro Institute is an example of this

and one of the schools that were recently indicted in phase two. EO Chin disclosed that she has to review some transcripts case by case to ensure it is a legitimate transcript and is thorough in her review. EO Chin disclosed that through her reviews of the transcripts were in applications that were submitted prior to 2024, which means those applications were exempted from the abandonment clause, § HRS 436B-9. EO Chin continued to add the policy for those applicants was to show an effort in taking the NCLEX, whether it was in Hawaii or another state. Due to this exemption, applications were allowed to roll over repeatedly. EO Chin disclosed that the licensing branch has been flagging applications that fall under the exemption and were sent deferral letters. EO Chin sent the deferral letters to give the applicants an opportunity to sit through a board approved nursing program. EO Chin highlighted that to prevent the fraudulent transcripts in applications from being granted a license, the exemption of the grandfather clause is no longer being granted, especially since it was not written into law. EO Chin emphasized that the Hawaii Board of Nursing will be following the full interpretation of § HRS 436B-9, which means that all applications will expire a year from the first date of registration for the test. EO Chin included that if the application expires, the applicant will have to redo the entire process again, like providing fingerprints. EO Chin continued to add that this interpretation will affect the remedial courses, as well. EO Chin expressed that she learned that exempt applications submitted prior to March 2013 did not have to take a remedial course if they failed the NCLEX three times consecutively, whereas applicants after March 2013 had to take a remedial course and show proof of completion. EO Chin included that the grandfather exemption for the remedial course was not written into law either pursuant to § HRS 16-89-9(b), so the Hawaii Board of Nursing will not grant it any longer. EO Chin added that the Board will follow the strictest interpretation, which means that applicants who fail the NCLEX three times consecutively will be subject to taking a board-approved remedial course. EO Chin continued to disclose this interpretation is not all that different from other state boards that have similar requirements. EO Chin brought up that other state boards have been more aggressive with regards to Operation Nightingale and the Hawaii Board of Nursing will be following their leads. EO Chin explained that Delaware's Board of Nursing has annulled any license that had a transcript from a Nightingale school and the list is provided on their website. EO Chin added that other states boards, like California or North Dakota, have listed the indicted schools on their websites and includes additional information on how to detect fraudulent transcripts. Mr. Kuo asked EO Chin how many potential abandoned applications are there. EO

Chin replied that there is currently a list that she has and is waiting for a list from the exam branch. Chair asked EO Chin if there is protocol for an applicant who has failed the NCLEX three times and has a scheduled date to sit for the exam again. EO Chin disclosed that due to the difficulty in catching that potential case, currently the only applications that are being flagged are from November 1<sup>st</sup>. Chair and Ms. Sheri-Sheilds expressed their gratitude for this stricter interpretation. Ms. Moore asked that out of the estimated 7,300 fake diplomas out in circulation, how many have been caught. EO Chin stated that since it is hard to track, there is no current number available just yet. EO Chin reassured the Board that she has been in communication with other state boards concerning Nightingale and seeing what other safeguards they have used that Hawaii may adopt. Ms. Moore questioned if a nurse who gets flagged for a faulty transcript never has another opportunity to become a nurse in the state of Hawaii. EO Chin explained that that is not the case, and that the applicant receives a deferral letter providing them with the opportunity to satisfy the educational requirement for the Hawaii Board of Nursing. Mr. Dunbar asked EO Chin if the approximate 7,300 were made aware to correct their academic insufficiency or if the list of indicted schools were given to state boards to be aware of those fraudulent transcripts. EO Chin replied that the applications that made it passed the Executive Officer review and received their license are being handled by RICO in accordance with Hawaii's rules and statutes. EO Chin further stated that if these applicants reapply it is up to the board on what decision they would like to make since the disciplinary action is reported on the applicants Nursys and NPDB reports. Chair added that the OIG investigation is focused on the schools that issued the fraudulent transcripts, whereas the individuals who obtained the faulty transcripts and the investigative efforts fall on the nursing regulatory bodies. EO Chin further included that Operation Nightingale is still an ongoing investigation and that there are other suspected schools that have not been indicted yet. Mr. Kuo asked what the other boards are doing if a fraudulent transcript holder continues their nursing education to a completion of a BSN or APRN coursework, when their foundation is from a faulty transcript. EO Chin and Chair have not heard of this situation yet but will pose the question to other state boards and the next President's call with NCSBN. Chair pointed out that it may be a matter of what credits are invalid since the BSN program is supposed to do their due diligence in the transfer evaluation of the previous education. Chair added that a concern she has are applicants that have fraudulent transcripts receiving their license through the multi-state compact. Mr. Kuo added that other state boards may not investigate the fraudulent transcripts for applicants

who are approved for the multi-state licensure. Mr. Kuo asked EO Chin if the OIG is sending the Operation Nightingale information to nursing schools as well and EO Chin responded that she would look into who has received this information. EO Chin reported that during phase one of the operation, the schools that were indicted sent out a list of the individuals that received a faulty transcript, but those lists weren't always complete. EO Chin recalls seeing applicants with the faulty transcripts take the NCLEX 30 to 40 times. Mr. Kuo asked if the new interpretation is being put into place that day. EO Chin replied that she is working with the exam branch to flag those applicants as well, but all applicants will have to receive a notice of abandonment. Chair emphasized and confirmed with EO Chin that starting on November 1, 2025, all applications that have had no activity on it from the preceding year is going to be considered expired. EO Chin added that the exam branch receives the scores and are able to tell if any applicant has or has not taken a remedial course.

### **Annual Audit**

EO Chin reported that there is a current audit being conducted. This is a random sample of nurses with current and active licenses in the State of Hawaii. The random audit has drawn 18 LPNs, 32 APRNs with prescriptive authority, and 320 RNs, which is about 1% of the licensed industry. EO Chin clarified that the letters were dated for August 2025 but postmarked for October 14, 2025. EO Chin disclosed that any licensee that was audited who received their letter after October 14, 2025, still have the 60-day timeframe stated in the letter to submit their continuing education evidence. Chair asked if the lists would be posted to the website and EO Chin confirmed that it is already on there.

Chair asked if there was any member of the public requesting to provide public testimony. There were none.

### **Reports:**

#### **Hawai'i State Center for Nursing – Laura Reichhardt, Director**

Laura Reichhardt appreciated the open discussion of Operation Nightingale, and the licensure process communicated from EO Chin.

Laura Reichhardt reported:

- The Hawai'i State Center for Nursing has released their 2025 Nursing Workforce Supply Data Tables in October. There have been over 16,000 responses, are present,

and done by license. In December, the report will be released and broken down by county.

- The Hawai'i State Center for Nursing is seeking nominations for three awards: the Emerging Nurse Scientist Award, the Exemplary Nurse Scientist Award, and the Hawaii Impact Award, that will be released at the Hawaii Nursing Scientific Symposium. Registration is open for the conference right now as well.
- The Hawai'i State Center for Nursing will be hosting an EBP Conference. It's an introduction to John Hopkin's models and tools, which is the EBP framework the Hawai'i State Center for Nursing has endorsed on behalf of the state and engage in training and community organizations to help both schools and facilities use the evidence-based practice process to improve the quality of their nursing work. There is multi-county participation.
- The Hawai'i State Center for Nursing worked with the healthcare partners in the state and the Governor's Office to include the Hawaii nurse residency program and specialty transition to practice initiative in the Rural Health Transformation grant application that will be submitted to the federal government. The grant is part of the HR1 plan to change Medicare fund, which is for \$100 million and a potential \$100 million match for the state. The Hawai'i State Center for Nursing has been able to demonstrate, through their programs and past grant activities, there is an outsized representation in programs by neighbor island nurses, when there is grant support. These programs have significantly improved retention of new nurses and decrease vacancies in specialty areas.
- In October, at the American Academy of Nursing Health Policy Conference, Marife Aczon-Armstrong, Sondra Leiggi Brandon, and Donna-Marie Palakiko were inducted into the American Academy of Nursing. This is a prestigious academy that nurses must demonstrate their impact locally, national, and internationally. Born and raised in Hawaii, Diane Alfonso was further recognized for the Living Legend Award by the American Academy of Nursing for scaling a nursing model that was developed in Hawaii, globally. This model is called the Malama Community Health Program, which worked to support maternal health, mental health, and health equity.
- Laura Reichardt expressed her immense gratitude to the Board for the work they're doing to protect nurses and the quality of nursing in the state. Additionally, expressed



her thanks to the licensing division for their efforts in licensing nursing applicants.
