After discussion, it was moved by Vice Chairperson Keliinoi, seconded by Ms. Chee and unanimously carried to adopt the Hearings Officer's recommended decision as the Board's Final Order and affirm its denial of the Petitioner's application.

Executive Session:

At 9:12 a.m., it was moved by Vice Chairperson Keliinoi, seconded by Mr. Lum and unanimously carried to enter into executive session pursuant to HRS section 92-5(a)(1) to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in HRS section 26-9, and to consult with Jordan A.K. Ching, Deputy Attorney General, on questions and issues pertaining to the Board's powers, duties, privileges, immunities, and liabilities pursuant to HRS section 92-5(a)(4).

At 9:22 a.m., it was moved by Ms. Wakabayashi, seconded by Mr. Lum, and unanimously carried to move out of executive session and to reconvene to the Board's regular order of business.

Applications:

a. Physical Therapist Application

1. Eric R. Leon

It was moved by Vice Chairperson Keliinoi, seconded by Ms. Chee, and unanimously carried to approve Eric R. Leon's physical therapist application.

2. James T. Mills III

It was moved by Vice Chairperson Keliinoi, seconded by Ms. Chee, and unanimously carried to approve James T. Mills III's physical therapist application.

b. Ratification

It was moved by Chairperson Tamayo, seconded by Ms. Wakabayashi, and unanimously carried to ratify the Physical Therapist and Physical Therapist Assistant licenses on the attached ratification list.

2025 Legislative Session:

SB 1373 Relating to Administrative Licensure Actions Against Sex Offenders

EO Ito stated that SB 1373 was signed into law on July 2, 2025 (Act 273, SLH 2025). Section 23 of the bill amends chapter 461J, HRS, to authorize the Board to automatically revoke and refuse to renew, restore, or reinstate the license of a physical therapist or physical therapist assistant based upon a conviction requiring registration as a sex offender.

Chairperson Tamayo inquired if the Board would be required to meet within 30 days of the revocation or denial should the licensee timely file a request for a hearing within ten days of the notice of the license revocation or denial. EO Ito stated that a contested case hearing must be held within 30 days of the revocation or denial notification. DAG Ching clarified that the Office of Administrative Hearings would hold the contested case hearing within 30 days. After the

conclusion of the contested case hearing, the Board will review and vote on the Hearings Officer's Findings of Fact, Conclusion of Law and Recommended Order.

Ms. Wakabayashi asked if the application form would need to be updated. DAG Ching stated that this bill allows the Board to automatically take action when the conviction occurs after a license has been issued.

Scope of Practice Question:

We have been asked to do pre-work screening for several unions. These screenings are as like functional capacity evaluations. Which entails to but not limited to:

- Lifting weighted crates- per job requirements- to waist level, to shoulder level, overhead
- 2. Treadmill assessments- with vital assessment
- 3. Checking ROM, MMT
- 4. Grip strength assessment
- 5. Squatting, kneeling,

Our assumption is this is in our practice act as a Physical Therapists. These assessments are direct from the companies/unions themselves vs from MD.

The inquirer provided clarification that the treadmill test is for functional endurance with monitoring of vitals such as heart rate and assessing symptoms. With regard to squatting and kneeling, the assessment is pass or fail; they either can squat or kneel without pain and functional limitation or not.

Chairperson Tamayo stated that the additional information provided by the inquirer clarifies that the treadmill assessment is an endurance test and not a stress test. A stress test does not appear to be in the scope of physical therapy. Based on the information provided by the inquirer, the treadmill assessment is a test for endurance with monitoring of vital signs such as heart rate, and assessment of symptoms. She stated that the screenings listed above are permitted in accordance with the definition of "Practice of physical therapy", "physical therapy" or "physical therapy services" in HRS section 461J-1. With regard to the inquirer's statement that the request for the above assessments are not coming from a medical doctor, Chairperson Tamayo stated that physical therapists are permitted to perform assessments without a referral.

DAG Ching added that tests and measurements of: muscle strength, endurance; cardiac, pulmonary, and vascular functions are included in the definition of "Practice of physical therapy".

It was moved by Vice Chairperson Keliinoi, seconded by Ms. Wakabayashi and carried by majority vote (with Ms. Chee recusing herself) to affirm that the inquiry as stated above is within the practice of physical therapy or physical therapy services as defined in Hawaii Revised Statutes section 461J-1.
