Call to Order: There being a quorum present, Chairperson Nishek called the meeting to order at 9:10 a.m.

Agenda: The agenda was posted on the State electronic calendar as required by Hawaii Revised Statutes ("HRS") section 92-7(b).

Minutes: It was moved by Mr. Alejado, seconded by Mr. Polischeck, and unanimously carried to approve January 6, 2026, Applications Committee Minutes; the Open Session Board Meeting Minutes of October 24, 2025, and November 21, 2025; and the Executive Session Minutes of October 24, 2025, and November 21, 2025.

Committee Reports:

1. Scope of Activity Committee:
Paul Alejado and John Polischeck, Co-Chairpersons
 - a. EBJ Construction, Inc.

Sherman Laboratory Window Improvement
University of Hawaii at Manoa, Project No. UHM 1090-24-800
Mr. Alejado stated that EBJ is seeking clarification on whether a C-31D licensee may perform non-structural sealant repair, specifically:
 1. Does the C-31D classification permit a contractor to perform caulking and sealing tasks at existing windows when the work does not involve glazing replacement or manipulation?
 2. Can the Board clarify whether the classification of work should depend on the building system involved or the task being performed, when the task (caulking) is explicitly listed in the C-31D definition?
 3. If the Board's prior comments regarding glazing-system caulking apply exclusively to curtainwall and glazing assembly work, does the same interpretation apply to simple perimeter waterproofing repairs?

Eduardo Jugueta, EBJ Construction Inc., testified that the University of Hawaii - Manoa is requiring contractors to hold a C-22 Glazing classification to bid on the above project. Mr. Jugueta stated he believes that a company holding the C-31 Masonry or C-31d Tuckpointing and caulking classification is able to perform the work as listed in the bid documents. He stated the plans are not for a window system repair, no window repair or replacement) but that the concrete would be replaced with caulking the aluminum frame.

He stated that the job would require the aluminum gasket to be cut and replaced. The plans only address the caulking, and a C-31 subclass can perform caulking. He stated he wanted the procurement officer to review the contract requirements based on the Board's response as the job only requires removing the gasket and applying silicone caulk.

Dwayne Arellano, Glazer's Union, reminded the Board that its prior judgement (June 24, 2022) was that this type of work needed a C-22 Glazing classification. He stated that a glazer is responsible for caulking so that water and air doesn't get in through the caulking point of the window system. He further stated that individuals with the C-22 Glazing classification are knowledgeable and can adhere to the manufacturer's recommendations. He stated that glazing and caulking requires someone who is responsible for the whole system.

Jeffrey Matsasuga, International Trades Union of Plumbers and Allied Trades, emphasized the C-22 Glazing classification was needed for this specific project.

Morris Onishi, University of Hawaii - Manoa, requested the Board for clarification on the C-22 Glazing classification as the interpretation in their view is consistent with the C-22.

David Hall, University of Hawaii – Manoa, stated that in the specifications were written using the guidance provided at the Board's June 24, 2022 meeting, citing, "...caulking can be performed by many trades making it difficult to determine classification" and that "the caulking should be in the classification of whatever the work is related to..." in this instance C-22 Glazing classification.

Mr. Lau asked if the window system and associated concrete and metal interface work was incidental to the window system. Mr. Hall relied in the affirmative. Mr. Lau asked if the project involved altering the glazing. Mr. Hall responded Yes, by cutting the gaskets.

Mr. Lau asked if this would affect the warranty with this type of work. Mr. Onishi stated the windows are very old and the warranty no longer applies.

Mr. Arellano stated that the project did not call for the removal of the whole gasket. Mr. Polischeck stated that the Board understood. Mr. Lau reemphasized that the glazer should properly seal it, not just the caulking.

Based solely on the information and oral testimony provided, Mr. Alejandro recommended that the C-22 Glazing would be

required. Mr. Polischek agreed that it would be required and that it was based on previous determination from the Board.

b. Hawaii Public Housing Authority

1. If a C-27 Landscaping contractor license covers or can be used for installing work listed under C-37b Irrigation and lawn sprinkler systems contractor.

Mr. Alejado recommended an affirmative answer stating that the C-27 Landscaping contractor covers work in the C-37b Irrigation and lawn sprinkler systems classification.

2. If a C-12 Drywall contractor license covers or can be used for installing work listed under C-33b Taping contractor.

Mr. Alejado recommended an affirmative answer stating that the C-12 Drywall classification covers the work listed under the C-33b Taping classification.

c. Office of Climate Change, Sustainability and Resiliency

1. Is a C-27 Landscaping license required to remove invasive mangroves from City-managed portions of Ka`elepulu Stream?

Chair Nishek stated that based on the project specifications which place responsibility for traffic control and required permits onto a contractor, a C-27 contractor's license would be required for the project as described.

Based solely on the information provided, Mr. Alejado recommended the C-27 Landscaping contractor is required for the Ka`elepulu Stream Invasive Mangrove Removal Project.

d. NyLawn Rec and Roll LLC

1. What license classification, other than C-44 Sheet metal contractor, is needed to install a commercial shade: "A" General engineering, C-25 Institutional and commercial equipment, and/or C-44 Sheet metal?

Mr. Rory Otto of Nylawn Rec and Roll LLC, testified regarding the installation of a shade structure system. Mr. Otto described the work as digging footing holes, setting posts, and installing the tensioned fabric canopy. He stated that the awning license classification involves fabricating awnings for windows but questioned whether this project instead falls

under a C-25 Institutional and Commercial Equipment classification, as the structures are prefabricated and similar to playground-type installations. He noted that the system involves cable tension components and indicated that the C-25 classification appeared to be the appropriate license. Mr. Alejado stated that the work includes footings, nylon fabric, and rebar, and suggested that classifications other than C-25 may also apply, including an "A" General Engineering contractor.

Mr. Polischeck stated that an A General Engineering contractor could perform the work.

Mr. Lau stated that portions of the work could be subcontracted, including work under the C-31 classification.

Mr. Alejado asked the Committee whether the C-44 classification would also apply.

Mr. Lau responded that sheet metal work may be involved. Mr. Polischeck stated that a C-41 Reinforcing Steel classification would be required for the rebar portion. Mr. Polischeck added that a general ruling could not be made because the applicable classifications depend on the specific scope of work.

Mr. Otto stated that the footings would be approximately 7' x 7' x 3'.

Mr. Alejado recommended that both the A General Engineering and C-25 classifications are required to install the commercial shades. Mr. Polischeck added that the rebar and sheet metal portions may need to be subcontracted to properly licensed contractors.

Mr. Alejado made the motion, seconded by Mr. Polischeck, and unanimously carried, to approve the recommendations of the Scope Committee on items (a), (b), (c), and (d).
