CORE A 2013

The Commission's mandatory core course, part A, "Real Estate-Related Legislation" and "Brokerage Policies & Procedures Manuals", is available in a live classroom and online or other alternative modes of offering.

The Train-the-Trainer session was held on Monday, June 17, 2013, at the Honolulu Board of REALTORS®. Instructors must either have attended the Train-the-Trainer session or view the video of the session which is available on YouTube. Once the instructor has completed viewing the Train-the-Trainer session, a certification form must be completed and submitted to the Real Estate Branch. Please contact the Real Estate Branch for the certification form.

For those CE Providers who are able to create their own online or alternative media offering of Core A, 2013-2014, there is a certification form that should be completed and submitted to the Real Estate Branch. Please contact the Real Estate Branch for this form, also. (roster@dcca.hawaii.gov, or telephone 808-586-2643) Any alternative media offering of Core A, 2013-2014, must use the approved core course materials and be set up so that licensees are timed in completing the course, which is two and a ½ hours in length.

CE Providers may also contact Elena Pacheos, <u>elenap@proschools.com</u>, to set up the online version of Core A, 2013-2014. The CE Provider's instructor(s) must have already attended the Train-the-Trainer session.



CORE A ... SOME CONSTRUCTIVE FEEDBACK

Here is some constructive feed-back from a CE Provider/instructor regarding Core A:

1) Be prepared for animated discussion when it comes to property management and the deposits that will be allowed for pet animals. No landlord may charge an additional security deposit for an assistance animal.

Instructors need to be prepared for prolonged discussions on certain legislation. Remember the priority is the section on the Brokerage Policies & Procedures Manual for Core A. The legislative acts presented are BRIEFLY summarized and are not meant for detailed discussion, but rather, information. If a licensee desires more detailed information on the specific legislation, they may research it by going to the appropriate websites.

2) Policies and Procedures Manuals are required by Hawaii Revised Statutes, §467-1.6(c). Think about this scenario: any licensee searching for a brokerage should always ask the principal broker, "Do you have a Policies and Procedures Manual?" If the answer is "No," and the licensee associates with that brokerage, this may potentially be a liability for that licensee should a complaint or case go before a court of law, or the Regulated Industries Complaints Office (RICO). E & O insurers may not view this disclosure favorably and may drop their insurance coverage. A judge or lawyer may find the licensee just as liable as the principal broker for knowingly associating with a brokerage with no Policies and Procedures Manual.



CERTIFYING A CONTINUING EDUCATION COURSE

Follow the chart below when submitting continuing education courses for certification. The author/owner of the continuing education course is required to submit the course certification application to the Commission. If a continuing education provider would like to offer a course written by an author/owner, whether it be a national course, ARELLO-certified course, or a course authored by an individual and is not a nationally-certified or ARELLO-certified course, the continuing education provider must obtain the written authorization from the author/owner to offer the course. The correct course application form must be completed along with the course application fees, a table of contents and time frames for the course topics, the course materials, and any student handouts for the course.

Courses may be submitted for a minimum of 3 credit hours up to 15 credit hours. DO NOT INCLUDE BREAKS OR NON-INSTRUCTIONAL TIME in the clock hours submitted for approval.

If the Commission's Education Review Committee (ERC) determines that certain topics included in the course content do not meet the definition of CE as stated in Hawaii Administrative Rules (HAR) §16-99-100 or are topics included in HAR §16-99-101, "Courses not acceptable for continuing education course certification", the ERC may reduce the number of credit hours requested, based on the time devoted to topics that do not qualify for CE credit.

When submitting a course for approval, please review the course content, topic by topic, so that you may justify the total time requested for CE credit. There is a form attached to the course application for just this purpose. The author/owner submitting the course for certification must provide a list of course topics and time frames for all topics **qualifying for CE credit**.

The course certification fees are \$150 for a 3-hour course, and an additional \$50 for each hour applied for over the minimum of 3 hours. For example, the application fee for a 4-hour course will be \$200. Course certification fees are non-refundable.

For nationally- or ARELLO-certified CE courses, the course certification fees remain at \$25 for a 3-hour course, and \$25 for each additional 3-hour increment, whether it is one (1) hour or three (3) hours over the minimum 3-hour course credit request.

ONLINE PRELICENSE SYSTEM


COMING SOON! The Real Estate Branch will soon have an online prelicense system similar to the successful continuing education online system that you know and love so well.
