Mr. Bryan Andaya was present to answer any questions from the Committee.

Commissioners Senter and Arakaki recused themselves from discussion and decision making due to conflicts of interest.

Mr. Andaya stated that salespersons and brokers will benefit from a review and refresher regarding rules on advertising and solicitation. The course covers various Hawaii real estate statutes and rules, current events and issues that affect real estate licensees, such as the temporary Principal Broker and Broker in Charge, location of a real estate office, license display, solicitation through telephone, fax and emails, and Hawaii real estate advertising rules.

Commissioner Sherley suggested that the author include leasehold disclosures on leasehold purchases. He also suggested including new federal rules with respect to capital gains when buying and selling real estate.

Mr. Andaya commented that he will include a disclaimer that states the course is not providing advice to real estate licensees, but rather the material attempts to present an intelligent discussion of the issue.

Commissioner Faulkner stated that he noticed some typos throughout the materials which should be corrected.

Mr. Andaya stated that he will correct typos and add in Commissioner Sherley's suggestions.

Commissioner Cobb questioned who the target audience was for this course.

Mr. Andaya replied that there is no specific target as the subject is broad. Everyone needs to have a refresher and be reminded of the applicable compliance requirements for licensees.
