Examination Contract

It was reported that effective January 1, 2014, the exam fee will increase from \$63 to \$68. SEO Fujitani noted that the previous test vendor charged \$68. PSI underbid at \$63, and now 5 years later will be increasing the fee to \$68. The Commission has just rolled over the contract with PSI for another 5 years.

Educator's Forum: No discussion presented.

Program of Work: <u>Instructor's Development Workshop</u>

HAR's flyer for the upcoming IDW "Inviting Technology Into the Classroom" was distributed for informational purposes. The Commission is co-sponsoring the IDW to be held on the Big Island on October 30th, Maui on October 31st and Oahu on November 1st.

Commissioner Sherley noted that the presenter, Alycea Snyder, an Innovation Developer for The CE Shop, is a great speaker and that he encourages all instructors to attend. This IDW brings technology to the classroom. There is a lot of interactive group participation, and the use of smart phones and tablets as the new evolution of hands-on tools in the classroom.

Commissioner Cobb questioned whether staff monitors the instructors' classes after attending a Commission-sponsored IDW.

Specialist Fujimura responded in the negative, but did note that courses are monitored.

CE Providers are responsible for monitoring their CE instructors and ensure that they are able to teach the subject matter.
