Upon a motion by Commissioner Sherley, seconded by Commissioner Gendrano, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Application for a Real Estate Broker's License of Jeff LaFrance; REC LIC 2013-001

Upon a motion by Commissioner Gendrano, seconded by Commissioner Arakaki, it was voted on and unanimously carried to approve the Final Order.
