## SEO's Report: Announcements, Introduction, Correspondence and Additional Distribution

SEO Fujitani announced that due to an anticipated lack of quorum for the April 9, 2014 meetings, the meeting date will be changed to Monday, April 7, 2014. Commissioners to confirm their availability to staff by end of today.

## **Minutes of Previous Meetings**

Upon a motion by Commissioner Gendrano, seconded by Commissioner Sherley, it was voted on and unanimously carried to accept the minutes of the February 12, 2014, Laws and Rules Review Committee meeting as circulated.

# Program of Work: Legislative and Government Participation Report

Legislative Report No. 2 was distributed to the Commissioners for their information. SEO Fujitani reported on the status of the following bills:

House Bill No. 474, H.D. 1 – Relating to transient accommodations. Clarifies that an association's duty to report to the Dept. of Taxation is limited to the relevant information an association actually receives from a transient accommodation operator. Passed third reading as amended in H.D. 1.

House Bill No. 457 H.D. 1 – Relating to Act 326, SLH 2012, Reporting requirements. Requires any operator of a transient accommodation to furnish "relevant information" concerning the operator. Modifies the duties of non-government entities regarding "relevant information" pertaining to operators of transient accommodations. Re-referred to CPN/TSM.

House Bill No. 2401 – Relating to condominiums. Clarifies the REC's enforcement authority by authorizing the award of attorneys' fees and, in certain cases, authorizing the Commission discretionary power to decline to bring enforcement actions. Removes board's ability to close meetings and deny participation to association members. Hearing was held on March 11<sup>th</sup>. Senator Baker has requested a meeting with REC staff, RICO, and CAI Hawaii to work together to reach solutions to assist unit owners with problems they are incurring.

Commissioner Senter questioned whether the problems are a procedural issue or substantive issue.

Specialist Yee noted that much of the problems seem to be centered on managing agents not responding timely to owners' requests.

Commissioner Arakaki noted that the bulk of calls received deal with assessments and the owners not receiving timely response from either the board or the managing agent. Realistically, most associations don't have the money to seek legal action. A specified time frame should be provided for producing documents.

Specialist Stone commented that RICO has jurisdiction over providing documents; no jurisdiction over the underlying issues.

Commissioner Cobb stated that boards should be provided more education and commented that she has requested previously that education be offered on the island of Kauai.

Commissioner Senter commented that there seems to be a combination of issues to resolve: mediation, funding, education, and legislation to provide for a time frame to produce documents.
