Condominium Seminars and Symposium - CAI Hawaii 2015 Seminars

The committee acknowledged receipt of CAI Hawaii's request for approval of CETF subsidized seminars.

Specialist Yee informed the committee that the approval process for this type of request where the topic or subject matter of the seminar had been previously approved by the Commission had been delegated to staff. Staff is thus reporting that the requested seminars fall within the delegation and staff will be approving the requested seminars being offered through June 30, 2015 for CETF subsidies subject to the terms and conditions of the existing contract and the availability of the CETF monies.

Condominium Seminars and Symposium—CAI Hawaii's Request for Approval of Estimated Expenses for National speaker at approved Condominium Education Trust Fund seminars (Oahu, Kona, and Maui)
