Call to Order: Chair Senter called the meeting to order at 9:05 a.m., at which time

immunities, and liabilities in accordance with Section 92-5(a) (4), HRS.

## Executive Officer's Report

The Executive Officer (EO) informed the Commissioners that the original applications, with any original associated documents considered at the meeting, were available for review.

EO announced that the Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on any agenda item subject to the conditions set forth in Section 16-99-83, HAR. The Commission may remove any person or persons who willfully disrupts a meeting to prevent and compromise the conduct of the meeting in accordance with Section 92-3, HRS.

Minutes of Previous Meetings:

Upon a motion by Commissioner Sherley, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the minutes of the September 26, 2014 meeting.

## Committees and Program of Work

### **Laws and Rules Review Committee**

Licensing Renewal - Real Estate Branch (REB) is currently accepting renewals for 2-year period from January 1, 2015 through December 31, 2016. Effective October 20, 2014, PVL increased their initial and renewal licensing fees by an estimated 23%. Commissioner Wada questioned if the increase applies to other licenses. SEO Fujitani responded that all PVL Boards to eventually be affected by this increase, but REB is the first Board affected since its renewal went live on October 20, 2014. It was an administrative departmental decision made under the authority of §92-28 and §436B-15, HRS. This increase is to upgrade the current computer system and replace the existing phone system.

Deputy Attorney General (DAG) Wong inquired why the increase. Commissioner Klein indicated that it was noted on page 3 of the Memo dated September 25, 2014, Request for Approval to Increase Certain Fees from the Director. DAG Wong further inquired how the increase was approved without exercising the Rulemaking process. SEO Fujitani responded that it was done under the Authority of §92-28 as indicated in the memo.

Commissioner Arakaki inquired if a statement will be released by the Department to inform the licensees of the increase. SEO Fujitani responded that it will be published in the Minutes, an announcement will be posted on the website, and will be included in future bulletins.

Report on the 2014 Annual Association of Real Estate License Law Officials (ARELLO) Meeting – The report was consolidated by all attendees. Commissioner Arakaki shared that as a first time attendee, he found the meeting to be substantive. He received valuable information to make him a better commissioner and is now equipped to better help the public. On a personal level, Commissioner Arakaki felt that he is more knowledgeable on the trends and the similarities of Hawaii's market compared to others. Commissioner Arakaki highly recommends attendance at these meetings.

Commissioner Cobb continued to find these ARELLO meeting very interesting and felt that Hawaii, compared to other states, is well ahead of the game.

SEO Fujitani added that ARELLO developed a Fair Housing Development member resource online with a link to it on its website.

Licensing Ratification:

Upon a motion by Commissioner Cobb, seconded by Commissioner Lee, it was voted on and unanimously carried to ratify the attached list.

Chapter 91, HRS, Adjudicatory Matters: The Chair took the agenda out of order and called for a recess from the meeting at 9:20 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate Salesperson's License of Vinah Morales; REC 2013-89-L

Upon a motion by Commissioner Sherley, seconded by Commissioner Faulkner, it was voted on and carried to accept the settlement agreement.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:25 a.m.

Licensing Applications:

EO informed the Commissioners that the information, provided to the Commissioners, is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing Applications:

### Timothy B. Ambler

After review of the information presented by the applicant, Commissioner Pang moved to approve the real estate salesperson license of Timothy B. Ambler. Commissioner Sherley seconded the motion. The motion was voted on.

Commissioners Senter, Sherley, Faulkner, Lee, Arakaki, Wada, and Pang voted aye. Commissioners Klein and Cobb voted nay. The motion passed.

### Jawdat Ihsan Bitar

After review of the information presented by the applicant, Commissioner Cobb moved to deny the real estate salesperson license of Jawdat Ihsan Bitar, unless, within sixty (60) days, he submits evidence of a payment plan or satisfaction of the court judgments.

The denial of his application is based on the following:

"§467-8 **Prerequisites for license, registration, or certificate.** No license, registration, or certificate under this chapter shall be issued to:

- (3) Any person who does not possess a reputation for or record of competency, honesty, truthfulness, financial integrity, and fair dealing;...;" and
- "§436B-19 Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses. In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:
- (1) Failure to meet or maintain the conditions and requirements necessary to qualify for the granting of a license;...
- (8) Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity; . . .
- (12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;..."

The Commission concluded that the information submitted indicates that Mr. Bitar does not meet the requirements for licensure pursuant to the provisions cited above.

Commissioner Arakaki seconded the motion. The motion was voted on and unanimously carried.
