Legislative Report No. 3 was distributed to the Commissioners for their information. The Commission as a body will submit testimony on bills that directly affect chapter 467 and licensees or that affect the Commission's operations and staff will assist if requested by a legislator or legislative committee for the Commission's input regarding specific bills.

SEO Fujitani reported on the status of the following bill:

HCR 48 –Requesting the Auditor to conduct an analysis of the need for the licensing and regulation of transient vacation rentals. The Department submitted testimony in support, all other testimony received were in opposition.

The SEO informed the committee that HRS §26H-6 requires that new regulatory measures being considered for enactment be referred to the Auditor for analysis to determine whether the regulation is warranted or not.
