Staff to inform the requestor that the Commission plans to address inquiries such as Mr. Dante's in its next round of administrative rulemaking to perhaps include sections or definitions for "manage or offers to manage" and "property management." This administrative rulemaking process will examine whether there has been a consistent historical pattern of deciding similar inquiries and offer the opportunity for community input, industry participation, and public comment at a duly-noticed public hearing.
