# <u>Applications</u>

Course – "Homeowner's Insurance Basics for Real Estate Professionals"; Author/Owner: John Dotten.; Provider: TBD; Course Category: Property Management, Finance, Property Ownership and Development, Risk Management; Clock Hours: 3 (Deferred from 7/8/15 ERC meeting)

Mr. Dotten was present to answer any questions the Committee may have.

Mr. Dotten informed the Committee that he has met with Professor Paul Deering of the University of Hawaii to clarify when, why, and how real estate agents should be involved with insurance issues.

Chair Cobb questioned if the attachments provided with the application were the handouts for the students.

Mr. Dotten responded in the affirmative and noted that the handouts are from the Insurance Institute. He also clarified that he is not trying to make real estate licensees insurance experts but to fundamentally familiarize them with insurance basics so they may adequately refer the client or consumer to an expert.

Chair Cobb stated that she is confused on the continuity of the information in the course. The organization of the instructor's course manual is confusing.

Upon a motion by Commissioner Arakaki, seconded by Commissioner Lee, it was voted on and unanimously carried to take the matter under advisement.

Course – "Red Flags to Look For in Condo Documents;" Author/Owner: John Dotten; Provider: TBD; Course Category: Contracts, Real Estate Law, Property Management, Property Ownership and Development, Risk Management; Clock Hours: 3

Mr. John Dotten was present to answer any questions the committee may have regarding the course application "Red Flags to Look For in Condo Documents."

Mr. Dotten noted that this course is a new submittal. The course is intended to give real estate licensees a better idea of what condo documents are to be provided to the prospective purchaser, to better understand the contractual issues in the documents, and to make licensees aware of their rights and responsibilities in regards to the association relative to their client.

Mr. Dotten noted that although the terms "apartment" and "unit" are interchangeable in the industry, he has corrected the usage of the term to "unit" in his course submittal. He also stated that the term Horizontal Property Regime, while no longer used, is still in existence and licensees should be aware of the term. He further noted that the term "red flag" is a term used in the administrative rules which is used to identify areas where there may be problems.

Mr. Dotten noted that he has worked with David Robiak, attorney at law, and Paul Deering, PhD, University of Hawaii, to correct the areas of concern previously noted by the Commission in an earlier submission of the course.

Commissioner Senter stated the course objectives need to be clarified. The course appears to be focused on resales and property management for the licensee. She noted page 3 states, "Condominiums in some respect effectively are small governments . . . " She suggested changing "small governments" to "condominium associations." Commissioner Senter also stated that page 7 should be corrected to state that "PCI" stands for "Percentage of Common Interest"; and page 10 under "HPR/CPR – State Registrations", the last sentence in the paragraph should be corrected by replacing "build" with "sell," so as to read, ". . . allowing the developer to sell condominiums."

Commissioner Sherley disclosed that he has known Mr. Berman for 20 plus years and is able to vote fairly and objectively on Mr. Berman's course submission.

Commissioner Klein noted that the course is well written and articulates an important area of concern for licensees.

Mr. Berman informed the committee that he made the course personal to keep everyone's attention and to make the course interesting. He stated that knowledge is power.

Commissioner Senter questioned if Mr. Berman is licensed in Hawaii. She also noted that there are some spelling errors within the course documents, otherwise the course content is very good.

Mr. Berman responded that he is not licensed in Hawaii. He is licensed in California and has federal jurisdiction with the IRS.

Upon a motion by Commissioner Arakaki, seconded by Commissioner Klein, it was voted on and unanimously carried to take the matter under advisement.
