## Program of Work: Rulemaking, Chapters 107/119

Specialist Yee reported that she has been fine tuning the Commission's Blue Ribbon Committee's recommended changes to the Commission's administrative proposed draft condominium rules. She also reported that she has discovered that the redrafting process is taking more time then what was first estimated. Nevertheless she announced that at the end of November, she will be distributing to the Blue Ribbon Committee for their final review whatever redrafts she has completed.

## **Legislative Acts and Resolutions**

Specialist Stone reported that as a representative of the Commission, she is participating in DBEDT's Hawaii Multi-Unit Dwelling EV Charging Working Group, (Act 164) by request of DCCA's Director. The purpose of the working group is to address the installation of electric vehicle charging stations at multi-unit dwellings which include condominiums. The working group is exploring barriers such as existing condominiums without infrastructure for EV charging stations. The working group has met twice. The report is due to the Legislature prior to the start of the upcoming session.

## **Interactive Participation with Organizations**

Specialist Choy attended the October 20, 2015 workshop "Kaka'ako: Our Kuleana A Free Urban Planning Academy for Everyone." Specialist Choy provided a summary of his written report which was provided for the Committee's review. Discussion followed on the impacts, if any, the information may have on the condominium project registration process and the developer's draft public report.

Specialists Choy and Stone attended HCCA's seminar "Almost Free Legal Advice" on October 29, 2015. Speakers included RICO's Daria Loy-Goto, Jane Sugimura, John Knorek, and Scott Sherley. The seminar was well attended
