Eddie Flores Real Estate Continuing Education - Advertising

Correspondence and response from Eddie Flores Real Estate Continuing Education regarding their advertising of the not yet certified Core B Core Course was provided for informational purposes.

As a reminder, §16-99-114(6) states "A continuing education provider shall not engage in any of the following acts; . . . (6) Advertise a course which has not been certified by the commission, unless the advertisement clearly states that it is 'proposed' or 'tentative' offering, subject to the certification by the commission;

Staff will follow up on information received from licensees and the education industry should it affect the offering of continuing education courses. Staff will also include reminders in its School Files publication.

Applications

Provider – At Your Pace Online, LLC, Administrator – Tony Bowers

Upon a motion by Commissioner Pang, seconded by Commissioner Sherley, it was voted on and unanimously carried to approve "At Your Pace Online, LLC" as a continuing education provider.

Course – "A Legal & Ethical Career in Real Estate"; Author/Owner: At Your Pace Online, Provider – At Your Pace Online, LLC (pending approval); Course Categories: Contracts, Real Estate Law, Risk Management; Clock Hours: 12

There was concern regarding the length of the course, 12 hours, and a suggestion that the course be divided into multiple courses. Staff informed the committee that while taking an online course, the attendee is able to pause the course and return to complete the course at a later time. The Commission also allows approval of courses up to 15 hours.

Commissioner Pang suggested that the author specify that the Fair Housing portion of the course is specific to Federal Fair Housing Laws as it does not seem to include Hawaii laws.

Upon a motion by Commissioner Pang, seconded by Commissioner Sherley, it was voted on and unanimously carried to approve "A Legal & Ethical Career in Real Estate" as a twelve (12) credit hour continuing education course, under the course categories Contracts, Real Estate Law, Risk Management.

Course – "Code of Ethics"; Author/Owner: Honolulu Board of REALTORS®; Provider - Honolulu Board of REALTORS®; Course Categories: Risk Management, Other - Ethics; Clock Hours: 3

Kamalani Rodrigues of the Honolulu Board of REALTORS® was present to answer any questions the committee may have. She noted that the course was written to satisfy the mandatory Ethics requirement of Realtor® members which is due by December 31, 2016. It was noted that the course addresses the most current and relevant happenings in the local market. HBR has already trained 5000 of its 6000 members, which allows for the remaining 1000 members to receive CE credit should the course be approved. The course would also be applicable to all licensees, not just the Board's membership.

Upon a motion by Commissioner Pang, seconded by Commissioner Sherley, it was voted on and unanimously carried to approve "Code of Ethics" as a three credit hour continuing education course, under the course categories Risk Management, Other - Ethics.

Course – "Run Your Business Like A Business"; Author/Owner: Hawaii Association of REALTORS®; Provider: Hawaii Association of REALTORS®; Course Categories: Other – Business planning; Clock Hours: 6

Commissioner Klein questioned the meaning of "An exercise in Crazy" on page 7, slide 2, under "What is a business plan?"

Marsha Shimizu of the Hawaii Association of REALTORS® explained the phrase as an attempt to describe the analytical process that is necessary to put together a business plan. All licensees are independent contractors so they need a business plan that gives them a solid foundation. She further responded that she would reevaluate the terminology used in the slide.

Upon a motion by Commissioner Sherley, seconded by Commissioner Klein, it was voted on and unanimously carried to approve "Run Your Business Like A Business" as a six credit hour continuing education course, under the course categories Other – Business planning.

Course – "Meth and Its Makers: New Hazards in Housing"; Author/Owner: Karel Murrya, CSP, DREI; Provider: Real Class, Inc.; Course Categories: Risk Management, Other – Environmental Hazards and Licensee Safety; Clock Hours: 3

Commissioner Sherley recused himself from decision making and informed the committee that he could answer any questions as he is the Provider of the proposed course.

Mr. Sherley stated that the author of the course has had first-hand experience in dealing with this course topic. The course will identify the ethical and legal

responsibilities of real estate licensees regarding properties contaminated by the cooking of meth. It will provide information on protecting the licensee, the buyer, and the community by knowing what to look for, how to disclose and who to call.

Upon a motion by Commissioner Klein, seconded by Commissioner Faulkner, it was voted on and carried to approve "Meth and Its Makers: New Hazards in Housing" as a three credit hour continuing education course, under the course categories Risk Management, Other – Environmental Hazards and Licensee Safety. Commissioner Sherley was recused from voting.
