SEO's Report: Minutes of Previous Meetings

Upon a motion by Commissioner Pang, seconded by Commissioner Faulkner, it was voted on and unanimously carried to accept the minutes of the April 6, 2016 Laws and Rules Review Committee meeting as circulated.

Program of Work: Rulemaking, Chapter 99, HAR, Real Estate Brokers and Salespersons

SEO Fujitani reported that the Commission had sent back the advertising section of the rules to be reviewed by the rules subcommittee. SEO Fujitani inquired as to the Commission's desire on its meeting method, i.e. via phone, via email, in person subcommittee meetings, etc.

The subcommittee members noted that the subcommittee is small enough in size to meet in person.

The SEO and EO have met and come up with a draft to discuss with the subcommittee. It was decided that the subcommittee to meet following the May Commission meeting.

Legislative Acts and Resolutions

The Commission is in receipt of two House Resolutions: HR No. 28 – Requesting the convening of a task force to conduct a study on imposing mandatory alternative dispute resolution to resolve homeowners associations disputes; and HR No. 104, HD1 – Requesting the Real Estate Commission to study the effectiveness of its existing dispute resolution process and consumer assistance program for condominium owners and associations, and possible expansion of these services to other types of homeowners associations.

The Commission will address issues raised in HR 104 HD1 in the Real Estate Commission's Annual Report to the Legislature.

Neighbor Island Outreach

The June 8, 2016 Committee meetings will be held in Hilo at the Hawaii Island Realtors® Office in conjunction with the Specialists' Office for the Day program. The Hawaii Island Commissioner will not be in attendance due to a conflict with his representation of the Commission at the Real Estate Educators Association Conference.

Licensing Renewal

The go live date for real estate online renewals is October 17, 2016. Twenty hours of continuing education are required for those licensees renewing on an active status.
