SEO's Report:

The SEO welcomed the guests present and acknowledged Representative Onishi. He further thanked the Hawaii Island REALTORS® for use of their facilities to hold the committee meetings.

Minutes of Previous Meetings

Upon a motion by Commissioner Sherley, seconded by Commissioner Klein, it was voted on and unanimously carried to accept the minutes of the May 11, 2016, Laws and Rules Review Committee meeting as circulated.

Program of Work:

Neighbor Island Outreach

It was reported that as part of the Commission's Program of Work and per HRS §467-4(6), the Commission holds its committee meetings quarterly in a different county, alternating between Maui, Kauai, and Hilo and Kona. The neighbor island meetings afford neighbor island licensees, government officials, condominium owners and interested parties the opportunity to attend and participate in the committee meetings.

Rulemaking, Chapter 99, HAR, Real Estate Brokers and Salespersons

SEO provided a status update of the proposed Chapter 99 rules. Staff removed all amendments to HAR §16-99-11 relating to advertising and resubmitted the rules in early May to the Office of the Attorney General for review and signature. During the process of removing the earlier proposed amendments formatting has changed the document, therefore the Deputy Attorney General is reviewing for accuracy. Deputy AG Wong has also informed staff that she is buried under Governor Reports, Medical Board lawsuit and other Board rule reviews.

Commissioner Cobb questioned the Rulemaking subcommittee whether or not HAR's advertising proposal has been accepted. She noted that she will be attending the REEA Conference where advertising will be a subject matter discussed and she will be bringing back information that may be beneficial to the committee.

Commissioner Pang responded that the subcommittee met and discussed the draft and included a large portion of what HAR requested. The draft will again be reviewed and presented to the full Commission for decision making.

ARELLO, Other Organizations And Jurisdictions:

Meetings, Workshops, and Reports

The committee acknowledged the written report submitted by Commissioners Arakaki, Cobb and SEO Fujitani on their participation at the 2016 Association of Real Estate License Law Officials Mid-Year Meeting held in Atlanta, Georgia. A copy of the report will be transmitted to the PVL Licensing Administrator.

SEO Fujitani noted that the Mid Year Meeting is important for Hawaii because the District meetings are held in conjunction.
