Course – "Protect Your Real Estate License: You Don't Have to be Guilty to Get Sued"; Author/Owner: Philip Hale Wilia; Provider: Dower School of Real Estate; Course Categories: Property Management, Other – Real Estate Management; Clock Hours: 3 (Deferred from 7/13/16 ERC meeting)

Commissioner Lee stated that the course application was deferred from the July 13, 2016 ERC meeting. At that meeting it was noted that page 6, section 2.02, included two section (d)s. Although the author has changed the sections to (d) and (e), the content remains identical.

Commissioner Arakaki stated that the material covers a lot of territory and by the end of the course, the student should glean much information.

Some commissioners noted that the material was very wordy and lengthy. Staff noted that the exhibits to the course content are copies of relevant laws and rules.

Commissioner Sherley responded that there are many types of learners, some may like a wordy document to refer back to, whereas others may not. It is the teaching style of the instructor which will hold their interest.

Upon a motion by Commissioner Pang, seconded by Commissioner Arakaki, it was voted on and unanimously carried to approve "Protect Your Real Estate License: You Don't Have to be Guilty to Get Sued" as a three credit hour continuing education course, under the course categories Property Management and Other – Real Estate Management, subject to correcting section 2.02 (d) and (e).

Course – "Beyond Hawaii Land History 101 – The Mahele, Cultural Practices and the Bureau of Conveyances;" Author/Owner: Celine P. Nelsen; Provider: Abe Lee Seminars; Course Category: Property Ownership and Development; Clock Hours: 3

Commissioners noted that it is a good course on historic information on the Hawaii land system which is very unique.

Specialist Fujimura noted that the course content was edited down from its original submission.

Upon a motion by Commissioner Arakaki, seconded by Commissioner Faulkner, it was voted on and unanimously carried to approve "Beyond Hawaii Land History 101 – The Mahele, Cultural Practices and the Bureau of Conveyances" as a three credit hour continuing education course, under the course category Property Ownership and Development.

Course – "A REALTOR'S® Responsibilities During Escrow"; Author/Owner: Marion Haller; Provider: REALTORS® Association of Maui, Inc.; Course Categories: Contracts, Risk Management; Clock Hours: 3

Commissioner Pang noted that the title and content of the course should not include the trademark "REALTOR'S®" and instead be replaced with "Licensee." It was noted that not all licensees are REALTORS®.

Commissioner Senter noted that there are four topics in the course, but the course materials only cover the escrow process. What are the course objectives? Is it in the four topics listed on the syllabus or is it in the escrow process? The course content should reflect the course title.

She further noted that the breakdown on the course curriculum form of the course application is difficult to reconcile with the information on the "course outline" and the "syllabus". They do not appear to be consistent.

After a review of the information presented, Commissioner Senter moved to defer "A REALTOR'S® Responsibilities During Escrow" as a continuing education elective course. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.
