Program of Work: Rulemaking, Chapter 99, HAR, Real Estate Brokers and Salespersons

Executive Officer Ino reported that the Chapter 99 rules are proceeding through the process and we hope to get it before the Governor for approval before the end of the year.

Amendments to §16-99-11 relating to advertising have been sent back to the department's administrative services office to correct some formatting issues to the ramseyer draft. Upon return the draft will be sent to the Attorney General and the Legislative Reference Bureau for review. We are still in the early stages of the rule revision to §16-99-11. The goal is to go through public hearing before year's end.

Commissioner Pang questioned if the Hawaii Association of REALTORS® (HAR) was provided a draft of §16-99-11.

Myoung Oh responded that HAR was informed by the Commission of the amendments to §16-99-11 that were approved at a previous meeting.

EO Ino informed Mr. Oh that staff will provide HAR with a draft of the ramseyer copy.
