Call to Order: The Chair called the meeting to order at 9:02 a.m., at which time quorum was established.

Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section 92-5(a)(4), HRS.

Executive Officer's Report: The Executive Officer ("EO") informed the Commissioners that the original application with any original associated documents to be considered at the meeting were available for review.

Announcement

Supervising Executive Officer Fujitani ("SEO") introduced and welcomed newly appointed Commissioner Sean Ginoza. Commissioner Ginoza is an interim appointment filling the position vacated by Scott Sherley. Commission thanked Commissioner Ginoza for serving.

Minutes of Previous Meeting

Upon a motion by Commissioner Lee, seconded by Commissioner Wada, it was voted on and unanimously carried to accept the minutes of the December 16, 2016 meeting.

Committees and
Program of Work:

Laws and Rules Review Committee

Laws and Rules Review Committee – Rulemaking, Hawaii Administrative Rules, Title 16, Chapter 99 – Real Estate Brokers and Salespersons – Draft for revisions to 16-99-11 – Advertising.

EO Ino explained that comments were received from the attorney general and the Legislation Reference Bureau (LRB), the latter of which advised the department that in accordance with Hawaii Administrative Rules Drafting Manual, Third Edition, all rulemaking actions for which a public hearing is held after December 21, 2016, all proposals for changes should be at the chapter level. Consequently, the draft of proposed revisions had been modified accordingly and was presented to the Real Estate Commission for approval.

DAG Wong recommended to the Commission that the chapter be divided by section, each section becoming a separate chapter. DAG Wong stated that this is how other boards produce their rules. Chair Senter recommended that this be done at a later date. Commissioner Pang suggested that staff study the rules to determine where to separate each section. EO Ino stated that there is a lot of over-lap and cross-referencing between sections in the existing format so this will be a long-term project for staff.

Upon a motion by Commissioner Klein, seconded by Commissioner Pang, it was voted on and unanimously carried to approve draft.

Education Review Committee

Education Review Committee – Continuing Education Core Course – Request for Quotes – Hawaii Real Estate Commission's Mandatory Core Course, 2017 – 2018. Two bids were received; one from Robin Sagadraca and Randy Prothero and one from Everett Kaneshige. Bidders were present for questions and comments.

Executive Session:

Upon a motion by Commissioner Cobb, seconded by Commissioner Faulkner, it was voted on and unanimously carried to enter into executive session, pursuant to section 92-5(a)(8), HRS, "To deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a state or federal law, or a court order." And pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Arakaki, seconded by Commissioner Cobb, it was voted on and unanimously carried to move out of executive session.

Upon a motion by Commissioner Arakaki, seconded by Commissioner Cobb, it was voted on and carried to approve bid submitted by Everett Kaneshige as he was the only qualified bidder. Commissioners Arakaki, Cobb, Senter, Lee, Faulkner, Wada, Klein and Ginoza voted aye. Commissioner Pang recused himself from the vote. The motion passed.

Upon a motion by Commissioner Faulkner, seconded by Commissioner Klein, it was voted on and unanimously carried to approve the Commission's Proposed Final Order.

In the Matter of the Real Estate Licenses of Todd E. Hart, a real estate broker, Debra Hart, a real estate salesperson, and Hart of Kona Realty, Inc., a real estate broker: REC 2008-227-L, REC-2015-169-L [Consolidated Cases];

Mr. Hart appeared and was allowed to address his concerns to the Commission.

In the Matter of the Real Estate Licenses of Realty Group Inc., dba Realty Group and Glenn Nishihara: REC-2012-53-L

Upon a motion by Commissioner Pang, seconded by Commissioner Cobb, it was voted on and carried to accept the settlement agreement. Commissioners Pang, Lee, Cobb, Arakaki, Faulkner and Ginoza voted aye. Commissioners Senter, Wada and Klein voted nay. The motion passed.

In the Matter of the Real Estate Licenses of Realty Group Properties, LLC and Trudy Nishihara: REC-2010-275-L

Upon a motion by Commissioner Pang, seconded by Commissioner Cobb, it was voted on and carried to accept the settlement agreement. Commissioners Pang, Lee, Cobb, Arakaki, Faulkner and Ginoza voted aye. Commissioners Senter, Wada and Klein voted nay. The motion passed.

Licensing –
Applications:

Andrew Ah Moon Hatchie, Jr.

After due consideration of information presented by the applicant, Commissioner Klein moved to deny the real estate salesperson application of Andrew Ah Moon Hatchie, Jr., basing the decision on the following grounds of the Hawaii Revised Statutes ("HRS"), which find factual support in the records and files of his application:

HRS § 467-8 **Prerequisites for license, registration, or certificate.**
(a) No license, registration, or certificate under this chapter shall be issued to:

HRS § 467-8(3) Any person who does not possess a reputation for or record of competency, honesty, truthfulness, financial integrity, and fair dealing; and

HRS § 436B-19 **Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses.** In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

HRS § 436B-19(1) Failure to meet or maintain the conditions and requirements necessary to qualify for the granting of a license;...

HRS § 436B-19(8) Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity;...

HRS § 436B-19(12) Failure to comply, observe, or adhere to any law in a manner such that the licensing authority deems the applicant or holder to be an unfit or improper person to hold a license;...

HRS § 436B-19(13) Revocation suspension, or other disciplinary action by another state or federal agency against a licensee or applicant for any reason provided by the licensing laws or this section;

HRS§ 436B-19(14) Criminal conviction, whether by nolo contendere or otherwise, of a penal crime directly related to the qualifications, functions, or duties of the licensed profession or vocation;

Commissioner Wada seconded the motion. The motion was voted on and unanimously carried.

Nathan J. Love

After due consideration of information presented by the applicant, Commissioner Pang moved to deny the real estate salesperson application of Nathan J. Love basing the decision on the following grounds of the Hawaii Revised Statutes (“HRS”), which find factual support in the records and files of his application:

§467-8 **Prerequisites for license, registration, or certificate.**
(a) No license, registration, or certificate under this chapter shall be issued to:

HRS § 467-8(3) Any person who does not possess a reputation for or record of competency, honesty, truthfulness, financial integrity, and fair dealing; and

§436B-19 **Grounds for refusal to renew, reinstate or restore and for revocation, suspension, denial, or condition of licenses.** In addition to any other acts or conditions provided by law, the licensing authority may refuse to renew, reinstate or restore or may deny, revoke, suspend, or condition in any manner, any license for any one or more of the following acts or conditions on the part of the licensee or the applicant thereof:

§436B-19 (1) Failure to meet or maintain the conditions and requirements necessary to qualify for the granting of a license;. . .

§436B-19 (8) Failure to maintain a record or history of competency, trustworthiness, fair dealing, and financial integrity;. . .

Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.

Jimmie Lee Cooper

After review of the information presented by the applicant, Commissioner Wada moved to most likely deny the real estate salesperson license of Jimmie Lee Cooper. Commissioner Cobb seconded the motion. Commissioners Wada, Cobb, Faulkner, Klein and Ginoza voted aye. Commissioners Pang and Lee voted nay. The motion passed.

Amber Lee Lane

After review of the information presented by the applicant, Commissioner Pang moved to most likely deny the real estate salesperson license of Amber Lee Lane. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.

Dante Velacion and Velcom Realty Corp.

After review of the information presented by the applicant, Commissioner Pang moved to approve the broker's license and corporation license of Dante Velacion and Velcom Realty Corp. Commissioner Klein seconded the motion. The motion was voted on and unanimously carried.
