Chair's Report: The Chair announced that the Commission may move into executive session to consider and evaluate personal information relating to individuals applying for licensure in accordance with Section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with Section 92-5(a)(4), HRS.

SEO's Report: Minutes of Previous Meetings

Upon a motion by Commissioner Faulkner, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the minutes of the July 14, 2017, Laws and Rules Review Committee meeting as circulated.

Program of Work: Legislative Acts and Resolutions – ACT 64 Relating to Public Meetings

Commissioners were provided with a copy of Act 64 and a summary sheet produced by the Office of Information Practices.

SEO Fujitani reported that Act 64 takes effect on July 1, 2018. The Act provides the following: 1) boards must make board meeting packets available for public inspection in the board's office at the time they are distributed to board members – staff to review, redact and make available an additional packet; 2) electronic notice of meetings must be posted on the state calendar no less than 6 calendar days prior to the meeting date, when feasible post the notice at the meeting location, and provide a copy of the notice to the Lt. Governor's office – REC is already following this practice; and 3) meeting minutes to be posted to the board's website within forty days – the change was from 30 to 40 days. With the change, approved minutes can now be made available rather than draft minutes.

Staff will await further direction from the Department as other questions arise such as how long the public copy of the packet needs to be retained and made available, and copyright issues on articles provided in the packet.

ARELLO, Other Organizations And Jurisdictions: ARELLO 2017 Mid-Year Meeting Report The committee acknowledged receipt of the ARELLO 2017 Mid-Year Report submitted by Commissioners Senter, Arakaki, Cobb and SEO Fujitani.

Chair Arakaki noted that ARELLO, the Association of Real Estate License Law Officials, is a national organization of real estate regulators. The conference allows for the sharing of knowledge and ideas with other jurisdictions.

SEO Fujitani noted that Hawaii is a part of District 4 which is made up of the West Coast jurisdictions. The district 4 meeting which SEO Fujitani finds vital to attend is held in conjunction with the Mid-Year meeting
