Call to Order: The Chair called the meeting to order at 9:00 a.m., at which time quorum was

established.

Chair's Report: The Chair announced that the Commission may move into executive session to

consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section

92-5(a)(4), HRS.

Executive Officer's

Report:

The Senior Real Estate Specialist informed the Commissioners that the original application with any original associated documents to be considered at the

meeting were available for review.

Commissioner Cobb was excused from the meeting. Prior notification of her non-

attendance was received.

Minutes of Previous Meeting

Upon a motion by Commissioner Faulkner, seconded by Commissioner Pang, it was voted on and unanimously carried to accept the minutes of the July 28, 2017 meeting.

Committees and Program of Work:

Licensing – Ratification:

Upon a motion by Commissioner Pang, seconded by Commissioner Klein, it was voted on and unanimously carried to ratify the attached list.

Licensing -

The Senior Real Estate Specialist informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Chair Senter announced she would be taking agenda items out of order for efficiency purposes.

Licensing – Applications:

Todd William Shirek

Mr. Shirek was present and was asked if he wished to have his request for preliminary decision application for real estate salesperson considered in executive session. He declined the offer.

Mr. Shirek stated this was an important matter to him and he flew in from North Dakota to be here. He added he has regret for past actions and will make sure it never happens again, and wants to move forward. Commissioner Faulkner asked if applicant was currently licensed in North Dakota and Minnesota and Mr. Shirek stated he previously held real estate salesperson's licenses in both states but no longer does. Commissioner Wada inquired why the amounts applicant was fined were \$750 and \$3000. Mr. Shirek answered the amounts varied because fines were from 2 different states.

After review of the information presented by the applicant, Commissioner Klein moved to most likely approve the real estate salesperson license of Todd William Shirek. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried, 8-0.

Richard Laporga

Mr. Laporga was present and was asked if he wished to have his request for removal of conditions considered in executive session. He declined the offer.

Mr. Laporga informed the Commission he was accompanied by Mr. Jacob Manegdeg, his current broker, who was also available for comment. Mr. Laporga stated he was humbled and grateful to be part of the real estate profession. He added he understands the seriousness of timelines, acknowledged he made mistakes, and was now ready to take the next step.

Commissioner Pang moved to take the matter under advisement. Commissioner Ginoza seconded the motion. The motion was voted on and unanimously carried, 8-0.

Upon a motion by Commissioner Lee, seconded by Commissioner Wada, it was voted on and unanimously carried, 8-0, to approve the settlement agreement.

In the Matter of the Real Estate License of Andrew S. Bashrum: REC 2015-247-L; Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Commission's Final Order

Upon a motion by Commissioner Lee, seconded by Commissioner Faulkner, it was voted on and unanimously carried, 8-0, to approve the settlement agreement.

In the Matter of the Real Estate License of Andrew L. Geiser: REC 2017-173-L; Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Commission's Final Order

Upon a motion by Commissioner Pang, seconded by Commissioner Faulkner, it was voted on and unanimously carried, 8-0, to approve the settlement agreement.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:26 a.m.

Executive Session:

Upon a motion by Commissioner Pang, seconded by Commissioner Arakaki, it was voted on and carried to enter into executive session, pursuant to section 92-5(a)(1), HRS, "To consider and evaluate personal information, relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Pang, seconded by Commissioner Faulkner, it was voted on and unanimously carried to move out of executive session.

Licensing – Applications:

David F. Maleski

After review of the information presented by the applicant, Commissioner Pang moved to approve the salesperson's license of David F. Maleski with conditions. Commissioner Faulkner seconded the motion. The motion was voted on and unanimously carried, 8-0.

The conditional real estate salesperson license is **approved** for the Applicant, subject to the following conditions:

- 1. That during the term of this conditional license, any violation of the terms of the payment plan with the Internal Revenue Service ("IRS") by the Applicant, shall be grounds for revocation of license.
- 2. That failure to provide written notice within 30 days to the licensing authority of any judgment, award, disciplinary sanctions, order, or other determination, which adjudges or finds that the licensee is civilly, criminally or otherwise liable for any personal injury, property damage or loss caused by the licensee's conduct in the practice of the licensee's profession or vocation shall be grounds for revocation of license.
- 3. That the Applicant shall at all times be associated with and under the direct supervision of a principal broker ("PB") or one or more brokers in charge ("BIC"), for all real estate transactions.
- 4. That the Applicant shall inform the PB, sole proprietor real estate broker, or BIC of a real estate branch office with whom the Applicant associates that the Applicant holds a conditional real estate salesperson license and may only practice pursuant to certain terms of the conditional license. The Applicant shall present to the Applicant's PB, sole proprietor real estate broker, or BIC of a real estate branch office a copy of the Commission-issued conditional letter. The Applicant shall ensure that the PB, sole proprietor real estate broker, or BIC of a real estate branch office acknowledges the terms of the Applicant's conditional license by signing and returning a signed copy of the conditional letter to the Commission.
- 5. That <u>ALL</u> changes of association and/or employment by Applicant to another real estate broker shall be submitted in writing to the Commission. The new PB, sole proprietor real estate broker, or BIC of a real estate branch office shall acknowledge the terms of the Applicant's conditional license within ten (10) days of the change by submitting a completed Change Form along with a copy of the conditional letter signed by the new PB. Failure to attach the signed conditional letter by the new PB may result in disciplinary action.
- 6. That the satisfaction of the Applicant from said payment plan shall not change any terms of the conditional license.
- 7. That upon completion of your payment plan with the IRS, the Applicant must submit a written request to the Commission if the Applicant desires to have the conditions removed.

Zuleika L. Leotele

After review of the information presented by the applicant, Commissioner Arakaki moved to defer the preliminary real estate salesperson's application of Zuleika L. Leotele and requested the applicant appear at the September 29, 2017, Real Estate Commission meeting. Commissioner Klein seconded the motion. The motion was voted on and unanimously carried, 8-0.

Richard Laporga

After review of the information presented by the applicant, Commissioner Klein moved to remove the conditions placed on the real estate broker's license of Richard Laporga. Commissioner Ginoza seconded the motion. The motion was voted on and unanimously carried, 8-0.

Melanie Castan

Pursuant to the vote at the July 28, 2017, Real Estate Commission meeting, the Commission signed the Proposed Final Order for Melanie Castan.
