Beth Holiday was present for any questions the committee may have regarding the above CE courses.

Commissioner Klein questioned the difference in course and clock hours. She also asked if all the courses were required or if the licensee may take any one of four courses.

Ms. Holiday explained she reviewed the course materials for repetition. She explained each course stands alone, but the courses together are a system of doing business. The system is set-up, preparation, seller's and buyer's tools, and negotiations.

Commissioner Pang asked if the licensees would be able to distinguish between the courses as the titles are similar. Commissioner Pang requested defining the title of the courses more specifically.

Ms. Holiday explained there will be a description of the courses and a tag line explaining what the courses will include.

Commissioner Lee asked if the courses will only be offered to one company, or if the courses will be offered to anyone who'd like to take the course.

Ms. Holiday explained she is purchasing the program from Larry Kendell to implement the Ninja System within her company to get everyone in the same system. They are holding a seminar in April for four consecutive days which will be open to anyone who would like to take the courses.

Ms. Holiday stated they are not excluding anyone and no one will be refused. Senior Real Estate Specialist Fujimura explained the approved courses will be on the Real Estate CE website available to all licensees.

Upon a motion by Commissioner Pang, seconded by Commissioner Arakaki, it was voted on and unanimously carried to take the matter under advisement.
