Commissioner Pang suggested amending the course title to, "Basics of Selling the Sun", as the course is very basic with general information.

Chairman Cobb commented the course was well done especially for people who have no knowledge of photovoltaic or solar energy systems.

Commissioner Pang moved to approve "Selling the Sun" as a 3-credit hour continuing education course, under the course categories Property Ownership and Development, Other – Environmental Issues related to residential real estate, subject to changing the title to "Basics of Selling the Sun". Commissioner Arakaki seconded the motion. The motion was voted on and unanimously carried.

## Course – "Skills for Success"; Author/Owner: I'mproving LLC dba Dale Carnegie Training Hawaii & Guam; Provider: Honolulu Board of REALTORS®; Course Categories: Dispute Resolution, Risk Management; Other – Communication and Negotiation; Clock Hours: 15

Kamalani Rodrigues and Jan Kaeo were present to answer any questions the Commissioners may have. Ms. Rodrigues commented the two concerns the Commission had last year regarding the Dale Carnegie course were the name branding name and the course itself. Ms. Rodrigues informed the Commission that Dale Carnegie is also a course developer and school, like ProSchools, Dearborn, CE Shop, OnCourse Learning, etc. The second concern was the course is written in a general way, which address many professionals across all industries. The course "Skills for Success" will follow the requirements of the RE Commission for CE courses and credit.

Ms. Rodrigues informed the Commission she had the opportunity to take the course to make sure the course met the Commission's requirements. The course submitted is an eight-week course, not the 12-week course she completed. She feels the material, exercises and activities will help the Hawaii real estate licensees.

Chairman Cobb asked if the course replicates any course currently offered.

Ms. Rodrigues commented it is similar to the Real Estate Negotiator, and Communication is Key courses. The Dale Carnegie course is general, but can be uniquely tailored to the student. As a real estate professional, the exercises and activities will target how to communicate with licensee's clients, consumers, cooperating brokers, etc.

Chairman Cobb asked how will they market a 15-hour course.

Ms. Rodrigues commented a one day or three-hour course is not sufficient. Communication skills and behavior are built within time and with the 15-hour course the student will consistently build communication skills every week, and add to what was previously learned. The student will review what he/she has learned each week of the 8week session.

Commissioner Arakaki commented the course exercises will be related to real estate activity. He asked, "During the course, is there an attempt to sell products or services?"

Ms. Rodrigues commented there will be no selling of products or services.

Commissioner Arakaki asked for the cost of the course.

Ms. Rodrigues commented the cost for the real estate licensee will be about \$800 for 28hours of instruction, materials and registration.

Commissioner Lee asked if you need to complete the entire course to get the 15-hours credit or can you take only certain modules.

Ms. Rodriguez commented the effectiveness is completing the entire course. There is no partial attendance or separating the course modules. Full attendance is required as this is a building-block course.

Ms. Kaeo commented if someone misses a specific session it can be made-up in a subsequent session. Commissioner Pang moved to take under advisement, "Skills for Success" as a 3-credit hour continuing education elective course, under the course categories Dispute Resolution, Risk Management; Other - Communication and Negotiation. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried. Instructor's Development Workshop (IDW) A copy of the Instructor Development Workshop flyer was distributed to the Commissioners for their information. Ms. Marsha Shimizu was present to answer any questions the Commissioners may have. Ms. Shimizu reported 39 attendees have signed-up for the workshop, and there will be last minute registrations. Those who registered include 4 prelicensing instructors, 33 CE instructors, and 9 company training instructors. Ad Hoc Committee on Education (ACE) A copy of the 2017-2018 Core Course Part B, first draft, was distributed to the Commissioners for their information. Also distributed was a copy of the ACE meeting report for April 19, 2018. Upon a motion by Commissioner Klein, seconded by Commissioner Lee, it was voted on and unanimously carried to approve the first draft of Core Course Part B "2017-2018: "Agency and the Practice of Dual Agency", and the ACE meeting report of April 19, 2018.

Executive Session:	Upon a motion by Commissioner Arakaki, seconded by Commissioner Pang, it was voted on and unanimously carried to enter into executive session pursuant to Section 92-5(a)(1), HRS, "To consider and evaluate personal information, relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and pursuant to Section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

	Commissioner Arakaki moved to approve "Skills for Success" as a 15-credit hour continuing education elective course, under the course categories Dispute Resolution, Risk Management; Other – Communication and Negotiation, subject to the condition that all exercises/activities included in the course relate to real estate. Commissioner Lee seconded the motion. The motion was voted on and carried with Commissioner Pang voting "no".
