Call to Order: The Chair called the meeting to order at 9:01 a.m., at which time quorum was

established.

Chair's Report: The Chair announced that the Commission may move into executive session to

consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section

92-5(a)(4), HRS.

Commissioner Pang was excused from the meeting. Prior notification of his non-

attendance was received.

Executive Officer's Report:

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in Section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with Section 92-3, HRS.

Minutes of Previous Meeting

Upon a motion by Commissioner Faulkner, seconded by Commissioner Klein, it was voted on and unanimously carried to accept the minutes of the April 27, 2018 meeting.

Licensing – Ratification:

Upon a motion by Commissioner Lee, seconded by Commissioner Ginoza, it was voted on and unanimously carried to ratify the attached list.

Chair Senter announced she would be taking agenda items out of order for efficiency purposes.

Licensing – Applications: The EO informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications:

Lynn Elaine Schemmel and The RMR Group LLC

Commissioner Klein recused herself from discussion and voting and left the room.

Ms. Schemmel was present and was asked if she wished to have her applications for real estate broker and limited liability company considered in executive session. She declined the offer.

Applicant was present with counsel, Scott MacKinnon. Mr. MacKinnon explained the New Mexico Real Estate Commission (NMREC) complaint in May 2014 was handled by Mr. Paul M. Fish, Esq. and subsequently, RMR was fined, issued a letter of reprimand and needed to complete four (4) hours of continuing education courses. As noted in the May 24, 2016, letter from Wayne Ciddio of the NMREC, RMR accepted and completed the terms of this agreement. Mr. MacKinnon added that according to Mr. Ciddio's letter, this matter has been closed and no formal action was taken against RMR, Lynn Schemmel, or anyone named in the complaint.

Mr. MacKinnon stated although Lynn Schemmel was not a full time Hawaii resident, she would have constant contact via telepresence. He added Ms. Schemmel will maintain physical presence as necessary, and will abide by HRS 16-99-33(o) if Ms. Schemmel is unable to be physically available. Mr. MacKinnon

stated Ms. Schemmel and RMR are aware of Hawaii laws and rules and will comply. He added, if they are not able to comply, they will suspend all activities. They are aware any property management activity requires a broker and don't want to inadvertently do something wrong.

Chair Senter inquired if RMR utilized client trust accounts for rents received. Applicant answered they did not and monies collected went to a lockbox at their corporate office. Chair Senter asked if any attempt was made to get an updated letter from NMREC showing the complaint was dismissed specifically for Ms. Schemmel. Mr. MacKinnon answered the case was closed and that Mr. Fish was a licensed attorney in New Mexico and that is why he was retained to handle that matter.

Commissioner Cobb asked how applicant would handle business from another state. Ms. Schemmel answered she would have daily conversations, weekly virtual meetings, and would be physically in Hawaii once a month. Applicant stated her office is very transparent and their business model is different and not conventional. She added RMR operates 3 publicly-traded real estate investment trusts (REIT) and RMR owns 51% of REITs.

Supervising Executive Officer Fujitani inquired where the money deposited in the lockbox went. Applicant responded monies from lockbox were deposited into First Hawaiian Bank and then to PNC in Boston. Senior Real Estate Specialist Fujimura asked who in RMR signs and enters leases. Applicant answered the REIT entity signs leases.

Commissioner Arakaki inquired about the need for client trust accounts and how a REIT differed from a brokerage. Applicant answered RMR only engaged in asset management and added they do not intend to solicit property management or sales from third parties. Their business model is solely contained in the oversight of the 3 REITs and they contract out to licensed brokers for marketing. Mr. MacKinnon added RMR provided asset management services and they do not engage in buying and selling, however, the potential does exist to perhaps change their business model in the future to include property management. Chair Senter commented she understood the model but it was not an exception to Hawaii laws and rules.

Senior Specialist Fujimura asked who would be the BIC in the extended absence of Ms. Schemmel. Applicant responded she would ask Michelle Harris and another employee who recently passed the broker's examination.

Commissioner Arakaki moved to take the matter under advisement. Commissioner Faulkner seconded the motion. The motion was voted on and carried.

Commissioner Klein returned to meeting.

Jeff Ray LaFrance

Mr. LaFrance was present and was asked if he wished to have his preliminary application for real estate broker considered in executive session. He declined the offer.

Applicant informed the Commission he acquired his real estate license in California in 1997 and was now currently in good standing. He added he was a red cross instructor, had his own non-profit organization, and was very active in the community.

Commissioner Arakaki asked if Mr. LaFrance had any outstanding liens or judgments. Applicant responded he did not and all liens and judgments have been satisfied.

Commissioner Lee asked what type of real estate brokerage Mr. LaFrance operated in California. Applicant answered he was a sole proprietor, full-service brokerage but now works with older clients. He noted the rules in California are different and he did not have to physically be present as required by Hawaii. Commissioner Lee inquired about Mr. LaFrance's current employment. Applicant responded he was the facilities manager at Sea Life Park where he takes care of every part of the park including plumbing, pump systems, animals, etc.

Commissioner Arakaki moved to take the matter under advisement. Commissioner Faulkner seconded the motion. The motion was voted on and carried.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 9:50 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate License of Evan Cole Clarke: REC 2016-214-L

Upon a motion by Commissioner Faulkner, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of Jodi Kuraoka also known as Charity J. Kuraoka: REC 2018-6-L

Upon a motion by Commissioner Cobb, seconded by Commissioner Klein, it was voted on and unanimously carried to accept the settlement agreement.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:55 a.m.

Executive Session:

Upon a motion by Commissioner Cobb, seconded by Commissioner Ginoza, it was voted on and unanimously carried to enter into executive session, pursuant to section 92-5(a)(1), HRS, "To consider and evaluate personal information, relating to individuals applying for professional or vocational licenses cited in section 26-9 or both;" and pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Klein, seconded by Commissioner Arakaki, it was voted on and unanimously carried to move out of executive session.

Licensing – Applications:

After review of the information presented by the applicant, Commissioner Arakaki moved to approve the real estate salesperson's license of Don-el Lisa Hentrich. Commissioner Ginoza seconded the motion. The motion was voted on and unanimously carried.

Ryan Gonsalves

After review of the information presented by the applicant, Commissioner Faulkner moved to approve the real estate salesperson's license of Ryan Gonsalves. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.

John Edward Sukup III

After review of the information presented by the applicant, Commissioner Arakaki moved to approve the real estate salesperson's license of John Edward Sukup III. Commissioner Wada seconded the motion. The motion was voted on and unanimously carried.

Lynn Elaine Schemmel and The RMR Group LLC

After review of the information presented by the applicant, Commissioner Arakaki moved to approve the broker's licenses of Lynn Elaine Schemmel and The RMR Group LLC. Commissioner Lee seconded the motion. Commissioner Klein abstained from the vote. The motion was voted on and carried.

Jeff Ray LaFrance

After review of the information presented by the applicant, Commissioner Ginoza moved to most likely approve the broker's license of Jeff Ray LaFrance. Commissioner Faulkner seconded the motion. The motion was voted on and unanimously carried.
