Applications

Course(s) – All You Need to Know About the 2017 Tax Cuts and Jobs Act; Author/Owner: Creative Solution Enterprises Inc.; Provider: The Berman Education Company LLC; Course Category: Finance; Clock Hours: 3

Mr. Harold Berman was present to answer any questions or concerns the Commissioners may have.

Mr. Berman commented he has presented several tax seminars which have been very well-received. The new tax law was passed in December 2017 and is very complex and controversial.

Commissioner Lee suggested making changes to the chapter titles to not reflect the first person.

Mr. Berman commented he will make changes to the chapter titles, and adjust his lecture to be more neutral.

Commissioner Faulkner stated the course is timely.

Upon a motion by Commissioner Klein, seconded by Commissioner Pang it was voted on and unanimously carried to approve All You Need to Know About the 2017 Tax Cuts and Jobs Act as a 3-credit hour continuing education course, under the course category, Finance.

CE Online Course Application

The CE Online Course report was distributed to the Commissioners prior to the meeting for their information.

Senior Real Estate Specialist is requesting delegation staff to review CE online course applications to ensure the courses meet the new requirements for online courses.

Senior Real Estate Specialist Fujimura informed the Commission, REB has a new application for CE Online Courses. There were concerns regarding the existing online courses videotaping an individual talking. To create a better educational CE online course experience with required interactivity throughout the course and a timing tracking device, new online CE courses requirements were approved.

All CE online courses will be required to submit the new online course application for the next biennium and amend their courses to comply with the new requirements. The courses need to meet course requirements which include interactivities and a timing function. The new requirements are loosely based on the ARELLO distance education standards. The mainland CE providers who have ARELLO certified courses will meet the new requirements. Some of the local providers are currently working to meet the new requirements. The CE authors will be submitting their live classroom application to be recertified and will have to submit the new online CE course application, if applicable.

Commissioner Lee questioned if the online course will be created before submitting the application.

Senior Real Estate Specialist Fujimura stated the author will provide a link to the online course in the application. Staff will review the course to see if the course meets the requirements, most specifically including interactivity and a timing device.

Commissioner Arakaki questioned if the link will take the full 3 hours to review or will the reviewer be asked to review the course to evaluate the contents of the online CE course without accessing the contents online.

Senior Executive Officer Fujitani questioned if the reviewer will be able to skip or move forward through the course?

Senior Real Estate Specialist Fujimura stated that, usually, the person taking a CE online course will not be allowed to skip or move forward through the course.

Commissioner Klein asked if a review of a course can be a partial review?

Commissioner Arakaki asked if two of the modules are okay, but the subsequent modules are not, is there a paper hardcopy to reference?

Senior Real Estate Specialist Fujimura commented the author will provide a hardcopy of the online course. There must be a time mechanism to check if the student is present and did not walk away from the course and let the time run.

Commissioner Pang questioned who will be delegated to review the online courses? Will additional staff be hired to review?

Commissioner Klein asked if REB has any administrative resources? It will take hours to review the CE online courses. Is there a way to access the education fund for this purpose?

Executive Officer Ino commented the fees are set in Chapter 53.

Senior Executive Officer Fujitani asked if most of the online courses also include a live version of the course? ERC receives the hard copy, then the Commission would review and approve the course. ERC rarely receives an online only course. The online only courses need to be reviewed and evaluated if they meet the new requirements

Commissioner Arakaki stated he's more concerned about the contents of the online courses, and if they meet all the requirements on the checklist.

Senior Executive Officer Fujitani commented the online course will be submitted as a hardcopy, as it would appear to the online user.

Senior Real Estate Specialist Fujimura stated the author will submit the screenshots of the online version.

Commissioner Lee suggested delegating to staff the review of the online course and the Commission will review the hardcopy contents.

	Commissioner Pang asked if the author can submit the CE online course prior to approval in the form of the hardcopy which will indicate interactivity and timing function.
	Senior Real Estate Specialist Fujimura said a complete packet including the hardcopy materials and the online link should be submitted for review and approval.
	Commissioner Klein commented the live CE course should be like a book when converting the course to an online class. There should be a checklist to check the contents of the course.
	Commissioner Arakaki questioned item #10 regarding "ADA information", "Technology support services available to students", and "Completion/Course Completion Certificates", on the CE online course application.
	Senior Real Estate Specialist Fujimura explained these boxes should be checked as it indicates the information the student manual or orientation area of the course. The course completion certificate is delivered from our online system.
	Commissioner Pang suggested the author of the course will submit a CE online course application, the Commission approves the contents of the course and the course is subject to audit. Once approved, one of the Commissioners will review the online course.
	Executive Officer Ino stated the ERC may review and approve the contents subject to staff confirming the online features are built into the course.
	Commissioner Arakaki moved to delegate to the staff the review of online CE course applications. Commissioner Klein seconded the motion. The motion was voted on and unanimously carried.
