BACKGROUND CHECKS

Hawaii does not require a background check of any kind as a licensing requirement for real estate licensees. Although the questions on the licensing application apply to past or pending criminal convictions, pending lawsuits, unpaid judgments, outstanding tax obligations, or any other type of involuntary liens filed against the applicant, and complaints or charges filed against the applicant with the licensing agency of any state, the answers are completely reliant on self-disclosure by the applicant.

This is not fool-proof, obviously. If a non-disclosed conviction, for example, is discovered after licensure, and reported to the Regulated Industries Complaints Office (RICO) or the Real Estate Commission, the resulting penalties may be compounded based on providing a false statement on the initial license application or renewal application. Failure to disclose prior convictions, etc. on subsequent renewal applications will also increase the penalties assessed. This record of non-disclosure may also impact a licensee from becoming a broker, or being a principal broker of his or her own brokerage.

A primary concern is knowing as much as possible about whom you are dealing with. This could be another licensee, a client, a customer. Safety is the watchword to keep in mind; safety for your client, your customer, fellow licensees, and yourself.

There are available public websites which provide background information. Some of these include:

- 1. Ho'ohiki, the Hawaii State Judiciary's Public Access to Court Information, www.courts.state.hi.us Information found on Ho'ohiki includes civil case information filed in Circuit and Family Courts, and certain civil cases of the District Courts.
- 2. eCourt Kokua Information includes traffic cases, District Court criminal, Circuit Court criminal, Family (Adult) Court criminal and appellate cases, www.courts.state.hi.us/legal_reference.
- 3. Hawaii Criminal Justice Data Center Information includes criminal history records check, sex offender and other covered offender information, www.ag.hawaii.gov/hcjdc.
- 4. Regulated Industries Complaints Office (RICO) Prior complaints history on regulated professions and vocations in Hawaii, www.cca.hawaii.gov/rico.

There are many resources available to real estate licensees to assist in due-diligence research.



If You Have Not Reregistered or Recertified . . .

Any prelicense school, prelicense instructor, continuing education provider, continuing education course that has not been reregistered or recertified by 12/31/18, you may still submit these applications, however, please include the \$10.00 restoration fee with the reregistration or recertification application in addition to the required reregistration or recertification fee. If the school, instructor, provider, or course has missed more than one biennium for reregistration or recertification, the \$10.00 restoration fee applies to each biennium that the school, instructor, provider, or course was not reregistered or recertified.

Continuing Education ONLINE Courses

All continuing education ONLINE courses are required to use the new continuing education online course application to obtain initial certification for the online course. For the 2021-2022 biennium, a recertification application will be available for the previously certified continuing education online courses. The recertification fees will be the same as the recertification fee for live continuing education courses, \$25 for each credit hour. Mahalo for your understanding regarding the transition to certifying continuing education online courses as courses in their own right.

Commission's Mandatory Core Course 2019-2020

The topics for the Commission's mandatory core course for the current biennium are:

CORE A: "Laws that Affect Your Real Estate Practice" – The laws that may be included are Hawaii Revised Statutes ("HRS") Chapter 467, Real Estate Brokers and Salespersons, and its accompanying Hawaii Administrative Rules ("HAR"), Title 16, Chapter 99, Real Estate Brokers and Salespersons; HRS Chapter 436B, Professional and Vocational Licensing Act; HRS Chapter 444, Contractors; HRS Chapter 508D, Mandatory Disclosures in Real Estate Transactions; HRS Chapter 521, Residential Landlord Tenant Code; HRS Chapter 514B, Condominiums. (Note: This is not a final list of laws and rules to be addressed. The Commission will work with the core course developer to finalize the list of laws and rules to be included.) All of the listed HRS Chapters contain sections which real estate licensees should be aware of in dealing with clients and their properties.

CORE B: "Principal Brokers and Brokers-in-Charge – Do You Know, Do You Care? **OR The Buck Stops Here!**" Information to be included will be HRS Chapter 467, specifically, §467-1.6, Principal brokers; HAR §16-99-2 Definitions, §16-99-4 Client's account; Trust funds; Properties other than funds; Policies and Procedures Manual.

The 2019-2020 Real Estate-Related Legislation will be part of Core A and Core B, respectively, as usual.

Please note that the Commission is emphasizing interactivity in continuing education courses. The current recommendation is at least one interactive component for each hour of the course.

2017-2018 Core Course

Reminder: The 2017-2018 Core Course, Parts A and B, is still available through May 31, 2019, when both parts will expire. BOTH the live and online versions of the core courses remain available through May 31, 2019. The core course will then no longer be available for licensees who may be reactivating or restoring their license. The core courses may not be used as make-up. Only continuing education elective courses, live or online, may be used for make-up.



INTERACTIVITY

Interactive continuing education courses, and even prelicense courses is a trending topic. While this is not new to education, it is new to some of Hawaii's educators, and is a new emphasis by the Commission. With the advent of the new continuing education online course application for the 2019-2020 biennium, courses should now include at least one interactive activity per one hour of instruction. Interactivity may include quizzes, true false questions and answers, definitions, case scenarios, small group break-outs (classroom courses), or other devices that encourage feedback and give-and-take regarding the course content. A minimum of five (5) assessment questions per clock hour is required, if using quizzes. These assessment questions may be asked either after each hour of instruction or grouped together at the end of the course.

While the emphasis is on continuing education courses, interactivity will also be aimed at prelicense education. The "talking head" approach to education may be the easiest and simplest way to teach. It is not the only way people learn, however. Prelicense instructors/schools should begin to evaluate their topic presentation to ensure there are different and varied approaches to teaching the content. In the near future, prelicense instructors/schools may be asked to describe and indicate in their syllabi exactly where interactivity will occur, and what form the interactivity will take.

ETHICS COURSES

The National Association of REALTORS® ("NAR") previously required the completion of an "ethics" course every four years. This requirement was recently changed to every two years, beginning in 2017 and ending in 2018, for the first two-year cycle.

During the recent real estate license renewal period, the Real Estate Branch received calls from licensees stating they had taken an ethics course but did not see it listed in their CE History.

Be aware that if a licensee took an ethics course directly from NAR, there would be no credit towards their Hawaii CE requirement in order to renew their license. NAR is NOT a Hawaii-approved continuing education provider. The Hawaii Association of REALTORS® is a Hawaii-approved continuing education provider. They offered a choice to licensees of taking an ethics course either for no credit or credit. There is a fee to take the ethics course for credit.

Licensees who are members of a local board of REALTORS® should check with their member-board if they have questions about an ethics course and receiving continuing education credit.
