Call to Order: The Chair called the meeting to order at 9:02 a.m., at which time quorum was

established.

Chair's Report: The Chair announced that the Commission may move into executive session to

consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section

92-5(a)(4), HRS.

Executive Officer's

Report:

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Minutes of Previous Meeting

Upon a motion by Commissioner Arakaki, seconded by Commissioner Kyono, it was voted on and unanimously carried to accept the minutes of the January 18, 2019 meeting.

Chair Pang announced he would be taking agenda items out of order for efficiency purposes.

Licensing – Ratification:

Upon a motion by Commissioner Lee, seconded by Commissioner Faulkner, it was voted on and unanimously carried to ratify the February 22, 2019, Approved Applications List.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 9:05 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate License of Daniel R.T. Carlson: REC 2018-289-L

Upon a motion by Commissioner Arakaki, seconded by Commissioner Klein, it was voted on and unanimously carried to accept the settlement agreement.

In the Matter of the Real Estate License of Tabatha D. Hazen: REC 2018-283-L

Upon a motion by Commissioner Arakaki, seconded by Commissioner Lee, it was voted on and unanimously carried to accept the settlement agreement.

Following the Commission's review, deliberation, and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled meeting at 9:07 a.m.

Licensing – Applications:

The Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications:

Carolyn Yvonne Landon

The applicant informed the Commission she would be available via teleconference should any further questions arise regarding her request for preliminary decision application.

Commissioner Lee recused herself from the discussion and voting and left the room.

Executive Session:

Upon a motion by Commissioner Ginoza, seconded by Commissioner Arakaki, it was voted on and unanimously carried to enter into executive session, pursuant to section 92-5(a)(8), HRS, "To deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a state or federal law, or a court order." And pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Upon a motion by Commissioner Faulkner, seconded by Commissioner Wada, it was voted on and unanimously carried to move out of executive session.

Commissioner Lee returned to the meeting.

Licensing – Applications:

Alesia J. Borja

Ms. Borja was present and was asked if she wished to have her application for real estate salesperson considered in executive session. She declined the offer.

The applicant informed the Commission obtaining her salesperson's license meant a lot to her and was here to answer any questions.

Commissioner Lee inquired about accumulated IRS taxes owed by the applicant. Ms. Borja responded she paid some down and that she currently has a payment plan in place for the remaining amounts. Commissioner Klein noted the applicant answered "No" on her application. Senior Real Estate Specialist Fujimura advised the Commissioners she has an amended application in her file. Commissioner Faulkner asked if there was a payment plan in place for each amount owed. Ms. Borja stated the amounts were consolidated and she makes one payment.

Chair Pang asked the applicant about her payments and when they would be paid in full. Ms. Borja answered she pays \$329 per month for the IRS Offer in Compromise and will be paid off by May 2019. She added the California Franchise Tax Board will be paid off by the end of this year. Chair Pang asked about the applicant's student loan and if payments were current. Ms. Borja responded her student loan will be paid off in 2020 and that she is current.

Commissioner Faulkner inquired what area of real estate the applicant was interested in. Ms. Borja responded property sales but would like to pursue property management and added she is currently employed by Team Lally as an administrative assistant.

Upon a motion by Commissioner Lee, seconded by Commissioner Klein, it was voted on and unanimously carried to take the matter under advisement.

Carolyn Yvonne Landon

Commissioner Lee recused herself from the discussion and voting and left the room.

The Commission had additional questions for the applicant and called the telephone number Ms. Landon provided. The call was unanswered and went to the applicant's voicemail. Executive Officer Ino left a message and informed the applicant that the Commission will try to contact her again.

Commissioner Lee returned to the meeting.

Deanna Brooke Tully fka Deanna Perlowin

After review of the information presented by the applicant, Commissioner Ginoza moved to approve the real estate salesperson's license of Deanna Brooke Tully. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.

Jacob Valentin

After review of the information presented by the applicant, Commissioner Klein moved to approve the real estate salesperson's license of Jacob Valentin. Commissioner Arakaki seconded the motion. Commissioners Klein, Arakaki, Ginoza, Kyono, Love, Pang and Wada voted aye. Commissioners Lee and Faulkner abstained from the vote. The motion was carried.

Alesia J. Borja

After review of the information presented by the applicant, Commissioner Arakaki moved to approve the real estate salesperson's license of Alesia J. Borja, with conditions. Commissioner Lee seconded the motion. The motion was voted on and unanimously carried.

The conditional real estate salesperson license is **approved** for the Applicant, subject to the following conditions:

- That during the term of this conditional license, any violation of the terms of the payment plan with the IRS and the California Franchise Tax Board, and the U. S. Department of Education by the Applicant, shall be grounds for revocation of license.
- 2. That failure to provide written notice within 30 days to the licensing authority of any judgment, award, disciplinary sanctions, order, or other determination, which adjudges or finds that the licensee is civilly, criminally or otherwise liable for any personal injury, property damage or loss caused by the licensee's conduct in the practice of the licensee's profession or vocation shall be grounds for revocation of license.
- 3. That the Applicant shall at all times be associated with and under the direct supervision of a principal broker ("PB") or one or more brokers in charge ("BIC"), for all real estate transactions.

- 4. That the Applicant shall inform the PB, sole proprietor real estate broker, or BIC of a real estate branch office with whom the Applicant associates that the Applicant holds a conditional real estate salesperson license and may only practice pursuant to certain terms of the conditional license. The Applicant shall present to the Applicant's PB, sole proprietor real estate broker, or BIC of a real estate branch office a copy of the Commission-issued conditional letter. The Applicant shall ensure that the PB, sole proprietor real estate broker, or BIC of a real estate branch office acknowledges the terms of the Applicant's conditional license by signing and returning a signed copy of the conditional letter to the Commission.
- 5. That <u>ALL</u> changes of association and/or employment by Applicant to another real estate broker shall be submitted in writing to the Commission. The new PB, sole proprietor real estate broker, or BIC of a real estate branch office shall acknowledge the terms of the Applicant's conditional license within ten (10) days of the change by submitting a completed Change Form along with a copy of the conditional letter signed by the new PB. Failure to attach the signed conditional letter by the new PB may result in disciplinary action.
- 6. That the satisfaction of the Applicant from said payment plan(s) shall not change any terms of the conditional license.
- 7. That upon completion of payment plan(s) with the IRS and/or State Department of Taxation, the Applicant must submit a written request to the Commission if the Applicant desires to have the conditions removed.

Carolyn Yvonne Landon

Commissioner Lee recused herself from the discussion and voting and left the room.

The Commission again called the telephone number provided by Ms. Landon. The call was unanswered and went to the applicant's voicemail. Chair Pang left a message and informed the applicant that this was the Commission's second attempt to contact the applicant.

After review of the information presented by the applicant, Commissioner Klein moved to most likely deny the real estate salesperson's license of Carolyn Yvonne Landon. Commissioner Ginoza seconded the motion. Commissioners Klein, Ginoza, Pang, Arakaki, Faulkner, Kyono, Love and Wada voted aye. Commissioner Lee was recused. The motion was carried.

Commissioner Lee returned to the meeting.

Foundation Property Management, Inc.

Real Estate Specialist Grupen informed the Commission that the applicant's attorney has requested this application be deferred to the March 22, 2019, meeting.

Committees and Program of Work:

SB 202 Relating to Professional and Vocational Regulatory Programs – No Discussion

SB 306 Relating to Condominiums – No Discussion

SB 439 / HB 213 Relating to Licensed Professionals – SEO Fujitani stated this bill would require the department of commerce and consumer affairs to post all licensee's business addresses and telephone numbers on its website. The SEO added the real estate branch does not collect telephone numbers from licensees and that the Licensing Administrator is asking for any input the REC may have. Commissioner Klein stated this may create problems as licensees move around to different brokerages. SEO responded that the Licensing Administrator has drafted testimony to that effect.

SB 551 Relating to Condominiums – No Discussion

SB 770 / HB 63 Relating to Real Estate Licenses – The SEO stated this bill requiring high school diploma or equivalency be a requirement for real estate licensure passed the first committee in the House with an effective date of 2050. He informed the Commission that an S.D. 1 from Senator Baker, with an effective date of 2020, to coincide with real estate license renewals, was forthcoming. Chair Pang inquired how the Real Estate Branch would prove an individual had their diploma or equivalency. Without deciding the issue now, more than likely, the applicant would attest to earning a high school diploma or its equivalent.

SB 774 / HB 73 Relating to Professional and Vocational Licensing – No Discussion

HB 112 Relating to Taxation - No Discussion

HB 810 Relating to Condominiums – Condominium Specialist Dathan Choy stated this bill would give associations, through lease agreements, the authority to prohibit smoking in and around the condominium. Commissioner Klein stated this would allow associations to communicate directly to tenants and not through unit owners. She added resident managers could be allowed to enforce this rule.

HB 811 / HB 552 Relating to Condominiums – The SEO stated this bill would extend the 514A repeal for an additional year. He added that although this repeal does not include time share properties, a proponent of having time share properties exempted from the disclosure requirement, as it existed in 514A, added into 514B. This added language should not affect the extension of 514A repeal.

HB 1528 Relating to Commerce and Consumer Affairs – The SEO informed the Commission that this bill, requiring the Department of Commerce and Consumer Affairs suspend all fees relating to licensing and registrations beginning fiscal year 2021 to the fiscal year ending in 2029, was introduced as some legislators believe these funds are too high. Commissioner Arakaki suggested implementing an easier process for victims to collect money from the real estate recovery fund. Deputy Attorney General Wong suggested conferring with other boards and programs for uniformity. The SEO stated this bill was a House initiative that will cross over to the Senate shortly.

SB 464 Relating to Private Property – The SEO stated the Senate has consulted with an arborist and is currently drafting new language regarding this bill which will authorize a property owner or agent to enter an adjacent property to eradicate albizia trees.
