Mr. Nishizawa stated he is the new Professional Development Administrator for HBR and was a teacher for 14 years.

Senior Real Estate Specialist Fujimura informed the committee the course above meets the NAR requirement for a Code of Ethics course for its members.

Upon a motion by Commissioner Pang, seconded by Commissioner Wada, it was voted on and unanimously carried to approve "Disclosure, Discrimination and Advertising in the Code of Ethics" as a 3-credit hour continuing education course, under the course categories: Dispute Resolution, Code of Ethics.

Senior Real Estate Specialist Fujimura questioned Mr. Nishizawa about the course. Upon a motion by Commissioner Arakaki, seconded by Commissioner Love, it was voted on and unanimously carried to defer the course application of "eDearment: The Art of Digitally Hugging Your Clients and Community" to the Real Estate Commission meeting on April 26, 2019, and request additional course materials.

Continuing Education Core Course

First draft of the 2019 – 2020 Hawaii Real Estate Commission Core A course was distributed to the Commissioners for their information.

Senior Real Estate Specialist Fujimura informed the committee the title of the course will be changed. Executive Office Ino compiled a list of the most common violations found in the last five years of HRS §436B, HRS §467 and HAR §16-99. The Ad Hoc Committee on Education reviewed the list and decided to focus on the violations that occurred most often. Most case studies for Core A will come from the REC Bulletin and the published administrative actions.

Commissioner Lee noted on page 15, second to the last paragraph to delete "with HIREC" from "hearing with HIREC", as the commission does not participate in the administrative hearing process.

The Commissioners agreed to focus on the most common violations from the last 5 years with supporting case studies.

Upon a motion by Commissioner Pang, seconded by Commissioner Lee, it was voted on and unanimously carried to approve the first draft of Core A 2019 – 2020 and the ACE report of its 4/12/2019 meeting.
