SEO Fujitani reported that two bills which the Commission had been closely monitoring were signed by the Governor, Senate Bill 770 requiring a high school education or its equivalent as a condition for obtaining a real estate broker or salesperson license was signed as Act 246; and Senate Bill 552, the Ch. 514A extension bill was signed as Act 223.
