Prelicense Independent Study/Online Course Instructor – Excellence in Education LLC dba Maui Real Estate School; Instructor – Dionne M.C. Phillips; Salesperson Curriculum

Ms. Dionne M.C. Phillips is currently approved as a prelicense salesperson instructor and applying as a prelicense independent study/online course instructor for the salesperson curriculum.
