Call to Order: The Chair called the meeting to order at 9:02 a.m., at which time quorum was

established.

Chair's Report: The Chair announced that the Commission may move into executive session to

consider and evaluate personal information relating to individuals applying for licensure in accordance with section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with section

92-5(a)(4), HRS.

The Chair informed the Commission that he, Supervising Executive Officer (SEO) Fujitani and Executive Officer Ino, found attending the 2019 ARELLO Annual Conference beneficial. He added they were looking to implement more outreach programs and to streamline the recovery fund process for smaller

claims.

Executive Officer's Report:

The Commission shall afford all interested persons an opportunity to submit data, views, or arguments, in writing, on any agenda item and shall provide all interested parties an opportunity to present oral testimony on an agenda item subject to the conditions set forth in section 16-99-83, HAR. The Commission may remove any person or persons, who willfully disrupt a meeting to prevent and compromise the conduct of the meeting in accordance with section 92-3, HRS. Each speaker will be limited to a five-minute time period pursuant with section 16-99-83 (a)(5), HAR.

Minutes of Previous Meeting

Upon a motion by Commissioner Lee, seconded by Commissioner Kyono, it was voted on and unanimously carried to accept the minutes of the August 23, 2019 meeting.

Committees and Program of Work:

Laws and Rules Review Committee Condominium Review Committee Education Review Committee

Laws and Rules Review Committee - Real Estate Recovery Fund

Upon a motion by Commissioner Arakaki, seconded by Commissioner Klein, it was voted on and unanimously carried to accept the June 30, 2019, Real Estate Recovery Fund budget.

Condominium Review Committee - Condominium Education Fund

Upon a motion by Commissioner Faulkner, seconded by Commission Lee, it was voted and unanimously carried to accept the June 30. 2019, Condominium Education Fund budget.

Education Review Committee - Real Estate Recovery Fund

Upon a motion by Commissioner Arakaki, seconded by Commissioner Klein, it was voted on and unanimously carried to defer and deliberate this matter in executive session.

Licensing – Ratification:

Upon a motion by Commissioner Ginoza, seconded by Commissioner Kyono, it was voted on and unanimously carried to ratify the August 23, 2019, Approved Applications List.

Chair Pang announced he would be taking agenda items out of order for efficiency purposes.

Licensing – Applications:

The Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Licensing – Applications:

Kevin Ko

Commissioner Yamane recused himself from the discussion and voting and left the meeting.

Mr. Ko was present and was asked if he wished to have his application for real estate salesperson considered in executive session. He accepted the offer.

Executive Session:

Upon a motion by Commissioner Arakaki, seconded by Commissioner Love, it was voted on and unanimously carried to enter into executive session, pursuant to section 92-5(a)(8), HRS, "To deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a state or federal law, or a court order." And pursuant to section 92-5(a)(4), HRS, "To consult with the board's attorney on questions and issues pertaining to the board's powers, duties, privileges, immunities, and liabilities."

Commissioner Yamane returned to the meeting.

Alexander Wright Ferguson

Mr. Ferguson was present and was asked if he wished to have his preliminary decision application for real estate salesperson application considered in executive session. He accepted the offer.

Upon a motion by Commissioner Faulkner, seconded by Commissioner Klein, it was voted on and unanimously carried to move out of executive session.

Licensing – Applications:

Kevin Ko

After review of the information presented by the applicant, Commissioner Klein moved to approve the real estate salesperson license of Kevin Ko.

Commissioner Arakaki seconded the motion. Commissioners Klein, Arakaki, Ginoza, Faulkner, Kyono, Lee, Love, Pang, and voted aye. Commissioner Yamane recused himself from the vote. The motion passed.

Alexander Wright Ferguson

After review of the information presented by the applicant, Commissioner Arakaki moved to most likely deny the real estate salesperson's license of Alexander Wright Ferguson. Commissioner Ginoza seconded the motion. Commissioners Arakaki, Ginoza, Klein, Kyono, Lee and Pang voted aye. Commissioners Faulkner and Love voted nay. The motion passed.

Jana Walden

After review of the information presented by the applicant, Commissioner Faulkner moved to defer this application and request the applicant appear at the October 25, 2019, Real Estate Commission meeting. Commissioner Kyono seconded the motion. The motion was voted on and unanimously carried.

Jeremy Robinson

At its Education Review Committee meeting of May 8, 2019, Commissioner Arakaki recommended issuance of a Commission's Proposal Final Order to bar Jeremy Robinson from taking any Hawaii real estate licensing exam for a period of one year, and strongly recommended that he take a LIVE prelicensing course.

Commissioner Kyono seconded the motion. The motion was voted on and unanimously carried. Mr. Robinson was allowed 60 days from the date of the Proposed Final Order to respond and present oral arguments. Having heard no response, Commission's Final Order was issued barring Jeremy Robinson from taking any Hawaii real estate licensing exam for a period of one year and require that he take LIVE prelicense course. The earliest date Mr. Robinson may take any real estate licensing exam is April 24, 2020.

Nicole De Fries-Dale

At its meeting of June 28, 2019, Commissioner Arakaki recommended issuance of a Commission's Proposed Final Order to bar Nicole De Fries-Dale from taking ay Hawaii real estate licensing exam for a period of one year. Commissioner Ginoza seconded the motion. The motion was voted on and unanimously carried. Ms. De Fries-Dale was allowed 60 days from the date of the Proposed Final Order to respond and present oral arguments. Having heard no response, Commission's Final Order was issued barring Nicole De Fries-Dale from taking any Hawaii real estate licensing exam for a period of one year. The earliest date Ms. De Fries-Dale may take any real estate licensing exam is May 24, 2020.

Education Review Committee - Real Estate Education Fund

Upon a motion by Commissioner Love, seconded by Commissioner Kyono, it was moved to approve the lifting of the moratorium based on a reasonable interpretation and reading of Act 29 which will go into effect on July 1, 2020, that the REEF could collect up to \$1,713,510 of Act 29's cap in the intervening months before the Act goes into effect, as well as the budget for the real estate education fund. Commissioner Kyono seconded the motion. Commissioners Love, Kyono, Pang, Ginoza, Klein, Faulkner, Lee and Yamane voted aye. Commissioner Arakaki voted nay. The motion carried.

Upon a motion by Commissioner Arakaki, seconded by Commissioner Kyono, it was voted on and unanimously carried to accept the settlement agreement.

Upon a motion by Commissioner Kyono, seconded by Commissioner Klein, it was voted on and unanimously carried to accept the settlement agreement.
