Course "Trusts & Estates Administration: Life in the Trenches"; Author/Owner: Stacey T.J. Wong; Provider: Abe Lee Seminars; Course Categories: Contracts, Dispute Resolution, Finance, Risk Management; Clock Hours: 3

Stacey Wong was present to answer any questions or concerns the committee may have.

Commissioner Lee asked what does "Life in the Trenches" mean?

Mr. Wong commented the administration of the trust or the estate can be difficult. A trust or estate can cause family members and loved ones to act in an unexpected way. It can be life-changing for people. There may be power grabs and strategic moves by family members. Also, the course may help people be less naïve about what a trust is. Mr. Wong explained he has experience as a court-appointed personal representative. He was previously a personal representative for an estate that took over 3 years to settle.

Commissioner Pang stated the CE course should give the licensee information on trusts and not teach the licensee how to advise the clients on trusts or administer trusts.

Mr. Wong stated he will always recommend the licensee urge his/her clients to talk to the experts.

Commissioner Lee asked, "Are you an attorney?" and "What qualifications do have for the court to appoint you as a personal representative?"

Mr. Wong stated he is not an attorney. The judge asked for names and he was chosen to represent the family.
