Mr. Wong was present to answer any questions the committee may have. Mr. Wong made changes to the title suggested by the Commissioners.

Commissioner Kyono asked Mr. Wong if the family court cases provided are public record?

Mr. Wong stated the family court cases in the course are public records. However, the family court cases from the 1950's on are not public record.

Upon a motion by Commissioner Pang, seconded by Commissioner Lee, it was voted on and unanimously carried to approve "Trusts & Estates Issues: Life in the Trenches" as a 3-credit hour continuing education course, under the course categories Contracts, Dispute Resolution, Finance, and Risk Management.

Mr. Bryan Andaya was present to answer any questions or concerns the committee may have. Mr. Andaya commented there are many different angles regarding the TVUs which concern the visitor industry, visitors, and consumers. The course focuses on the island of Oahu, but there will be a part two for the neighbor islands.

Mr. Andaya informed the committee he will provide the materials to the appendix. The students will receive the appendix materials to complete group exercises and full-page maps will be included.

Mr. Andaya commented Unit III in the course provides information as of 2020.

Commissioner Klein stated the course is timely.

Chair Faulkner stated he is concerned about licensees managing illegal rentals and suggested Mr. Andaya caution the licensees during the course.

Mr. Andaya stated Unit 2, Lesson 8 in the course materials covers possible violations by licensees, who manage illegal units. The course also distinguishes the differences between TVUs and B&Bs.

Mr. Andaya commented the course covers Bill 89 which has profound affects on the TVU industry.

Commissioner Lee commented on page 23, the Hawaii General Excise Tax is 4.712%.
