## **Minutes of Previous Meetings**

Upon a motion by Commissioner Faulkner, seconded by Commissioner Kyono, it was voted on and unanimously carried to accept the minutes of the February 12, 2020, Laws and Rules Review Committee meeting as circulated.

Program of Work:

Legislative and Government Participation Report – House Bill 2315, HD3 Relating to Professional and Vocational Licensing Trust Funds

HB 2315, HD3 was circulated. This bill would allow the contractors license board and the real estate commission to adjust, reduce, suspend, or cease collection of recovery fund and education fund fees to maintain a reasonable relation between the fees generated and the cost of services rendered by the fund. Removing the ceiling caps is a positive step. Staff noted that page 5, line 16 of the bill, the word "biannually" should be changed to "biennially," once every two years. The language should read: "The balance of the funds shall not exceed a sum determined by the board. The sum shall be determined by the board biannually biennially."
